SUMMARY

Falling Creek Methodist Church and cemetery is situated on 2 acres of property, on County Road 131, one and two-tenths mile off U.S. Highway 41. The one room, frame vernacular church was built c.1885. The rectangular building rests on a foundation of stone and concrete piers, and has a front gabled tin roof. A log church previously stood on this same site. An adjacent community cemetery has historically been associated with the church since its previous log building.

SETTING

Falling Creek Methodist Church has a rural setting six miles northwest of Lake City in Columbia County. The church fronts toward the east with the property on the western side of paved County Road 131 (Photo 1). Falling Creek community is so named because of the steep-banked creek that runs along the westerly and southerly boundary of the property. A waterfall is located one-tenth mile south of the church. The church property contains two acres and is surrounded on three sides by heavily wooded land owned by ITT Rayonier Inc. timber company. The church yard, except for the cemetery itself, contains scattered pine, hickory, dogwood and oak trees.

PHYSICAL DESCRIPTION

Exterior

Falling Creek Methodist Church's main facade faces east, and is easily visible from County Road 131. The church measures 25' X 30' (Photos 2 & 3). The walls are unpainted pine, horizontal siding. The church rests on stone piers ranging in height from 10" to 15". Supplemental cement piers are present. Two, two-panel, pine doors provide the

main access to the interior. Doorsteps with three risers are made of concrete block smoothed over with cement.

The south facade contains two, 6/6, double hung, wood sash windows and a door positioned in the westerly half of the facade (Photos 4 & 5). The door is accessed by a new cypress ramp. The north facade contains three windows; two are 6/6 double hung sashes and one is 2/2 sash (Photo 6). The west facade contains two, 2/2, double hung wood sash windows (Photo 7).

Interior

Aisles lead from each of the two front entrances (Photo 8). The interior of the building is unpainted and the walls and ceiling are finished with 2.5" beaded, tongue and groove pine. The 23 slat benches with curving seats are made from the same 2.5" tongue and groove boards. The floor is unpainted 5" pine planking. The ceiling is 11' high. unfinished, handmade pine table assembled with wooden pegs serves as an altar (Photo 9). The box style pulpit of dark stained exterior paneling was built with four panels in front and a panel on each end. These panels are of a slightly lighter color with combed design stain finish. pulpit measures 8' across and 34" high and sits on a foothigh wooden platform. A large wooden cross hangs on the west wall. A small smoked area on the ceiling is a reminder of a ornate kerosene lamp which hung in the center. electric lights and two fans are on the ceiling, and electric conduits for these are clearly visible on the east and northern wall.

CEMETERY

A cemetery, containing approximately 60 graves, 42 of them marked, is located to the west of the church (Photos 10 & 11). From the period of the log church, this cemetery has been used as burial ground for people in the area, including those not connected with the church. The earliest legible dated marker is 1871 (Photo 12). The most recent memorial is dated 1994 (Photo 13). Two areas are fenced for family burials, and several markers are artistically carved (Photos

14 & 15). Two graves are raised and covered with bricks, and four are mounded, stone covered graves (Photo 16). Throughout the cemetery there are stone markers which have been worn to the ground, and unmarked depressions in the ground.

Alterations

The original three sets of wooden steps, (two on the east, one on the south,) were replaced in the 1940s with concrete block steps and smoothed over with cement. 1940s, the west outside wall was repaired by replacing 3/4 of the wall with novelty pine lumber. The church was wired for electricity in 1970 and two lamps hung from the ceiling, one over the piano and one over the pulpit. They were salvaged from the Blue Goose Restaurant which operated in Lake City during the 1930s and 1940s. An historic, ornate kerosene lamp disappeared unexpectedly in 1963. repairs were made to the north, east, and south outside walls when seven of the lower boards were replaced with treated pine lumber. A 6" rough-sawn wooden cross was placed on the rear, west wall behind the pulpit in 1976 by Rev. Will Wright. During the 1980s two electric fans with light combination were installed along the center of the church ceiling.

SUMMARY

The Falling Creek United Methodist Church is significant under criteria A and C, in the areas of Social History and Architecture, and under Criteria Considerations A and D. The current frame church was constructed c.1885, but was preceded on the same location by a log church, built between 1853 and 1866, and used by a Baptist congregation. A community cemetery has been associated with the church since 1871, and possibly earlier. A public, one-room school existed on the property from 1887 into the mid 1930s. The Church and its site has functioned as a community center for worship, education, social gatherings and burial, for 130 years.

HISTORIC CONTEXT

At the time the church was established, between 1853 and 1866, the population of the entire Columbia County was 4,646, of which 2,062 were slaves. The county's current population is approximately 49,000. During this early period, the area economy was dominated by farming. Today only two or three working farms remain, and a large percentage of the land is cultivated pine forest. After World War II, farming became more mechanized and family farms became fewer. In recent years, land previously used for farming has been divided and sold for home sites as the region's population grows. Forestry remains an important part of the area's economy.

Some of the early settlers active in the early church were also crucial in the development of this farming community, its industry, mercantile busineses, and in establishing a post office. The history of the village of Winfield, one mile west of the church, is interwoven with the community of Falling Creek.

The church property is associated with Thomas D. Dicks, who acquired acreage in 1855, from the State of Florida Internal Improvement Fund for \$.50 an acre. This purchase contains the existing church and cemetery. Mr. Dicks and his wife, Rachel, came in 1853 from Hampton, South Carolina,

in a covered wagon. Included in a wagon caravan from South Carolina were Rebecca's two sisters and their families, their father Tommy Manker, families of Reverend W.J. Greene, Richard Mole, and others. They settled in the vicinity of Falling Creek. Thomas D. Dicks's son, James Winfield Dicks, founded Winfield Station on the Georgia Southern & Florida Railroad, where he built a mercantile store with post office. James Dicks helped build the existing church benches, and was a Sunday School superintendent, as well as trustee and steward of the church.

At the end of the Civil War, a sawmill was established by L.W. Rivers and a Mr. Reed, on Falling Creek. The mill was run by power from the water fall. By the 1890s, the naval stores industry brought more growth to Winfield. A large turpentine distillery was located there. Two early members of Falling Creek Church, John L. Roberts and Mrs. Harriett McCall Curry, established two other merchantile stores and a cotton gin. Mrs. Curry is intered at the cemetery. There was also a cotton gin and grist mill operated by church member T.J. Summerall.

County Road 131 was originally known as Blount's Ferry Road. It was the main connection between Lake City and Blount's Ferry, a major agricultural town located on the Suwannee River, just south of the Georgia border. In the 1880s, Bount's Ferry was a settlement of 160 people with two stores, sawmill, cotton gin and grist mill. This road was first paved in 1950, at which time the original steel truss bridge with wooden plank floor, which crossed Falling Creek, was replaced by a concrete bridge. At this time, the road designation was changed to County Road 131. The newly paved road was 133' east of the original road which meant church property no longer touched the road. Church trustees acquired two small parcels abutting the paved road from the Estate of Mary J. Rivers and from the Columbia County School Board.

HISTORIC SIGNIFICANCE

Although the earliest deed we have from James W. and Thomas F. Dicks is dated February 6, 1886, a log church was established on this site between 1853 and 1866, as a

Missionary Baptist Church. It was this log church that the Methodist congregation acquired in 1866. They were admitted at that time to the Florida Methodist Conference, then known as the Methodist Episcopal Church South.

The present frame church and its furnishings were designed and built by church members c.1885. T.J. Summerall built the pulpit and donated a pump organ. In 1878, Summerall had been paid to build a bridge at Blount's Ferry, indicating his engineering ability and possible contribution to the project. The stone pier foundations and pine lumber used in the construction of the church were local materials. The two main doors on the easterly elevation are reminders of the common custom for men and women to enter, and sit on opposite sides of the church.

A cemetery containing approximately 60 graves, of which 42 are marked, is located behind the church, to the west. The cemetery has been used by the community, including people not connected with the church. The earliest legible. dated tombstone, is that of Elizabeth Mole, 1841-1871, a member of the 1853 wagon train. The most recent marker is dated 1994. Two family areas are fenced, and several markers are artistically carved. Three of these graves are those of Confederate veterans of the Civil War, one of a Seminole Indian War veteran, and one of a World War II veteran. It is not known where Thomas Dicks, original owner of this parcel of land, was buried upon his death in 1867. His father-in-law, Thomas Manker, who settled in the area with Dicks, was buried at his home in 1862, leading to the belief that the church cemetery had not yet been established. Two of Manker's daughters, Sarah Ann Hoover, and Harriet Langford, who moved from South Carolina in 1853 are buried in the cemetery.

A one-room, frame school was established a few yards north of the church, called Falling Creek School, in 1887 (Photo 17). Classes were held in the church prior to the construction of the school. The church building served as a place for the students to present special programs, such as at Christmas or school closing exercises. During the 1890s, A.W. Jackson, who headed the school, also held singing classes at Falling Creek Church. These two places were the center of activity for the community. The school continued

in use until the mid-1930s. The initiator of this nomination, Esther Moore, recalls attending school there in 1933. A popular event for many years was the annual Fourth of July picnic held on Falling Creek Church grounds. People came from across the county and neighboring counties to attend. As rural schools were consolidated and small farming ceased, church attendence became smaller, yet the church has never failed to have regular meetings and worship services.

The waterfall at Falling Creek draws sightseers. The nearby Falling Creek Church, remains unlocked and open to visitors. The church is a designated stop-over and point of interest for bicycle tours organized out of White Springs. The church is occasionally used for weddings, for members and non-members. Since 1977, an annual church homecoming and Moore family reunion draw 80 to 100 participants. Every fourth year the Methodist parish holds its Christmas Eve pageant at the church.

Falling Creek Methodist Church has historically functioned as a community center, serving as a place of worship, education, social gatherings, and burial. With the exception of education, the church continues to this day to serve these functions.






