Describe present and historic physical appearance.

The Cyclone Roller Coaster, also known simply as the Cyclone, was built in 1927 on a 75- by 500-foot lot at the intersection of Surf Avenue and West 10th Street in Coney Island, Kings County, New York. According to roller coaster terminology, the Cyclone is classified as a gravity ride of the wood-track twister type (a compact configuration that turns on itself). The ride's three trains, two of which can run at the same time, consist of three linked cars which accommodate eight riders each. A motor-driven chain hoisting mechanism pulls the cars up to the first plunge; thereafter, the trains travel on their own momentum, reaching speeds up to sixty-eight miles per hour and maintaining velocity over the three thousand feet-length of track. The Cyclone remains at its original Surf Avenue location as a featured ride of the Astroland Amusement Park, and is the only roller coaster to remain in operation at Coney Island, a seaside area of Brooklyn which was once dominated by the carnival-like atmosphere of amusement park rides and attractions.

The Cyclone's structure is a steel framework of vertical I-beam posts connected by horizontal tie bars and diagonal cross-bracing members secured by riveted steel plates. This scaffolding-like system supports the wooden track and railings, following the twister-type configuration as it executes six fan turns and nine drops. The ride ends within a tunnel-like frame enclosure, as brakes slow the forward progress of the trains and return them to the coaster's starting point at the loading platform. Renovations to the Cyclone in 1939 reduced the height of the first drop by five feet; in addition, some of the coaster's curves were realigned at that time to provide a quicker, more jolting ride. The only other alterations to the structure itself involve routine maintenance repairs and replacement of deteriorating parts over the years.

Incandescent lights, some of which are attached to the structure by original curved lightposts, follow the Cyclone's contours. Illuminated metal letters, produced by Manheimer & Weiss of New York, spell out "CYCLONE" on each side of the ride's highest peak. More recent signage, advertising "ASTROLAND" in painted letters, has been erected above the historic signage, but does not obscure it. Another sign, apparently dating to the Cyclone's renovations of circa 1939, is affixed to the structure on its Surf Avenue side and vertically spells out "CYCLONE" in neon letters of a modernistic typeface.

The ride's starting platform, entered via a ticket sales area on West 10th Street, is sheltered by a steel arch-framed, gable-roofed canopy whose open sides feature segmental arcades. Incandescent bulbs outline the shelter's architectural features, illuminating the passenger waiting area as well as the coaster operator's station. The Cyclone's original mechanical system was built by Eisenberg Brothers of Brooklyn and housed in a machinery room adjacent to, and partially underneath, the starting platform. The modern mechanical system (installed at an undetermined date) is currently housed in this room. Other resources within the property's historic boundaries include two non-contributing storage sheds beneath the coaster's southern loop and two non-contributing souvenir stands/ticket sales booths (post-dating the period of significance) along the Surf Avenue boundary. The open spaces between the coaster and its historic property boundaries are currently paved and used primarily for storage of building materials and as private parking. The boundary is delineated by a surrounding non-historic metal chain-link fence.

The Cyclone's setting has been altered to some extent due to a decline in the number of amusement parks operating at Coney Island. Its eastern boundary is now marked by the New York Aquarium's parking lot, where originally an amusement park or ride once stood. Originally, the Cyclone was built as an individual ride for Jack and Irving Rosenthal. It remains an individual ride today under license to the owners of Astroland Amusement Park; their park, with its collection of rides, is just across West 10th Street from the Cyclone (to its west). Astroland helps to provide a carnival-like atmospheric setting similar to that which historically characterized much of Coney Island.

improved transportation networks — railroad service from Brooklyn and the Ocean Parkway — brought larger crowds and improved facilities to Coney Island. Grand hotels and restaurants arrayed on the shoreline accommodated wealthy vacationers. In addition to bathing in the ocean, they enjoyed Coney's man-made attractions — three large racetracks, mechanically-driven rides, and technologically-advanced structures like the 300-foot Iron Tower (originally the Sawyer Tower at the 1876 Centennial Exposition in Philadelphia). The "Switchback Railway," the first modern roller coaster (in the sense of cars mounted on wheels and run on rails), premiered at Coney Island in 1884.

Around the turn of the century, Coney Island was transformed by the introduction of the enclosed amusement park. By 1894, there were dozens of separately owned individual rides, but the following year Captain Paul Boyton opened Sea Lion Park, a group of rides and attractions one enjoyed after paying an admission fee at the entrance gate. the next decade, Coney Island's three most famous enclosed parks opened: Steeplechase Park, Luna Park, and Dreamland. These parks popularized thrilling mechanical rides, including big roller coasters and ferris wheels, and developed elaborate pavilions to house other amusements and sideshows. Throughout Coney Island and intermingled with the enclosed parks, individual rides (such as the Barrel of Love and the Hoop-la) continued to attract thrill-seekers, while food vendors, typical carnival games and midway features further enlivened the scene. The typical summer Sunday afternoon crowd averaged around 100,000 people. With the completion of subway lines around 1920, lowerincome visitors paying the five-cent fare) could afford to vacation at Coney Island for the first time. The elegant restaurants, already suffering the effects of Prohibition, were gradually replaced by stands offering cheaper fare. The best known example is Nathan's Famous, which began selling "red hots" (hot dogs) in 1916 for just a nickel. By 1925, this democratization of Coney Island brought the average summer Sunday afternoon attendance to over one million.

Following its introduction to Coney in 1884, the roller coaster was an immediate success, and became an integral component of the Coney Island experience. Descended from eighteenth century Russian ice slides and refined with carriages on artificial hills in nineteenth-century France, early coasters developed rapidly under the guidance

of inventors in the United States after the Civil War. "Artificial Sliding Hills" and "Artificial Coasting Courses" in the 1870s gave rise to the "Switchback Railroad" and other modern coasters at Coney Island. Whether built as an individual ride or as part of a larger amusement park, roller coasters continued to develop throughout the early twentieth century; competition among inventors and builders led to innovations and features which improved the ride's thrills and safety. When constructed in 1927, the Cyclone was a state-of-the-art, wood-track coaster with steep inclines and declines, fan turns along the 3000-foot figure-eight track, and a top speed of sixty-eight miles per hour (far exceeding the average of thirty to forty miles per hour). The Cyclone, like most successful individual rides, attracted customers through its size (ninety-one feet high at "The Big Drop," and occupying a lot 75- by 500-feet), a prominent location adjacent to both the Riegelmann Boardwalk and a station of the elevated train system, and blatant self-promotion (large, illuminated signage).

The amusement parks and other attractions at Coney Island began losing popularity only after World War II; through that period, even wartime blackouts did not dim the spirited play which characterized the area. Soon after the war, however, several of the rides and large parks were destroyed by fire. These losses, combined with a reduction in vacationers (the result of the well-documented exodus from the city to the suburbs after the war), led Coney Island to lose its prominent position as New York's "playground." Neglect, poor planning, and additional fires over recent decades have led to the loss of many more of the resources which characterized Coney Island's recreational resort culture. Of the nearly two dozen coasters which once operated at Coney, only the Cyclone remains intact and in operation today.

The most significant alterations to the property took place in 1939, when the first drop was lowered three feet, the tracks were slightly realigned to increase the ride's speed, and modernistic neon signage, spelling "CYCLONE" in a vertical format, was attached to the structure on its Surf Avenue side. Since that time, replacement—in—kind of deteriorated wood members and repainting as part of a regular maintenance program have been the only significant alterations to the structure. A non—historic storage building and souvenir/ticket sales booths have been introduced within the historic

property boundaries, but their small scale and non-permanent character do not detract from the property's overall integrity. The Cyclone Roller Coaster still conveys the excitement of the coasters once so prevalent at Coney Island; it remains a rare, significant survivor of the earlier era.



The Cyclone Roller Coaster, built in 1927 for entrepreneurs Jack and Irving Rosenthal at Surf Avenue and West 10th Street, is historically significant under Criterion A for its association with the development of Coney Island as New York's premier amusement park entertainment center from the 1880s through World War II. The last functional roller coaster at Coney Island, where more than twenty others once operated, the Cyclone is also the only surviving wood-track coaster at Coney Island. Since its original construction, the integrity and configuration of the Cyclone has remained essentially intact, although maintenance has necessitated replacement—in—kind of some structural elements. As a rare surviving example of the mechanized amusement park rides which once abounded at Coney Island during its heyday, the Cyclone Roller Coaster is a symbolic, functioning reminder of the area's history as a mecca of outdoor recreation.

Coney Island's reputation as a recreational spot and vacationing destination first originated in the mid-nineteenth century, when small seaside hotels provided New Yorkers with an escape from the summer heat of Manhattan and Brooklyn. Beginning in the 1870s,







In addition to its historical significance, it is an outstanding roller coaster. I have been riding coasters since 1948 and have found none better than the Cyclone.



It is one of the few coasters in America left in tact from what was known as the "goldenage" of amusement places, the 1920's. It still uses the original trains which is really quite rare! 

Dear Mr. Berger:

We are pleased to inform you that the property noted above will be considered by the State Review Board at its next meeting for nomination to the National and State Registers of Historic Places. These Registers are the federal and state governments' official lists of historic properties worthy of preservation. Listing in the Registers provides recognition of our national, state and local heritage and assistance in preserving it. Enclosed is a copy of the criteria under which properties are evaluated for listing.

Listing in the National and State Registers affords properties a measure of protection from the effects of federal and/or state sponsored or assisted projects, provides eligibility for certain federal tax provisions and renders certain properties eligible for federal and state preservation grants. There are no restrictions placed upon private owners of registered properties. The benefits of listing are explained more fully in the attached fact sheet.

Owners of private properties proposed for listing in the National Register must be given the opportunity to concur in or object to the listing. Each private property owner has one vote regardless of how many properties or what part of a single property that party owns. A notarized objection by the sole owner of a private property will prevent that property from being listed in the National Register. For properties or districts under multiple ownership, a majority of the owners must object in order to prevent the listing. If a property owner wishes to object to a proposed listing, he/she must submit a notarized acknowledgement that he/she is the owner of the property in question and that he/she objects to the proposed National Register listing. Objections must be submitted before the property is listed. Specific instructions for objecting to National Register listing are given in the enclosed fact sheet.

If a property cannot be listed because of owner objection, the SHPO will submit the nomination to the Keeper of the National Register for a determination of eligibility for listing. Properties formally determined eligible for National Register listing by the Keeper are subject to the same protection from the effects of federally sponsored or assisted projects as are listed properties. There are no provisions in the New York State Properties. There are no provisions in the New York State historic Preservation Act that allow an owner to prevent listing in the State Register by means of objection.

If you wish to comment on whether or not the property should be nominated to the National and State Registers, please send your comments to the SHPO at the address below. Comments must be received by

June 5, 1991 in order to be considered when this property is reviewed by the State Review Board.

Coney's Latest Ride, The Cyclone Opens

CONEY ISLAND, N.Y., July 2 — It's one grand thing after another in Coney. The latest ride sensation that has swept the Island is the cyclone. It lives up to its title, and has already established an enviable reputation as a thriller. It is accumulating the shekels abundantly. Large crowds are in evidence until the 2 a.m. curfew. The location is excellent, in the heart of Coney, where thousands of amusement seekers mill thru the maze of every conceivable form of entertainment, at the corner of Surf avenue and West End street, where the giant coaster formerly dotted the horizon. The Rosenthals, Jack and Irving, are responsible for the cyclone, and they have a 19-year lease on the present site, which is owned by the Coast Holding Company, consisting of many prominent business and amusement men of Coney. The cyclone represents and investment of \$100,000 and is a Harry C. Baker product, pure and simple. The rides was built over the suggestions of the Rosenthals. Its spiral dips are a feature. There are 3,000 feet of track embodied in its construction. Its main drop is 83 feet. One minute and 40 seconds is required to complete this cyclonic ride. It simply wows the riders and the spectators and in itself is a bally par excellence. There are nine cars and each car rides eight people

giving it a total capacity of 72 people at 25 cents each, and 35 cents on Sundays and holidays. Irving Rosenthal is personally in charge of the cyclone. Jess Dupe is general manager. Bill McKee is the superintendent of construction. Vernan Keenan designed the ride. Three brakemen are employed, three secondfare men, two ticket sellers and ticket collectors. The ride occupies a frontage of 75 feet on Surf avenue and 500 feet on West End avenue. Its construction features must be visualized to be appreciated. The power house is a complete unit, and is the work of Eisenberg Bros. of Brooklyn. The National Bridge Company, of New York, installed the steel work. Cross, Austin & Ireland, of Long Island City, furnished the lumber. The stand work was done by Menheimer & Weiss of New York, and represents an expenditure of \$5,100. There is a 45-foot front vertical sign, with four-foot letters, reading "Cyclone". There is a 30-foot entrance sign. There are two signs on the structure, with letters 10 feet high. This is a great repeat ride. One the big days it was impossible to accommodate the repeaters. Negotiations are pending between the Rosenthals and Louis Gordon concessionaire of Luna Park, who expects to acquire an interest in this ride.

The first commercial roller coaster, which appeared at Coney Island in 1884, was an immediate success, and in the following decades hundreds of such rides were built at amusement parks across America, making the roller coaster the most popular of amusement rides and the signature attraction at parks. By the 1920's the technology of the wooden roller coaster had become fully developed, and that heady, prosperous decade saw the construction of hundreds of classic thrillers. In a decade known as the golden age of the roller coaster, a few rides gained reputations that placed them in an elite class above all the others. The Cyclone was one such ride.

The roller coaster never lost its popularity, but the amusement industry did not fare as well. Hundreds of parks closed during the depression. In the postwar years, the decline of parks continued as Americans turned their attention to other diversions such as automobiles and television, and as changing real estate values and urban social conditions forced other parks to close. As these parks disappeared, so did their roller coasters. By the 1970's the number of wooden roller coasters in America had declined from a peak estimated at over 1500 during the 1920's to substantially less than 100.

Fortunately, today the amusement industry is enjoying a second era of prosperity, and each year we are once again seeing the opening of new roller coasters. Most of these new rides are modern steel coasters, but we are also witnessing a resurgence of the wooden roller coaster, a true testament to their unique characteristics and enduring popularity.

Some of the new wood coasters are going higher, and longer, and faster that ever before. A few are attempting to emulate the characteristics of the classic coaster of the golden age, and several have been modeled after the Coney Island Cyclone. But these rides are very different from the original version. Sometimes the subtlest of changes in a ride's layout or profile can make a big difference in the ride experience it delivers. The differences between these newer imitations and the Brooklyn original are both subtle and not-so-subtle.

The curves are a good example. The world class reputation of the Coney Island Cyclone is founded on its superior mix of both steep, stomach-taking drops, and fast, only lightly banked turns, the kind of curves that subject riders to strong centrifugal forces, sliding them into each other or against the side of the seat. On the newer versions, heavy banking has been introduced into the curves for the express purpose of eliminating the centrifugal forces on riders. One might say these rides are producing only half the thrill of the original. Other important differences include the trains. The Coney Island Cyclone's original wood chassis trains, equipped with heavily upholstered seats and simple, traditional restraint systems, afford passengers an experience that is uninhibited, yet safe and comfortable.

In today's business environment it is unlikely that a roller coaster truly comparable to the classic Coney Island Cyclone will ever be built again. While today's larger rides are thrilling in their own special way, the Cyclone delivers its classic thrills in the style of a period that defined the roller coaster as the ultimate thrill ride. One of only a handful of coasters surviving from the golden age, the Cyclone is at the top of its class, and a superlative, working representative the truly classic wooden roller coaster at its best.

In considering the traditional amusement park and the classic wooden roller coaster as significant components of the history American popular culture, it is vitally important that everything possible be done to ensure that the Cyclone survives and continues to deliver its outstanding, time-honored thrills to present and future generations. Placing the ride on the State and National Registers would be an important step.



Dear Mr. Lehman:

At the urging of Mr. Milton Berger, representative of Astroland Amusement Park, Coney Island, Brooklyn, New York, I'm writing regarding the inclusion of the **Cyclone Roller Coaster** into the National and State Register of Historic Monuments. As a founder and the first President of the American Coaster Enthusiasts (a non-profit organization of 5000 worldwide members who seek to preserve these unique thrill devices), I hope that this matter will not be taken lightly and that your office will seriously consider such status for this wonderful piece of Brooklyn history.

Without laboring over the long and intricate history of the roller coaster I wish to present the following facts regarding the **Cyclone's** present fragile condition and why, after reviewing this information, it should receive state protection from the threat of eventual loss.

- (A) What is generally considered the first wood coaster, the <u>Switchback Railway</u>, appeared in 1884 a few hundred feet from the present **Cyclone** site. It's overwhelming popularity attributed to the rapid development of the roller coaster up to the "golden era" of design, the 1920's. Since that first example, over fifty (50) assorted roller coasters have appeared on Coney Island (see list attached) including the first looping coaster in 1895. Between 1907 and 1927, over twenty (20) coasters operated at the same time, a feat unparalled elsewhere in the amusement industry. Since 1983, the **Cyclone** is the <u>last</u> roller coaster to operate at Coney Island. A question could be raised as to why, from such a vast selection, the **Cyclone** is the sole survivor?
- (B) Presently, it is only one of about 85 wooden coasters in North America and one of only five (5) in New York State alone. On a national scale, there are only eight (8) rides older than the Cyclone still operating.

- (C) The metropolitan New York/New Jersey area boasted coasters in every borough/county (including three in Manhattan!), a number that easily approaches one hundred-sixty (160) rides. Only three (3) remain today: two (2) in Playland, Rye, N.Y. and the Cyclone.
- (D) With little objection the Cyclone was recently nominated and selected a Landmark by the New York City Landmarks Commission, a dubious honor from what is usually a very selective committee.
- The Cyclone has gone through several dilemmas. Most recently, (E) inflated insurance costs almost shut it down permanently. In 1975, the nearby N.Y. Aquarium wished to remove the Cyclone for further parking and/or exhibits. While that was unsuccessful, a Houston park studied a proposal to move the Cyclone to a site near the Astrodome. Considered unfeasible, a "duplicate" was erected at Astroworld, in 1976. Titled the Texas Cyclone it has shared top rated honors for over a decade with its Brooklyn counterpart. In 1990, Six Flags Corporation built their version at their Atlanta parks, the Georgia Cyclone, and another in 1991 at their Los Angeles park, apply christened, in a play on words, the Psyclone. No other ride in history has been duplicated to such an extent, especially after operating for fifty (50) years! Obviously these parks have recognized the popularity of the original Cyclone.
- (F) On the many occasions that I personally visited the **Cyclone** it has played host to a contingent of responsible leaders in politics, religion and the corporate world. It is not uncommon to spot Hollywood celebrities who show up in limosines for a few rides. In the past three seasons I have seen *Neil Sedaka*, *Matt Dillon, Kristy McNichols* and *George Plimpton* take a few spins, and I know why! In its 63 years of operation it has entertained an estimated 30 million riders. During it's initial seasons (1927 and 1928) it was getting 25 cents (sometimes 50 cents) per ride, unheard of in the days of the 10 cent ride.
- (G) The Rosenthal Brothers financed the project in late 1926, and later went on to operate Palisades Amusement Park. The ride was designed by Vernon Keenan, with the profile by John A. Miller. What Frank Lloyd Wright was to American Architecture, Miller was to the American roller coaster. No man has designed and built more amusement devices or parks during their lifetime, an amazing tribute to the "master". The engineer was Harry G. Baker, who was heavily involved in the amusement industry and later with the design of the 1939-40 New York World's Fair. While all those involved in the creation of the Cyclone are deceased, it was this combination of futurists, designers and builders which created possibly the most famous roller coaster ever built.

(H) Two world class riding endurance marathons have been held on the Cyclone. Both records were entered into the Guinness Book of World Records in 1975 and 1978.-

In summary, the **Cyclone** is probably the first name people, throughout the world, think of in association with the word roller coaster. Generations of New Yorkers have enjoyed it. It never fails to make the experts "top-ten" rating lists and is generally considered the ride that others are compared with when compiling such ratings.

At this time, with a rústing <u>Parachute Jump</u> on the endangered list and the remainder of the amusement area on the decline, the **Cyclone** represents the best **Coney Island** has to offer. It is my opinion (based on 18 years of research) that **Coney Island**, in its present condition, would eventually cease to exist as an amusement center with the **Cyclone**. It <u>must</u> be preserved to keep the memories of generations alive.

I get no bigger thrill during the many talks and interviews I've done when a reporter, in a puzzled tone, says, the **Cyclone** is still running?... I thought it was torn down years ago". Without a doubt somewhere down the road he's on his way to **Coney Island** to relive his childhood one more time.

Please support this nomination. If the Cyclone is not protected Coney Island will never be the same.

Baker for Jack and Irving Rosenthal, the Cyclone belongs to an increasingly rare group of wood-track coasters; modern building codes make it irreplaceable. I enclose a copy of the findings the Commission adopted when it made its designation.

I urge the State Review Board to give favorable consideration to this nomination at its next meeting.


FINDINGS AND DESIGNATIONS

On the basis of a careful consideration of the history, the architecture and other features of this structure, the Landmarks Preservation Commission finds that the Cyclone has a special character, special historical and aesthetic interest and value as part of the development, heritage and cultural characteristics of New York City.

The Commission further finds that, among its important qualities, the Cyclone is often cited as one of our country's best designed roller coasters, known for its speed and famed for its exhilirating fan turns and steep drops; that it belongs to an increasingly rare group of wood-track coasters, one of about eighty-five extant from the 1,500 that once thrilled America, whose special qualities are natural resilience, distinctive sound, unique aesthetic as a structural frame, and relative ease of replacing parts; that the Cyclone's rarity is assured by modern building codes which prohibit a timber-supported coaster like the Cyclone from being duplicated; that it was built in 1927, at the zenith of Coney Island's popularity; that it is one of nearly two dozen roller coasters built at Coney Island, where the world's first coaster with cars mounted on wheels had been introduced and where the ride came of age; that it was conceived by Harry C. Baker, a leading operator of amusement park rides in the early-twentieth century; and that necessary maintenance and repairs have conserved the Cyclone's original integrity and configuration.

Accordingly, pursuant to the provisions of Chapter 21, Section 534, of the Charter of the City of New York and Chapter 3 of Title 25 of the Administrative Code of the City of New York, the Landmarks Preservation Commission designates as a Landmark the Cyclone, 834 Surf Avenue at West 10th Street, Borough of Brooklyn, and designates Tax Map Block 8697, Lot 4 in part consisting of the land on which the described improvement is situated, Borough of Brooklyn, as its Landmark Site.
