GAMMA-RAY ASTROPHYSICISTS

The Universities Space Research Association (USRA) is currently seeking two astrophysicists to participate in research activities within the Low Energy Gamma Ray Group in the Goddard Space Flight Center's Laboratory for High Energy Astrophysics. The Group develops instrumentation for performing high-resolution gamma-ray spectroscopy on high-altitude balloons and on spacecraft. Data from existing instruments are analyzed and used to study astrophysical source regions. Theoretical studies are performed on gamma-ray emission from sources.

One scientist will participate in studies of gamma-ray emission from astrophysical sources - including theoretical calculations and analysis of gamma-ray and x-ray data. The second scientist will study the sources of instrumental background in spaceborne gamma-ray spectrometers. This will include design studies for future instrumentation like the planned INTEGRAL mission.

Applicants must have a Ph.D. in Physics or Astronomy, and experience working with Astrophysical data and instrumentation. Also, they should be familiar with statistics and the use of computers in analyzing data and modeling astrophysical phenomena. Salary will be competitive, commensurate with experience. A relocation allowance is available if required.
