Subj: Lud Ashley recommendation of Ed Gannon

In his letter to you of 15 May (attached), Lud Ashley recommended a fellow named Ed Gannon for executive director of the President's Commission on Executive Exchange.

This is the outfit which June Walker has headed for several years, and it's where Gov. Sununu and I, with Lee Atwater's urging, decided Betty Heitman should be chief when the Federal Election Commission couldn't work out for her. (Alice Taussig will be the deputy.) I told this to Lud in a phone call today, and he will call me back with some other things in which Gannon is interested. You therefore don't have to reply to his letter.
