




The 101st Airborne is at FOB Cobra, the French are at White, and the 7th Corps is headed for Collins. There was then a brief discussion about war termination.

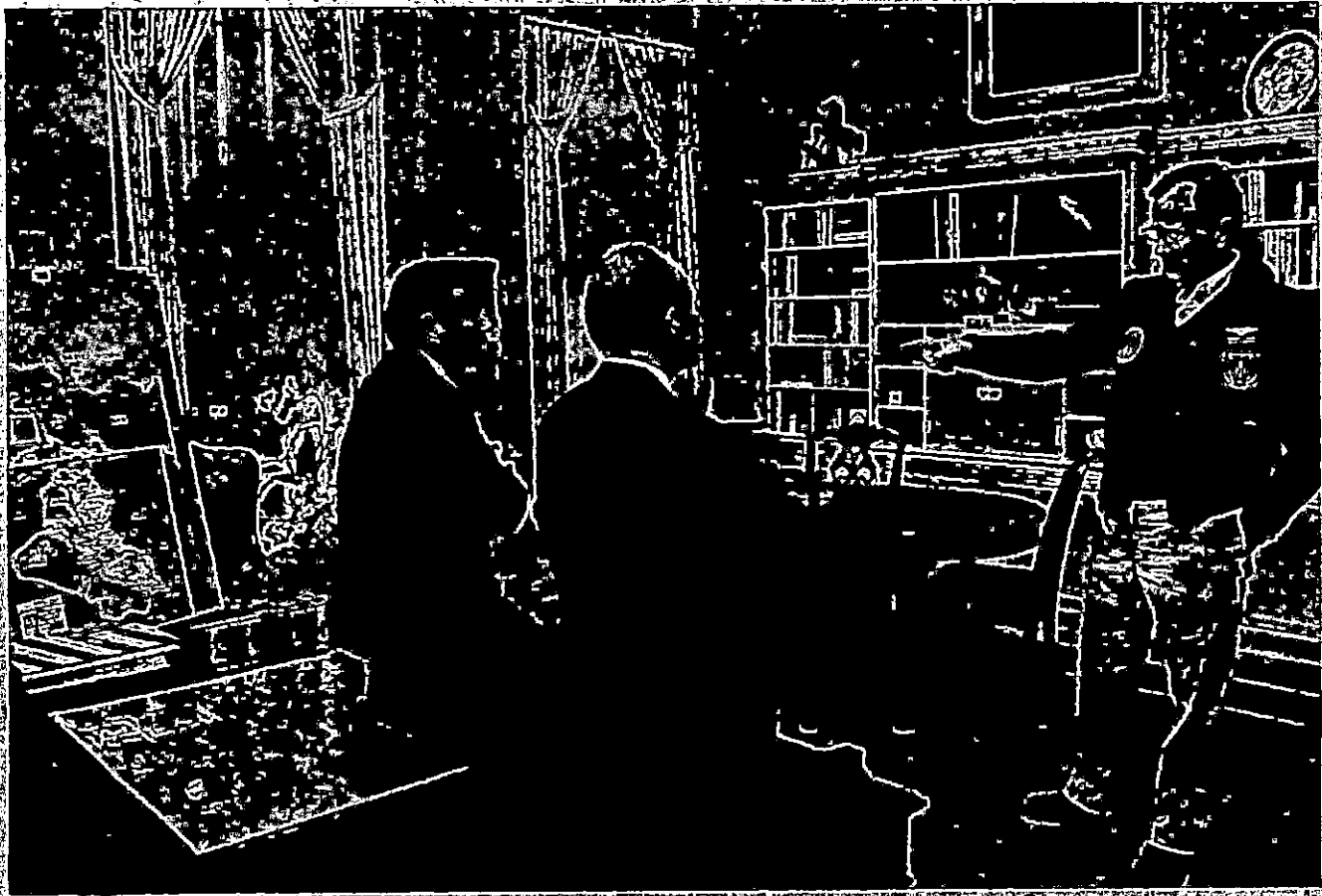

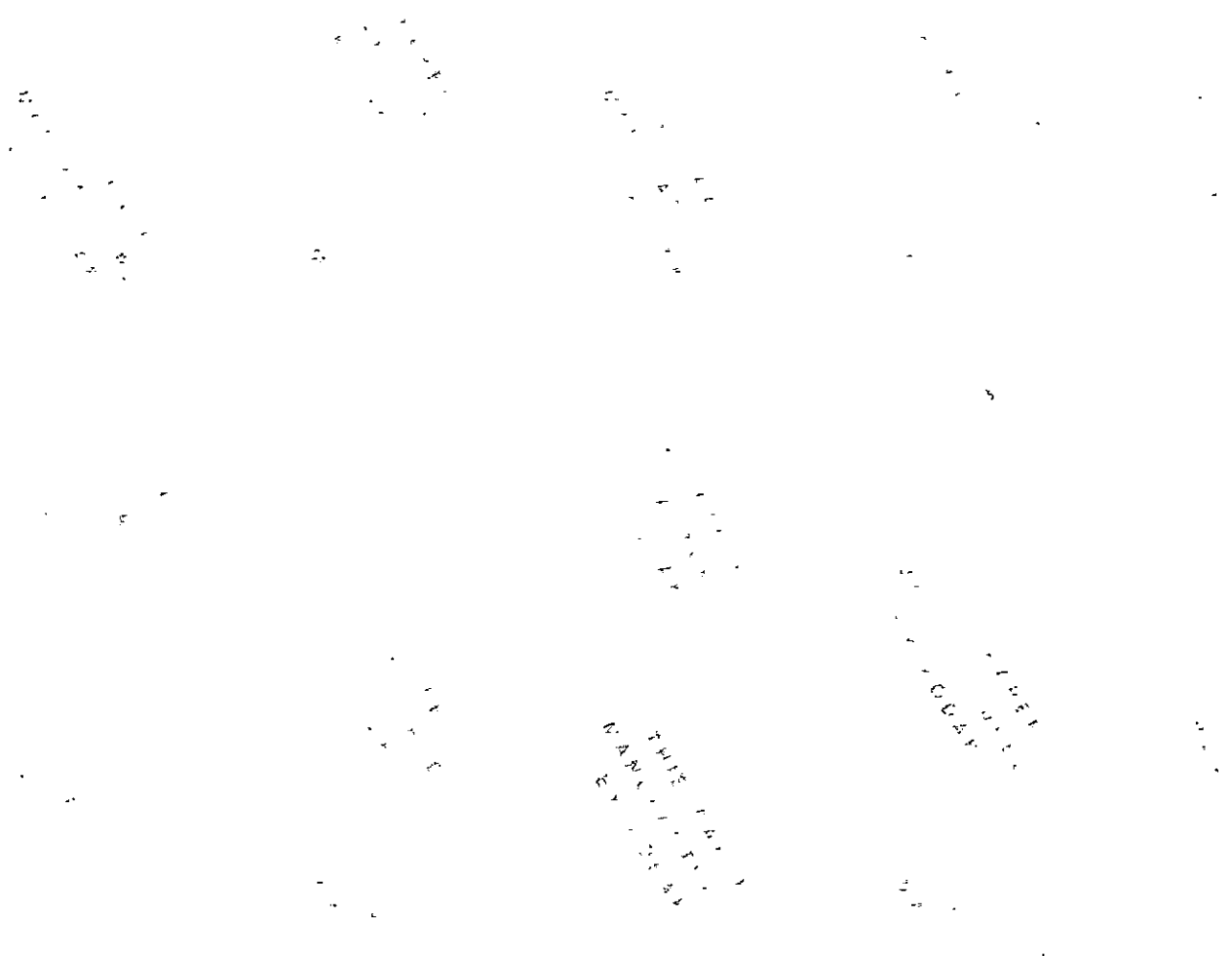
