I AM CERTAIN THAT WE SHALL SEE ONE ANOTHER MORE OFTEN IN THE YEARS AHEAD IN ORDER TO RENEW AND STRENGTHEN OUR FRIENDSHIP AND PLAY OUR MODEST ROLE IN CEMENTING U.S. EGYPTIAN COOPERATION.

MESSAGE FROM PRESIDENT MUBARAK TO PRESIDENT BUSH

DEAR GEORGE ,

I WAS VERY PLEASED TO RECEIVE YOUR THOUGHTFUL MESSAGE IN WHICH YOU CONGRATULATED ME AND THE EGYPTIAN PEOPLE ON THE OCCAISON OF THE TENTH ANNIVERSARY OF THE TREATY OF PEACE BETWEEN EGYPT AND ISRAEL. YOUR MESSAGE, TOGETHER WITH THE JOINT RESOLUTION OF THE U.S. CONGRESS HONORING THE OCCAISON SYMBOLIZE, AMERICA'S FIRM COMMITMENT TO WORK RELENTLESSLY AND VIGOROUSLY WITH THE PARTIES CONCERNED IN ORDER TO STRENGTHEN THE STRUCTURE OF PEACE IN OUR TROUBLED REGION AND HELP THE PARTIES BRIDGE THE GAP BETWEEN THEIR POSITIONS. DURING THE PAST FEW YEARS, THE U.S. PLAYED A PIVOTAL ROLE IN THE PEACE PROCESS, A ROLE WHICH WAS INDISPENSIBLE FOR REACHING AGREEMENT. WITHOUT THIS ROLE THE PARTIES WOULD HAVE WASTED VALUABLE TIME ARGUING OVER CERTAIN POINTS OF CONTENTION HERE AND THERE. THE SIGNING OF THE PEACE TREATY IN WASHINGTON WAS A HISTORIC ACHIEVEMENT OF GREAT SIGNIFICANCE. AS YOU RIGHTLY NOTED IN YOUR LETTER, THAT DOCUMENT STANDS AS A LIVING TESTIMONY THAT DIRECT NEGOTIATIONS WORK AND THAT PEACE IN THE MIDDLE EAST CAN ENDURE. THE TREATY UNDERWENT SEVERAL TESTS, OF WHICH THE TABA DISPUTE WAS THE MOST VISIBLE. FORTUNATELY, IT PASSED ALL THESE TESTS AND CONSEQUENTLY, THE IDEAL OF PEACE EMERGED STRONGER AND GAINED MORE CREDIBILITY. THIS TURN OF EVENTS DEMONSTRATED TO MILLIONS OF ISRAELIS AND ARABS THAT PEACE IS NOT ONLY NECESSARY FOR THE PRESERVATION OF LIFE AND THE ATTAINMENT OF PROGRESS THROUGHOUT THE REGION. BUT IT IS ALSO FEASIBLE TO ACHIEVE WITHOUT ANY UNDUE RISKS. ON THE OTHER HAND THAT REALIZATION PROMPTED THE PALESTINIANS THE COURAGEOUS STEPS THEY TOOK IN RECENT WEEKS ON THE ROAD TO PEACE. CONVERSELY, THE PROPOSITION OF PEACE IS GAINING MORE SUPPORT AMONG ISRAELIS STEADILY. HENCE, I BELIEVE THAT THE TIME IS RIPE FOR EXERTING A CONCERTED EFFORT IN ORDER TO LAY THE GROUND FOR STARTING NEGOTIATIONS WITHIN THE FRAMEWORK OF THE INTERNATIONAL PEACE CONFERENCE ON THE BASIS YOU MENTIONED IN THE LETTER, NAMELY UN SECURITY COUNCIL RESOLUTION 242, SECURITY FOR ALL PARTIES IN THE REGION, AND LEGITIMATE POLITICAL RIGHTS FOR THE PALESTINIAN PEOPLE. NO NATION IS MORE QUALIFIED THAN THE UNITED STATES TO CONTRIBUTE TO THE PROCESS OF GETTING THE NEGOTIATIONS STARTED. IN THE FEW WEEKS THAT PASSED SINCE YOU ASSUMED OFFICE, THE U.S. TOOK A SERIES OF CAREFULLY PLANNED STEPS IN THIS DIRECTION. YOUR ONGOING DIALOGUE WITH BOTH ISRAELIS AND PALESTINIANS IS CERTAIN TO REMOVE MANY OBSTACLES FROM THE ROAD TO PEACE AND CREATE NEW REALITIES WHICH COULD HELP BRING ABOUT THE DESIRED CHANGE. WHEN WE MEET IN WASHINGTON NEXT MONDAY, WE WILL HAVE THE OPPORTUNITY TO DISCUSS IN DETAILS WAYS AND MEANS TO ACHIEVE THAT. I HAVE A FEW

DEAR GEORGE,

I WAS PLEASED TO RECEIVE YOUR LETTER OF MAY 3 1989. AS YOU RIGHTLY STATED, IT IS QUITE FITTING TO LOOK BACK AT OUR ACTIVITIES OF RECENT WEEKS AND CONSIDER THEIR IMPLICATIONS FOR THE FUTURE. THIS IDEA COINCIDES WITH MY APPROACH OF ANALYZING VARIOUS DEVELOPMENTS SYSTEMATICALLY AND ON A REGULAR IN ORDER TO ASSESS THE SITUATIONS AND ADJUST OUR PLANS FOR THE FUTURE.

HAVING SAID, I WOULD LIKE TO ASSURE YOU THAT WE FULLY APPRECIATE THE FACT THAT YOU PUT PEACE IN THE MIDDLE EAST IN THE FOREFRONT OF YOUR AGENDA SINCE YOU ASSUMED OFFICE LAST JANUARY. DURING THE PAST FEW MONTHS SEVERAL POSITIVE DEVELOPMENTS HAVE TAKEN PLACE AND THEY ARE LIKELY TO INFLUENCE THE COURSE OF EVENTS FOR MONTHS. THE PERCEPTION OF MOST MIDDLE EASTERNERS OF THE SITUATION IN THE REGION AND THE PROSPECTS FOR PEACE HAS IMPROVED SIGNIFICANTLY. MEANWHILE, THE IMAGE OF THE U.S. AND THE AMERICAN ROLE IN THE MIDDLE EAST HAS BEEN STRENGTHENED TREMENDOUSLY AS A RESULT OF YOUR ACTIVE POLICY AND THE FAIRNESS YOU PROJECT.

OUR MEETING OF APRIL 3 AND THE EXTENSIVE CONVERSATIONS WE HAD DURING MY STAY IN WASHINGTON WERE QUITE STIMULATING AND REASSURING. THEY CONFIRMED MY BELIEF THAT YOU WOULD PUT THE PROBLEM OF THE MIDDLE EAST HIGH ON YOUR AGENDA AS YOU ARE AWARE OF ITS REGIONAL AND GLOBAL IMPLICATIONS AND ITS FALLOUT ON COUNTRIES THAT ARE FRIENDLY TO THE U.S. YOU WOULD CERTAINLY RECALL THAT WE AGREED, AT THE END OF OUR MEETING IN WASHINGTON, TO DOUBLE OUR EFFORTS AND TO PURSUE VIGOROUS ENDEAVOURS WITH A VIEW TO ADVANCING THE CAUSE OF PEACE IN THE AREA. WE ALSO AGREED THAT THE THRUST OF OUR JOINT EFFORT SHOULD BE DIRECTED TOWARDS THE PROMOTION OF A COMPREHENSIVE PEACE SETTLEMENT THROUGH MEANINGFUL NEGOTIATIONS.

ON THE OTHER HAND, WE SHARE WITH YOU THE BELIEF THAT CERTAIN INITIAL STEPS MUST BE TAKEN IN ORDER TO CREATE AN ATMOSPHERE CONDUCTIVE TO THE DEVELOPMENT OF A POLITICAL PROCESS OF DIALOGUE AND NEGOTIATIONS. IN FACT, I TOOK THE INITIATIVE IN THIS DIRECTION WHEN I PROPOSED IN JANUARY 1988 A FOUR POINT FORMULA FOR A MUTUAL REDUCTION, AND EVENTUALLY THE ELIMINATION OF VIOLENCE. HOWEVER, IT HAS BECOME CONVENTIONAL WISDOM THAT FOR AN IDEA OF IMPROVING THE ATMOSPHERE TO BE OPERATIVE AND EFFECTIVE, IT MUST BE PUT IN THE PROPER POLITICAL CONTEXT AND SHOULD BE GIVEN DUE POLITICAL SIGNIFICANCE. THUS, THE IDEA OF HOLDING ELECTIONS IN THE OCCUPIED TERRITORIES, I.E. IN THE WEST BANK AND GAZA, COULD BE A STEP FORWARD. APART FROM ITS PHILOSOPHICAL AND DOCTRINAL APPEAL, I PUT IN THE CONTEXT OF WHAT I WOULD CALL A MASTER PLAN FOR SOLVING THE ARAB ISRAELI CONFLICT ONCE AND FOR ALL. OUR PURPOSE IS TO ELIMINATE WAR AND DESTRUCTION IN THE REGION AND USHER IN A NEW ERA OF COEXISTENCE, COOPERATION AND GOOD-NEIGHBORLINESS. A SENSE OF STANDING TOGETHER AGAINST THE AWESOME CHALLENGES OF OUR TIME. TO BE PUT IN SUCH A PROPER POLITICAL CONTEXT, IT SHOULD BE LINKED DIRECTLY TO THE NEGOTIATIONS ON THE FINAL SETTLEMENT. IT IS NO

ANSWER TO SPEAK OF SOME SEPARATE AND SPORADIC MOVES HERE AND THERE WITHOUT BEING CLOSELY LINKED TO THE FINAL SETTLEMENT. NOR WOULD IT BE ACCEPTABLE TO LINK ELECTIONS OR ANY SIMILAR STEPS TO INTERIM ARRANGEMENTS OR TRANSITIONAL FORMULAE. IN OTHER WORDS, OUR FOCUS SHOULD BE ON THE CREATION OF A POLITICAL PROCESS THAT PROVIDES FOR A FINAL SETTLEMENT WHICH COULD BE IMPLEMENTED IN PHASES. IF AND WHEN THE IDEA OF ELECTIONS IS PUT IN THE RIGHT CONTEXT, WE CAN PROCEED TO SPEAK OF THE CONDITIONS UNDER WHICH THEY CAN BE HELD FREELY AND DEMOCRATICALLY. FROM OUR LONG EXPERIENCE AND CONTACTS WITH THE INHABITANTS OF THE OCCUPIED TERRITORIES, WE DREW THE CONCLUSION THAT, UNLESS ELECTIONS ARE PART AND PARCEL OF COMPREHENSIVE PROCESS LEADING TO A FINAL SETTLEMENT IN THE NEAR FUTURE, THE PALESTINIAN PEOPLE UNDER OCCUPATION WILL NOT AT ALL TAKE PART IN THE VOTING. THIS IS SO BECAUSE THEY FEAR THAT ELECTIONS HELD OUTSIDE THAT FRAMEWORK COULD BE USED TO PERPETUATE OCCUPATION AND BESTOW LEGITIMACY ON IT. IN DEFERENCE TO YOUR DESIRE OF EXPLORING FURTHER THE IDEA PROPOSED BY PRIME MINISTER SHAMIR, WE REFRAINED FROM MAKING ANY UNFAVORABLE COMMENT ON IT PUBLICITY. LIKE YOU, WE SAID THAT IT WAS INCOMPLETE AND THAT IT NEEDED DEVELOPMENT. I MUST ADD THAT WE WERE DISCOURAGED BY THE NEGATIVE ELABORATIONS HE MADE YESTERDAY. HIS MOST RECENT COMMENTS MAKE THE WHOLE IDEA MORE MEANINGLESS AND LESS RELEVANT.

NEVERTHELESS, WE MADE IT A POINT TO COUNSEL MODERATION AND POSITIVISM TO THE PALESTINIAN LEADERSHIP. I TOLD CHAIRMAN ARAFAT THAT HE SHOULD REMAIN HOPEFUL AND GIVE THE U.S. A CHANCE TO PERSUADE THE ISRAELI PRIME MINISTER TO ELABORATE ON HIS IDEA AND DEVELOP IT TILL IT REACHES ITS POTENTIAL. I MUST SAY THAT ARAFAT DID HIS BEST IN THIS REGARD AGAINST MANY ODDS. FURTHER-MORE, WE WERE ABLE TO MOTIVATE HIM TO TAKE ADDITIONAL STEPS IN THE RIGHT DIRECTION IN THE PAST FEW DAYS. FIRST, HE MADE THE STATEMENT IN PARIS ABOUT THE P.L.O. CHARTER BEING OBSOLETE (OR CADUQUE TO USE THE FRENCH TERM HE USED). THAT WAS A COURAGEOUS AND SIGNIFICANT STEP THAT SHOULD NOT GO UNNOTICED OR UNREWARDED. SECOND, CAME HIS FIRM REJECTION OF THE DEPLORABLE PROPOSAL SUBMITTED TO THE PALESTINIANS BY A HIGH RANKING IRANI OFFICIAL TO ASSASSINATE NATIONALS OF THE WESTERN NATIONS IN REVENGE FOR ISRAELI REPRESSIVE PRACTICES IN THE OCCUPIED TERRITORIES. THE STRONG POSITION TAKEN BY THE P.L.O IN PUBLIC WOULD CERTAINLY STRENGTHEN THE P.L.O. RENUNCIATION OF TERRORISM.

ON OUR PART, WE ARE SEIZING EVERY OPPORTUNITY TO COMMUNICATE OUR VIEWS TO THE ISRAELI GOVERNMENT IN THE HOPE THAT IT MIGHT SEE THE WISDOM OF TAKING A POSITIVE AND CONSTRUCTIVE POSITION THAT WOULD SET IN MOTION THE PROCESS OF COMPREHENSIVE SETTLEMENT. WE ARE DOING SO DESPITE THE NEGATIVE ATTITUDE TAKEN BY ISRAEL IN SEVERAL ISSUES, E.G. THE ESCALATION OF REPRESSION IN THE OCCUPIED TERRITORIES AND DIVESTING THE ELECTIONS PROPOSAL FROM ANY MEANINGFUL CONTENT. IN SHORT, WE DO NOT GIVE UP OR SUCCEED TO DESPAIR EASILY. HAD WE DONE THAT, THE PEACE PROCESS WOULD BEEN HATLED LONG AGO WHEN WE FACED MANY MORE FORMIDABLE OBSTACLES. ON SEVERAL OCCASIONS, WHEN IT WAS APPARENT THAT ISRAEL WAS HOLDING BACK FOR ONE REASON OR THE OTHER, WE PERSEVERED AND EXPLORED EVERY AVAILABLE AVENUE IN ORDER TO CREATE AN OPENING. THIS REMAINS OUR ATTITUDE TODAY AND TOMORROW.

DEAR FRIEND,

I AM CERTAIN THAT YOU MEANT EVERY WORD WHEN YOU EXPRESSED YOUR DETERMINATION AND FIRM COMMITMENT TO HELP EGYPT UNDERTAKE ITS AMBITIOUS ECONOMIC REFORM PROGRAM. WE HAVE ALREADY CREATED A SPIRIT OF MUTUAL CONFIDENCE AND TRUST THAT IS APT TO REASSURE EACH ONE OF

US OF THE GENUINENESS OF THE OTHERS PROMISES AND COMMITMENTS. I NEVER QUESTION THE VALIDITY OR SINCERITY OF ANY STATEMENT YOU MAKE AND NEVER NEED AN ADDITIONAL ASSURANCE.

I HAVE NO DOUBT THAT YOU ARE FULLY AWARE OF THE URGENT NEED FOR EGYPT TO IMPLEMENT AN EFFECTIVE REFORM PROGRAM THAT CAN IMPROVE OUR ECONOMIC PERFORMANCE AND ENABLE US TO PURSUE GROWTH AND DEVELOPMENT VIGOROUSLY. AT TIMES, TECHNOCRATS OF THE IMF AND THE WORLD BANK MIGHT THINK THAT WE ARE NOT DOING ENOUGH OR ARE MOVING SLOWLY ON REFORM. HOWEVER, I AM CONFIDENT THAT YOU KNOW THAT THIS IS NOT THE CASE. WE WILL NOT HESITATE TO TAKE ANY MEASURE OR STEP WHICH IS LIKELY TO SERVE OUR CAUSE. THE RECORD DEMONSTRATES THAT WE UNDERTOOK CERTAIN REFORM MEASURES WHICH MANY OTHER COUNTRIES FOUND IMPOSSIBLE TO TAKE OR WERE FORCED TO ROLL BACK. BUT BECAUSE WE KNOW OUR OWN DOMESTIC SITUATION BETTER, WE ARE MORE EQUIPPED TO MAKE A SOUND JUDGMENT AS TO THE PACE OF CHANGE, ESPECIALLY WHEN IT COMES TO AREAS THAT AFFECT THE NEEDY AND THE POOR. FAILURE TO TAKE THIS PRECAUTION WOULD CERTAINLY RESULT IN A SERIOUS SETBACK TO OUR REFORM EFFORT THAT WOULD PREVENT ANY GOVERNMENT FROM UNDERTAKING SIMILAR EFFORTS IN THE FUTURE. WE ARE PUTTING AMBASSADOR WISNER REGULARLY INTO THE PICTURE AND I AM SURE THAT YOUR ASSISTANTS HAVE A FAIRLY GOOD IDEA OF THE STEPS WE ARE TAKING IN A CAREFULLY DESIGNED SEQUENCE. THEREFORE, WE EXPECT THE UNITED STATES TO BE ACTIVELY SUPPORTIVE OF OUR REFORM POLICY AND USE ITS GOOD OFFICES WITH BOTH INTERNATIONAL INSTITUTION IN ORDER TO PERSUADE THEM TO MODERATE THEIR STAND AND REFRAIN FROM ASKING FOR THE IMPOSSIBLE OR ATTEMPTING TO IMPOSE HARSH CONDITIONS ON US, FOR WE ARE NOT GOING TO ACCEPT ANY CONDITIONS WHICH WE VIEW AS DETRIMENTAL TO OUR NATIONAL INTEREST REGARDLESS OF THE CONSEQUENCES. AT ANY RATE, I KNOW THAT WE CAN CONTINUE TO COUNT ON YOUR UNWAVERING SUPPORT AND BACKING.

IN CONCLUSION, LET ME ASSURE YOU THAT I STRONGLY SHARE YOUR DETERMINATION TO WORK INCESSANTLY FOR STRENGTHENING THE BONDS OF FRIENDSHIPS AND AFFINITY THAT EXIST BETWEEN OUR PEOPLES. WE WILL SPARE NO EFFORT IN OUR DRIVE TO ACHIEVE THAT. I HOPE YOU AND YOUR FAMILY HAD A VERY HAPPY EASTER.

DEAR GEORGE

I HAVE JUST CONCLUDED A BRIEF VISIT TO MOSCOW, WHERE I MET WITH PRESIDENT GORBACHEV FOR THREE HOURS AND SPOKE WITH RUSSIA'S PRESIDENT YELTSIN ON THE PHONE AS HE WAS REPURATING OUT OF TOWN . I WOULD LIKE TO SHARE WITH YOU HERE MY IMPRESSIONS AND THOUGHTS FOLLOWING THAT VISIT ;

FIRST : I WAS PLEASED TO NOTICE THAT BOTH PRESIDENTS GORBACHEV AND YELTSIN ARE DETERMINED TO COOPERATE WITH ONE ANOTHER, AND WORK HAND-IN-HAND, AN ATTITUDE THAT WAS REINFORCED BY THE FAILED COUP ATTEMPT. YELTSIN ASSURED ME OF THAT AND WHENI CONVEYED IT TO GORBACHEV , HE CONCURRED, ADDING THAT COOPERATION BETWEEN HIM AND YELTSIN WAS VITAL FOR THE SUCCESS OF THE PROGRAMME OF POLITICAL AND ECONOMIC REFORM. I ENCOURAGED BOTH MEN TO MAINTAIN THIS ATTITUDE FOR THE GOOD OF THEIR NATION . I POINTED OUT THAT THE MAINTENANCE OF STABILITY IN THE SOVIET UNION WAS INDISPENSABLE FOR THE PRESERVATION OF WORLD PEACE AND SECURITY .

SECOND : I NOTICED THAT PRESIDENT GORBACHEV WAS COFIDENT THAT ALL THE SOVIET REPUBLICS WOULD REMAIN IN THE UNION FOR PEASONS OF SELF-INTEREST. ANY OTHER COURSE OF ACTION WOULD BE DETRIMENTAL TO THEIR VITAL NEEDS AND INTERESTS. VOICES OF DEMAGOGUERY OF AMBITIOUS POLITICIANS MIGHT BE RAISED EVERY NOW AND THEN , CALLING FOR CESSATION. BUT SOON, THESE VOICES WOULD DRAWN AND REASON WOULD FINALLY PREVAIL . ANY REPUBLIC WHICH OPTS FOR CESSATION WOULD ENCOUNTER ENORMOUS AND UNSIRMOUNTABLE PROBLEMS. THE MASSES UNDERSTAND THAT QUITE WELL. HENCE, THE SOVIET LEADERSHIP PLANTS TO HAVE THE AGREEMENT ON ECONOMIC UNION SIGNED AND PUT INTO FORCE SOON . EVEN THE BALTIC STATE ARE INCLINED TO SIGN THAT TREATY. ON THE OTHER HAND, EIGHT REPUBLICS HAVE AGREED ON THE TEXT OF THE NEW CHARTER FOR UNION AMONG SOVEREIGN REPUBLICS. UKRAINE HAS NOT CONSENTED YET TO ADHERE TO THIS DOCUMENTS, BUT HE BELIEVES THAT IT WILL DO SO AFTER HOLDING ITS STATE-WIDE ELECTIONS. THERE

ARE FIFTEEN MILLION RUSSIANS LIVING IN THAT REPUBLIC AND IT WOULD BE BOTH DIFFICULT AND HARMFUL TO CUT THEM OFF FROM THE MOTHER LAND .

IN SHORT, PRESIDENT GORBACHEV FELT THAT THE PROBLEM OF NATIONALITIES IS MANAGEABLE . THE INTERSTATE ECONOMIC COMMISSION HAS BEEN FORMED AND IT WILL START FUNCTIONING WITHOUT DELAY .

THIRD : PRESIDENT GORBACHEV WAS SOUNDED DETERMINED , AND UNWAVERING ON PURSUING ECONOMIC REFORMS . IT WAS EVIDENT THAT THEY WOULD NEED SUBSTANTIAL OUTSIDE AID IN ORDER TO ENSURE THE SUCCESS OF THE REFORM PROGRAM . ONE DAY BEFORE I MET WITH HIM , HE HAD RECEIVED THE NEW BUSINESS GROUP, WHICH ASKED HIM TO SET UP A COMMITTEE ON PRIVATE SECTOR ACTIVITIES . I EXPLAINED TO HIM OUR OWN EXPERIENCE WITH ENHANCING THE ROLE OF THE PRIVATE SECTOR, BOTH IN AGRICULTURE AND INDUSTRY. HE WAS QUITE RECEPTIVE .

FOURTH : IT WAS APPARENT TO ME THAT THE SOVIET LEADERSHIP IS DETERMINED TO MAINTAIN CLOSE COOPERATION WITH THE UNITED STATES IN VARIOUS FIELDS . PRESIDENT GORBACHEV STATED THAT THIS IS A CORNERSTONE OF SOVIET POLICY . HE SPOKE OF YOU HIGHLY AND WITH GREAT ADMIRATION AND RESPECT. HE PRAISED SECRETARY BAKER AS WELL . I UNDERSTOOD THAT YOU WOULD SPEAK TO HIM BY PHONE AN HOUR AFTER WE HAD CONCLUDED OUR MEETING .

FIFTH : THE SOVIET PRESIDENT WAS VERY POSITIVE ON THE MIDDLE EAST PEACE PROCESS . HE FAVORED THE CONVENING OF THE PEACE CONFERENCE AS SOON AS POSSIBLE AND THE ELIMINATION OF ANY REMAINING OBSTACLES SO THAT NEGOTIATIONS CAN BE STARTED FORTHWITH . HE ADDED THAT THEY WERE URGING THE PALESTINIANS TO ADOPT A POSITIVE STAND AND NOT TO MISS THAT GOLDEN OPPORTUNITY FOR PEACE.

SIXTH : PRESIDENT GORBACHEV EMPHASIZED THEIR EARNST DESIRE TO PUT AN END TO THE CONFLICT IN AFGHANISTAN ALONG THE GENERAL PRINCIPLES LAID DOWN IN THE U.S-SOVIET JOINT COMMUNIQUE , ISSUED ON SEPTEMBER 13, 1991 . HE ASKED ME TO USE OUR GOOD OFFICES WITH SAUDI ARABIA AND PAKISTAN IN ORDER TO ENSURE THEIR COOPERATION AND PROMPT THEM TO USE THEIR INFLUENCE WITH THEIR ALLIES THERE .

AT THE END OF THE MEETING, I GOT THE IMPRESSION THAT PRESIDENT GORBACHEV WAS REASSURED AND HOPEFUL. HIS GENERAL OUTLOOK WAS QUITE POSITIVE AND HE SOUNDED DETERMINED TO PURSUE HIS FAR-REACHING PLAN FOR ECONOMIC REFORM AND DEMOCRATIZATION. HE IS EVIDENTLY A FIRM BELIEVER IN DEMOCRACY AT HOME AND COOPERATION AMONG NATIONS. I AM CERTAIN THAT YOU SHARE WITH ME THE VIEW THAT IT IS IN THE INTEREST OF WORLD PEACE AND SECURITY TO HAVE STABILITY PREVAIL THROUGHOUT THE SOVIET UNION. THE SUCCESS OF THEIR ECONOMIC REFORM DRIVE IS OF CRUCIAL IMPORTANCE .

DEAR GEORGE,

I HAVE JUST LEARNED FROM PRESS REPORTS THAT THE U.S. IS CONSIDERING TO PROPOSE TO THE U.N. THE DISPATCHING OF A SIZABLE FORCE TO SOMALIA IN ORDER TO REINFORCE THE UN HUMANITARIAN OPERATION THERE. SOME REPORTS SUGGESTED THAT THE US WILL DISPATCH A FORCE OF ITS OWN FOR THAT PURPOSE AND CERTAIN FIGURES WERE MENTIONED. ALTHOUGH I REALIZE THAT SUCH REPORTS MAY NOT BE ACCURATE, I DEEM IT FIT, AT THIS POINT, TO SHARE WITH YOU SOME THOUGHTS ON THE MATTER.

FIRST; I TRUST THAT YOU AGREE WITH ME THAT ANY ACTION TAKEN WITH REGARD TO THE TRAGIC SITUATION IN SOMALIA SHOULD BE CHANELLED THROUGH THE UN INCLUDING TRANSPORT OPERATION. THAT WOULD SPARE ALL OF US PLENTY OF TROUBLE. SOME UNFRIENDLY SOURCES HAVE ALREADY BEGUN TO REGISTER THEIR OPPOSITION TO ANY FOREIGN INTERVENTION IN AN ATTEMPT TO DISTORT US INTENTION.

SECOND, IN LIGHT OF THE CONTINUOUS DETERIORATION OF THE SITUATION THERE, IT MIGHT BE ADVISABLE IN THE FUTURE TO SEEK FURTHER ACTION BY THE SECURITY COUNCIL. ENFORCEMENT ACTION CAN NOT BE EXCLUDED IF OTHER MEANS ARE EXHAUSTED. HOWEVER, THIS WILL DEPEND ON THE OUTCOME OF THE CONSULTATIONS WHICH ARE UNDERWAY IN NEW YORK. I WILL BE HAPPY TO REMAIN IN TOUCH WITH YOU ON THIS AND OTHER ISSUES IN THE COMING WEEKS.

I HEARD OF IT ONLY ON THE RADIO AND THROUGH THE WIRE SERVICES. AT ANY RATE THIS WILL NOT BLUR THE PICTURE BEFORE OUR EYES AND WE SHALL NOT BE DERAILED IN OUR ENDEAVOR WHICH AIMS AT CLARIFYING THE ISSUE INVOLVED AND HELPING THE PARTIES MAKE THEIR OWN POSITIVE DECISIONS AS THE SITUATION EVOLVES.
