DEAR HOSNI:

THANK YOU FOR YOUR CALL AND FOR YOUR MESSAGE, WHICH I RECEIVED NOT LONG AFTER WE SPOKE.

AS I SAID ON THE PHONE, I AM VERY AWARE OF THE VALUE OF THE U.S.-PLO DIALOGUE, ITS CONTRIBUTION TO THE PEACE PROCESS AND TO THE RESTRAINT OF TERRORISM, AND ITS IMPORTANCE TO THE EFFORTS OF OUR FRIENDS, ESPECIALLY YOURSELF. I HAVE CONSIDERED YOUR POINTS VERY CAREFULLY, OUT OF MY DEEP RESPECT FOR YOUR INSIGHT AND ADVICE, AND RECOGNIZING EGYPT'S ESSENTIAL ROLE IN THE PEACE PROCESS THAT YOU AND I ARE DEDICATED TO CONTINUING.

OUR DIALOGUE WITH THE PLO HAS AS ITS FUNDAMENTAL BASIS THE ORGANIZATION'S ADHERENCE TO ITS COMMITMENT TO RENOUNCE TERROR. THE RECENT SEA ATTACK ON ISRAEL CALLS INTO QUESTION THE INTEGRITY OF THE PLO'S COMMITMENT, PARTICULARLY SINCE ARAFAT HAS NOT DENOUNCED THE ACTION OR DISCIPLINED ABUL ABBAS, SPECIFICALLY BY TAKING STEPS TO SUSPEND OR EXPEL HIM FROM THE EXECUTIVE COMMITTEE. AND, AS I MENTIONED, MY CONCERN IS NOT BECAUSE OF THIS INCIDENT ALONE, FOR I HAVE SEEN OTHER INDICATIONS THAT ARE SERIOUSLY WORRYING.

HOSNI, I ASSURE YOU THAT I DO NOT WANT THE DIALOGUE TO STOP. EQUALLY, I ASSURE YOU THAT I MAY NOT HAVE A CHOICE.

ARAFAT HAS GIVEN US VERY, VERY LITTLE TO WORK WITH. THIS WAS DEMONSTRATED AGAIN BY HIS REPLY TO YOUR INTERVENTION AFTER OUR PHONE CALL. HE MUST KNOW THAT WITHOUT A DENUNCIATION OF THE ATTACK AND STEPS TO DISCIPLINE ABUL ABBAS, THE DIALOGUE IS IN SERIOUS JEOPARDY. I HAVE NOTED HIS PUBLIC DISASSOCIATION OF THE PLO FROM THE ATTACK AND HIS REAFFIRMATION OF THE PLO'S COMMITMENT TO ITS PEACE INITIATIVE. FRANKLY, THAT IS NOT ENOUGH.

AS I TOLD YOU, HOSNI, I AM PREPARED TO WORK TO SAVE THE DIALOGUE, BUT ARAFAT MUST MAKE A MOVE AS WELL IN THE NEXT SEVERAL DAYS. I HOPE THAT YOU WILL CONVEY TO HIM, IN THE MOST SERIOUS OF TERMS, WHAT IS AT STAKE. IF ARAFAT DENOUNCES THE ATTACK AND TAKES THE STEPS TO DISCIPLINE ABUL ABBAS AS NOTED ABOVE (AS WELL AS GETTING PAST THE OTHER WORRYING INDICATIONS THAT I HAVE MENTIONED TO YOU), THEN WE WILL BE ABLE TO DEFEND, INDEED EVEN TO EXPAND, THE DIALOGUE. FAILING THAT, MY OPTIONS ARE BLEAK.

I AM PERSONALLY VERY APPRECIATIVE OF ALL YOU ARE DOING AND OF ALL THAT YOU HAVE DONE. I HOPE YOU WILL BE ABLE TO CONVINCE ARAFAT TO DO HIS SHARE TO KEEP THE DIALOGUE GOING. LET US STAY IN TOUCH.

I JUST READ FRANK WISNEP'S REPORT OF YOUR CONVERSATION WITH
CONGRESSMAN WAYNE OWENS. I WANT TO APPLAUD YOUR CANDOR AND
DIRECTNESS WITH HIM -- YOU DID EXACTLY THE RIGHT THING. IT IS
CRITICALLY IMPORTANT THAT CONGRESS HEAR WITH UNMISTAKEABLE CLARITY
SOME OF THE REALITIES IN THIS CRISIS, AND I CAN THINK OF NO LEADER
WITH GREATER CREDIBILITY THAN YOURSELF IN DELIVERING THIS MESSAGE.

JIM BAKER HAS JUST WRAPPED UP EXCELLENT MEETINGS WITH SHEVARDNADZE,
WHOM I SAW TODAY AS WELL. SHEVARDNADZE MADE A VERY HELPFUL PUBLIC
STATEMENT AGAINST IRAQ'S DELAY TACTICS IN SETTING A REASONABLE DATE
TO SEE JIM IN BAGHDAD. THE SOVIETS ARE WITH US. THE FRENCH
ANNOUNCEMENT OF ADDITIONAL TROOPS WAS ALSO A BOOST. I SEE NO
CRACKS IN THE UNITY OF OUR COALITION, DESPITE IRAQ'S MANIPULATION
OF THE HOSTAGES ISSUE AND ITS EFFORT TO SCHEDULE THE BAKER MEETING
AS CLOSE TO JANUARY 15 AS POSSIBLE. OUR MESSAGE, EITHER PUBLICLY

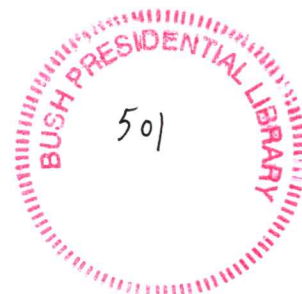

DEAR HOSNI,

WHILE IN MOSCOW ON MARCH 14-16, SECRETARY BAKER RECEIVED A
NEW SOVIET PROPOSAL THEY ARGUE SHOULD BE SUFFICIENT TO
RESOLVE THE IMPASSE OVER THEIR FAILURE FULLY TO IMPLEMENT
THE CFE TREATY. HE IS COMMUNICATING THE DETAILS TO YOUR
FOREIGN MINISTER AND HIS OTHER ALLIED COUNTERPARTS.

AS YOU KNOW, THE SOVIET GOVERNMENT IS NOW ATTEMPTING TO
REVISE ITS CFE OBLIGATIONS ON THE AMOUNT OF EQUIPMENT TO BE
REDUCED, AND THE WAY IT IS TO BE REDUCED. WHILE WE ARE
ENCOURAGED THAT THE SOVIETS ARE SEIZED WITH THIS ISSUE AND
SEEM EAGER TO SEE IT RESOLVED, THEIR OFFER IS NOT
ACCEPTABLE FOR THE SAME BASIC REASON THAT THEIR INITIAL
STANCE IS UNACCEPTABLE: OBLIGATIONS ENTERED INTO IN GOOD
FAITH MUST BE HONORED AND CANNOT BE REOPENED WHENEVER A
PARTY CHOOSES.

ALL OF US MADE COMPROMISES IN THE NEGOTIATION OF THIS
TREATY AND ACCEPTED RESPONSIBILITY FOR THE DECISION TO SIGN
IT. STILL, ELEMENTS IN THE SOVIET GOVERNMENT WISH TO
COMPEL THE OTHER 21 SIGNATORIES OF THE TREATY TO
RENEGOTIATE ITS TERMS AFTER THE FACT. IF WE ACCEPT THIS
TACTIC, WE WILL DO MORE THAN UNDERMINE THE CFE TREATY. WE
WILL ENDANGER THE PROSPECTS FOR PROGRESS IN ARMS CONTROL
ACROSS THE BOARD BY WEAKENING THE BASIS FOR NEGOTIATIONS,
AND UNDERMINING THE EXPECTATION THAT BARGAINING IN GOOD
FAITH WILL LEAD TO A DEFINITE, BINDING CONCLUSION.

I HAVE ALREADY OUTLINED MY CONCERNS ON THIS SUBJECT TO
PRESIDENT GORBACHEV. THE CFE TREATY IS TERRIBLY IMPORTANT
AND WE MUST DO EVERYTHING POSSIBLE TO SEE IT RATIFIED AND
IMPLEMENTED. WE SEEK A PRACTICAL SOLUTION, WITH DUE
RESPECT FOR THE DIGNITY OF ALL INVOLVED. WE ARE READY TO
EXPLORE VARIOUS POSSIBILITIES, SO LONG AS THEY PRESERVE THE
INTEGRITY OF THE AGREEMENT. SPECIFICALLY, I AM PREPARED TO
WORK FOR A SOLUTION THAT COMPLIES WITH THE FOLLOWING
PRINCIPLES: FIRST, TOTAL SOVIET HOLDINGS OF TANKS,
ARTILLERY, AND ARMORED COMBAT VEHICLES IN THE CFE ZONE
(REGARDLESS OF THE BRANCH OF THE MILITARY SERVICE TO WHICH
THEY MAY BE ASSIGNED) CANNOT EXCEED THE LIMITS SPECIFIED IN

THE TREATY. SECOND, ANY SUCH EQUIPMENT IN EXCESS OF THESE LIMITS WILL HAVE TO BE DESTROYED OR CONVERTED USING AGREED PROCEDURES. THIRD, THE SOLUTION WILL HAVE TO BE CONSISTENT WITH THE OTHER TERMS OF THE CFE TREATY (INCLUDING LIMITS ON EQUIPMENT HELD IN ACTIVE UNITS AND CEILINGS ON EQUIPMENT IN SPECIFIED ZONES) SO THAT IT WILL NOT BE NECESSARY TO RENEGOTIATE ITS TERMS. I INTEND TO CONVEY THIS POSITION TO PRESIDENT GORBACHEV. I HOPE YOU WILL BE ABLE TO TAKE A PARALLEL APPROACH IN YOUR COMMUNICATIONS WITH HIM.

ALLIED SOLIDARITY HAS HELPED PRODUCE SOME MOVEMENT FROM MOSCOW. TO GIVE THE SOVIETS ANY REASON TO THINK WE CAN BE DIVIDED OR WEAKENED ON THIS MATTER WOULD SET BACK THE PROSPECTS FOR SUCCESSFUL RESOLUTION OF THE ISSUE. TOGETHER WE CAN CONTINUE TO SHOW THE SOVIET LEADERSHIP OUR FIRM RESOLVE TO STAND BY THE AGREEMENT WE SIGNED IN PARIS.

PLEASE PASS THE FOLLOWING MESSAGE TO PRESIDENT MUBARAK FROM
PRESIDENT BUSH.

BEGIN TEXT:

DEAR HOSNI:

THIS MORNING WE WILL BE GOING PUBLIC WITH OUR EVIDENCE DETAILING LIBYA'S ROLE IN THE PAN AM 103 TRAGEDY AND IN TERRORISM MORE BROADLY. WHAT EMERGES IS A CLEAR AND TO MY MIND PERSUASIVE CASE OF LIBYAN INVOLVEMENT IN AND SUPPORT FOR SUCH ACTIVITY. WHAT WE WILL BE ASKING OF THE LIBYA GOVERNMENT IS THAT IT ACCEPT COMPLETE RESPONSIBILITY FOR THE ACTIONS OF LIBYAN OFFICIALS AND SURRENDER FOR TRIAL ALL THOSE CHARGED, COOPERATE FULLY WITH THE INVESTIGATION, AND PAY COMPENSATION. IN ADDITION, WE ARE DEMANDING THAT LIBYA PROVE IT HAS RENOUNCED TERRORISM BY PROVIDING INFORMATION ABOUT ITS LINKS WITH KNOWN TERRORIST GROUPS, BY EXPELLING THE MEMBERS OF SUCH GROUPS, AND BY CEASING ALL TRAINING, FINANCING AND ARMING OF SUCH GROUPS.

HOSNI, I KNOW THAT YOU AND I DO NOT SEE EYE TO EYE ON YOUR NEIGHBOR. BUT THE INDICTMENTS AND THE INFORMATION NOW AVAILABLE MAKE IT IMPERATIVE THAT QADHAFI DO ALL THAT WE ARE ASKING. HERE I WOULD VERY MUCH APPRECIATE YOUR ASSISTANCE. THE ALTERNATIVE TO HIS MEETING THE REQUIREMENTS SPELLED OUT ARE POLICIES THAT WILL ONLY INCREASE LIBYA'S ISOLATION AND THE PRICE IT WILL PAY FOR WHAT IT HAS DONE.

I HAVE INSTRUCTED MY STAFF TO BRIEF YOUR MOST ABLE AMBASSADOR HERE ON THE EVIDENCE AND WHAT WE ARE DEMANDING OF QADHAFI. AT THE SAME TIME, I WOULD THINK IT WELL WORTH YOUR TIME IF YOU COULD MEET WITH AMBASSADOR PELLETREAU TO HEAR FIRST HAND JUST WHAT WE KNOW. WE WILL WANT TO TALK FURTHER WITH YOU REGARDING WHAT WE SHOULD DO ABOUT THIS. HOSNI,

BOB PELLETREAU HAS REPORTED FULLY TO ME ON YOUR MEETING NOV. 27,
INCLUDING THE PLANNED VISIT OF QADHAFI TO CAIRO AND YOUR THOUGHTS
ON DEMANDS. I HAVE APPRECIATED OUR ABILITY TO CONSULT ON THIS
PROBLEM STARTING WITH MY RECENT MESSAGE TO YOU AND SUBSEQUENT
