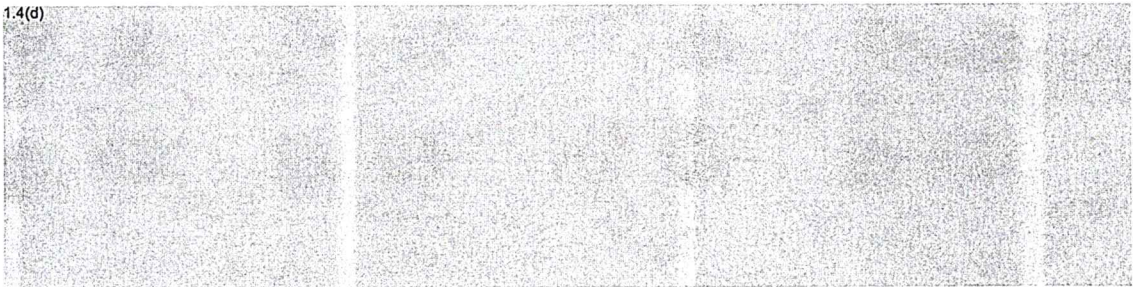

SUBJECT: President's National Security Briefing

The following subjects were discussed:

- There was a long discussion of the Mubarak visit and conversations on Monday. The President asked that Scowcroft fill him in late afternoon on the results of Mubarak's meetings with others during the course of the day.
- In this connection, the President asked that we think about personal touches with respect to the visit of Prime Minister Shamir in terms of equal attention as Mubarak received.
- Scowcroft showed the President a copy of the letter from King Fahd ^{3.3(b)(1)} 
- Scowcroft also gave the President a letter from Prime Minister Thatcher on technology transfer and her desire for an exception for a British company.

He said that just because he is opposed to abortion does not mean he is opposed to family planning and he wants to make sure this is communicated to government organizations.

- Referring to the meeting with the families of the victims of Pan Am 103 on Monday, the President said he wanted to have a more caring knowing policy. He said in the first instance he wants the government to get its act together to ensure that the next time there is a tragedy that the bureaucracy does not swallow communications to or from the families and that the families know immediately that the government has compassion and wants to be as helpful as it can. He also wants further work with the FAA in terms of putting limits on being able to carry radios on planes or whatever other actions can be taken to diminish the threat.
