U.S. equips UNITA with Toyota gun buggies

KINSHASA, Zaire — The United States has stepped up support for Angolan rebels and has shipped specially equipped four-wheel-drive vehicles that could give them an edge, an unnamed U.S. diplomatic source told The Associated Press.

In recent months, rebels of the National Union for the Total Independence of Angola (UNITA) — who receive about \$50 million a year in U.S. aid — have faced one of the biggest offensives in the 15-year-old civil war from the government backed by Cuba and the Soviet Union.

"Three Toyota Landcruisers are being stripped daily here and outfitted with heavy machine guns. They [the rebels] are going to use them for hit-and-run attacks," said the source, adding that at least 120,000 gallons of diesel fuel is also being shipped from Kinshasa to Jonas Savimbi's UNITA rebels.

The United States has pledged to support Mr. Savimbi until Angola's Marxist president, Jose Eduardo dos Santos, agrees to "national reconciliation" — jargon for negotiations that lead to power sharing. During last week's tour of southern Africa by Secretary of State James A. Baker III, a senior official traveling with him said Washington would not let Angola crush UNITA.
