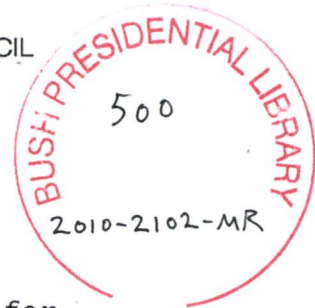

It was agreed that:

- Although the charge would have final discretion, one attractive option to accommodate Liberian threatened with massacre in an extremis situation would be to shelter them at the Greystone compound across from the Embassy compound. (S)
- State should publicize effort already made to encourage American citizens to leave Liberia. (C)
