Minutes

Mr. Gates: At today's meeting I would like to talk about the gameplan on how to deal with BW and the Soviets: First, whether to recommend that Secretary Baker go ahead and raise this again with Shevardnadze in Paris on Wednesday or his next meeting with Shevardnadze? Two, where we stand with this issue and the United Kingdom? Third, the White Paper and the prospective Soviet responses and what we would do with them. (TS)

This matter has a long history. We began a couple of months ago with the UK and the U.S. Ambassadors going into the Foreign Ministry in Moscow with a demarche. Baker raised it directly with Shevardnadze in May. The President raised it with Gorbachev at the Summit and finally Mrs. Thatcher has also raised it
