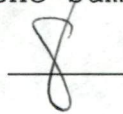

It was agreed that:

- The NSC and State would work on a decision paper for the President on the U.S. role vis-a-vis the ECOWAS intervention in Liberia. This would entail a phased, calibrated approach including public support, a liaison mission and then possibly some limited material support beginning with small items such as maps, etc. (8)
