I think you ought to say skateboarding is not a crime. I don't know why people say it is. I think they should not have filled in the skate parks in the first place.

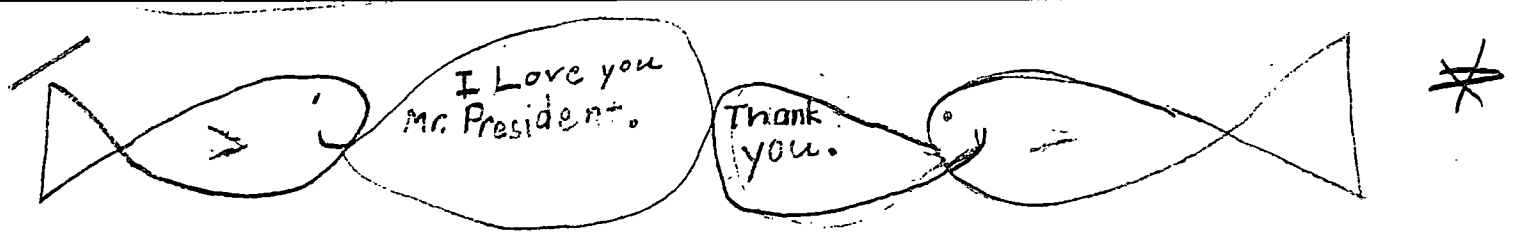
The reason I want you to is because I don't have anywhere to skateboard.

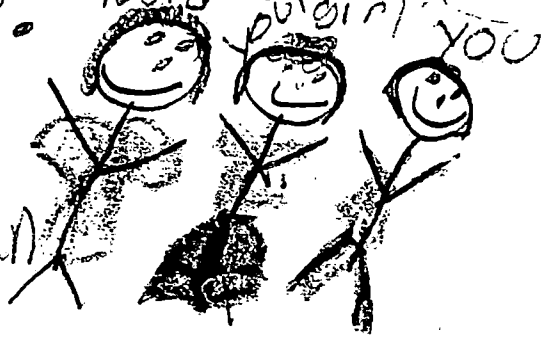

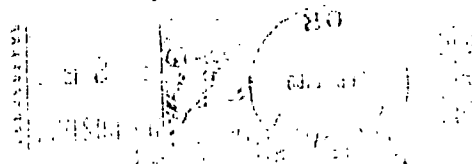
