THE PRESIDENT HAS SEEN

- Economy's foundation is strong, but is going through a challenging period (housing, energy prices). Economic growth has slowed.

- Congress should approve the Colombia FTA this year. This FTA will level the playing field -- over 90 percent of U.S. imports from Colombia now enter our country duty-free, but U.S. exports to Colombia face tariffs up to 35 percent.
- Colombia is an ally confronting violence, terror, and drug traffickers -- and recent provocative measures by the regime in Venezuela.
- Failure to approve this agreement would let down a close ally, damage our credibility in the region, and embolden the radical leaders in our hemisphere.
- Republicans and Democrats should come together and approve this agreement to show people across the region that they can count on America to keep its word -- and on democracy and free enterprise to lead to a better life.
