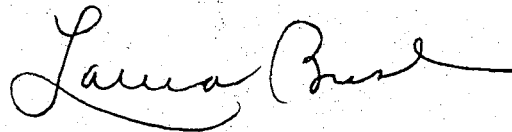

Last week, for the first time in several years, I had occasion to speak by telephone to Sister Ann Therese, a nun of Mother Teresa's order of Missionaries of Charity, who had been visiting Washington briefly. Sister Ann Therese was a source of prayer and support for me personally during the eight years that our little First Lady's Prayer Group prayed for Hillary Clinton. In the past, Sister Ann resided in Washington at the convent for contemplative (not active) Missionaries of Charity sisters in Anacostia. She is currently residing in the Bronx, New York. In addition to prayer, her duties now include keeping records of any miracles submitted to her order from around the world, as having been accomplished through the intercession of Mother Teresa since her death.

In our conversation on Wednesday, September 5th, I told Sister Ann Therese that our little prayer group was carrying on, now praying for you. I told her that we anticipated your attendance at our next prayer gathering on September 26th. She then spoke to me with conviction and rare insistence the following words (quote is virtually verbatim):
"You must tell Mrs. Bush that she and her husband should be prepared spiritually to come under attack due to her husband's efforts to protect the unborn. Satan is outraged at the President for this. The attacks will threaten them physically, but will not generally be associated by most people with the President's stand for life. Nonetheless, this will be the spiritual reality behind them."

I did not recall Sister's words until last night. In the light of Tuesday, they seem prophetic to me. I know Sister to be a holy and wise woman. I believe that her words and insight must be the fruit of her life of countless hours of prayer day and night before JESUS in the tabernacle. I thought that her words might be a source of deepened understanding of the significance of Tuesday's events in your life personally, as well as for our nation. *Understanding* is one of the seven gifts of the Holy Spirit. It permits us to assess events in the light of an eternal perspective.

May God bless you and keep you, your husband, and your family during these extraordinary times. I know that I join millions of others throughout the world in my constant daily prayers for you all.
