Foreword

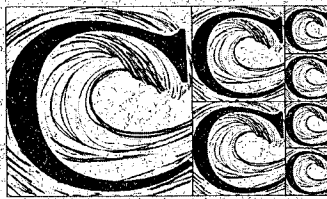

... So when they had dined, Jesus saith to Simon Peter, "Simon, son of Jonas, lovest thou Me more than these?" He saith unto Him, "Yea, Lord; Thou knowest that I love Thee." Jesus saith unto him, "Feed My lambs." He saith to him again the second time, "Simon, son of Jonas, lovest thou Me?" He saith unto Him, "Yea, Lord; Thou knowest that I love Thee." Jesus saith unto him, "Tend My sheep."



He saith unto him the third time, "Simon, son of Jonas, lovest thou Me?" Peter was grieved because He said unto him the third time, "Lovest thou Me?" And he said unto Him, "Lord, Thou knowest all things; Thou knowest that I love Thee." Jesus saith unto him, "Feed my sheep." —John 21

Simon Peter is Amway, with its established rules of conduct. The disciples are the board members, doing business as usual with a concept that has proven to be successful in the past. Nighttime is the season Amway is in now. It's a time that despite operations restructuring, sales revenue has not been restored to the level it had once achieved.
