A Push to Prosperity: The Millennium Challenge Account

While the United States and its allies have fought to keep the world free from terror, developing countries can stifle the seeds of terror by fighting poverty at home. Several poor nations have already nurtured hope and opportunity through better schools, healthier children, freer markets and more scrupulous officials. But meager rain or a failed bank can quickly derail the delicate growth that emerges, sending the poor back to lives of uncertainty and despair.

President Bush seeks to turn these fragile nations into engines of growth through his innovative Millennium Challenge Account (MCA). Currently before Congress, this bold initiative will expand the circle of democracy and stability.

Development with a Difference

The MCA transforms struggling countries into models of success through several innovations designed to increase the flexibility and rigor necessary for real growth.

Focus on growth. The MCA departs from traditional assistance programs by focusing exclusively on development, particularly helping good governments establish conditions for growth. MCA activities such as adding primary schools for girls, applying new technology to rural farms, and training potential entrepreneurs give the poor more choices to find livelihoods they can happily sustain.

Select worthy countries. The MCA targets only those countries that govern justly, invest in people and promote economic freedom -- the crucial elements that alleviate poverty. By pinpointing assistance to countries ready and eager to promote the welfare of their people, the MCA increases the odds of sparking successful development with U.S. dollars.

Include all voices. The MCA drives development to occur from within rather than imposed from outside. The government must engage businesses, communities and citizens to develop an MCA proposal that encompasses the resonant voice and wide-ranging needs of those who can best identify on-the-ground hurdles to progress.

Full participation ensures that the MCA finances those priorities most important to the people, strengthening the ability of the poor to improve their own lives.

Work with partners. When the proposal becomes a program funded by MCA, the country enters into a unique partnership with the U.S. Founded on a business-like contract that sets out specific benchmarks and expected results, the U.S. and the recipient country commit to clear goals as equal partners. They share responsibility for monitoring progress and evaluating results, an exceptional union in delivering development aid.

The innovative use of a contract effectively promotes the country from a sidelined receiver of charity to an active participant in building the foundation for its own sustainable development. This mutual accountability embraces the human dignity of its recipients.

Keep it lean and mean. These new elements of providing foreign aid - the focus on development, rigorous selection process, participatory role of peoples, and partnerships through corporate contracts - require an independent organization to disburse funds with the utmost

flexibility and authority. The Millennium Challenge Corporation (MCC) will employ a small staff to realize the MCA mandate efficiently and creatively.

Deserves Congressional Support

The President has asked Congress to start the MCA with an initial jolt of \$1.3 billion. Even with this addition, the total amount of U.S. foreign assistance remains less than one percent of the federal budget, a small price to pay for enhancing the well-being and security of people worldwide.

The MCA Bill deserves the strong support of your representatives in Congress. A deep and flexible MCA mandate can catalyze real change, raising confidence among the poor.

Even as we seek to fight terror, we must promote the values that make life worth living.
