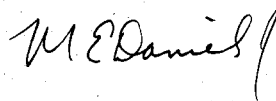

An Act

SECTION 1. SHORT TITLE.

This Act may be cited as the "District of Columbia Police Coordination Amendment Act of 2001".

**SEC. 2. PERMITTING ADDITIONAL FEDERAL LAW ENFORCEMENT
AGENCIES TO ENTER INTO COOPERATIVE AGREEMENTS
WITH METROPOLITAN POLICE DEPARTMENT OF THE DIS-
TRICT OF COLUMBIA.**

Section 11712(d) of the National Capital Revitalization and Self-Government Improvement Act of 1997 (D.C. Code, sec. 5-133.17(d)) is amended by adding at the end the following:

"(33) Any other law enforcement agency of the Federal government that the Chief of the Metropolitan Police Department and the United States Attorney for the District of Columbia deem appropriate to enter into an agreement pursuant to this section."

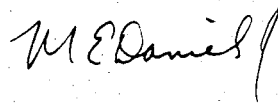
Under current law (P.L. 105-33), thirty-two specific Federal agencies are permitted to enter into cooperative agreements with the Metropolitan Police Department of the District of Columbia. These agreements allow Federal agencies to send personnel on patrol in areas of the District which immediately surround the area of the agency's jurisdiction, and to share equipment and radio frequencies.

H.R. 2199 would amend P.L. 105-33 to permit any Federal law enforcement agency to enter into a cooperative agreement with the Metropolitan Police Department of the District of Columbia, if deemed appropriate by the Chief of the Metropolitan Police Department and the United States Attorney for the District of Columbia.

According to the Senate Governmental Affairs Committee report on H.R. 2199, the 1997 law "inadvertently omitted certain agencies [and] H.R. 2199 addresses this problem by adding a new catch-all clause to encompass any other Federal law enforcement agency."

Conclusion and Recommendations

We join the Department of Justice in recommending approval of H.R. 2199, which passed the House by a vote of 420-0 and the Senate by unanimous consent.

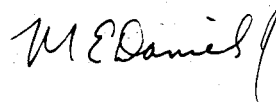
