Dear President Carter:

Your luncheon on July 30 was a great success. Thank you for including me. From the Camp David meetings, I have expanded my comprehension of national problems and have also been able to put my personal situation in perspective.

I do understand and wish you well as you realign staff, but I also take the liberty of informing you of the nature of my own personal and institutional problems that have resulted from my brief interlude with your administration.

To respond positively to Secretary Califano's request that I become Under Secretary of HEW on September 1, Wellesley College granted me a leave of absence for sixteen months and requested Dr. Carol Johnson Johns of Johns Hopkins to act as President. John Hopkins in turn went about freeing Dr. Johns and her husband. She is Associate Professor of Medicine and head of the outpatient clinic, and he is chairman of the Biomedical Engineering Department of the University medical school. Wellesley is committed to this arrangement, and I must move by August 20.

I rented an apartment in Washington, contracted for a mover, and immediately resigned from all boards and outside affiliations as requested by those responsible for my clearance. I did all this in the interest of being of service to the government, despite personal financial loss.

Recognizing the hardship in my case, a number of your staff have asked what positions would be of interest. You will be appointing a Secretary of Education, upon the final passage of the legislation. The quality of this appointment will affect greatly the future effectiveness of the department. I believe you would find my credentials exceptional for the position of Secretary of Education, for I have worked in the public and private sector on problems related to all levels of education. I gather you feel pressured to make an appointment that is sensitive to ethnic considerations.

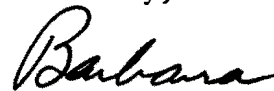

My professional field was comparative economic systems and labor economics. I have traveled internationally both on behalf of the United States Government and Wellesley College.

When you consider the disruptions of two educational institutions that the cancelation of my potential appointment has caused, I am sure you can understand the awkward position in which I find myself. Pat Harris told me of your concern for my predicament, and I believe I can bring strength to your administration.

I look forward to hearing from you about my interest in the post of Secretary of Education or an ambassadorial post.
