Dear Dr. Myers,

The President will be releasing a new HIV/AIDS initiative that targets Africa, as well as countries such as India. The release date appears to be this Monday. This initiative will significantly increase USG funding for AIDS in developing countries and allow us to combat this terrible tragedy.

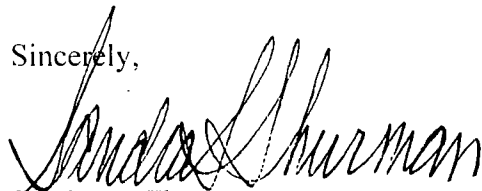
As part of the initiative, a series of recommendations will be issued. One will be for the White House and the Commerce Department to host a meeting of business leaders to discuss AIDS in developing countries, as well as to increase their commitment as important stakeholders. Given Ford's leadership in AIDS in the workplace and community outreach work in South Africa and elsewhere, we would very much like for the Ford CEO to co-chair this meeting when it is scheduled (no dates available yet).

At this stage, we would very much like to know whether the Ford CEO is willing to co-chair the meeting with the Secretary of Commerce at a time to be scheduled sometime this year.
