You are invited to an important Interagency Working Group meeting on the Administration's response to the global HIV/AIDS crisis, co-chaired by Sandy Thurman, Director, Office of National AIDS Policy, and Ken Bernard, Special Advisor to the Assistant to the President for National Security Affairs, NSC, at 1:30 p.m. on Tuesday, February 8, in Room 208 OEOB.

As a follow-up to the landmark January 10th, UN Security Council meeting on AIDS and Africa, chaired by the Vice President, we are charged with developing a plan to advance the Administration's and international efforts to combat the disease. In preparation for a possible Principal's Meeting addressing AIDS as a priority national security issue, we are tasked with developing recommendations to enhance bilateral and multilateral efforts. As appropriate, these recommendations will be presented to the President for his consideration.

Tentative Agenda for the meeting:

- Introduction: Leon Fuerth, National Security Advisor to the Vice President
- Review of the "LIFE" Initiative and other programs: Sandy Thurman
- Summary of State Department follow-up: Dr. Jack Chow, Senior Advisor on Global Health Policy, Department of State
- Discussion on how the Administration should organize to address AIDS as a national security issue: the group
- Review and discussion of proposals for new initiatives: the group
- Discussion on how to best use the opportunity presented by the International AIDS Conference, Durban: USAID/HHS
- Next steps: Co-chairs.

In preparation for this meeting, please bring a summary of your agency's current international AIDS activities (with budgets) and possible new initiatives and ideas in support of the Administration's enhanced focus on the issues. Summaries should be no longer than two pages. We ask that you bring a sufficient number of copies to pass to all participants.

We intend to be finished with the planning process and development of recommendations by the end of February. See you on the 8th.
