I received your letter regarding the proposed reprogramming of funds from the National AIDS Program Office (NAPO) to the National AIDS Policy Coordinator (NAPC).

I have two substantive concerns about the request. First, I feel it is inappropriate to transfer resources from public health agencies to the White House. In addition, because the conference committee on our bill dramatically reduced funding for NAPO from the House-passed level, I am reluctant to approve a further reduction in funding at this time.

Nancy, although we disagree on the matter of the reprogramming, I would be happy to discuss these matters with you in the context of the 1996 L/H/E bill, and I look forward to working with you throughout the year.

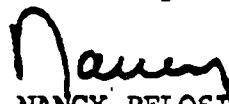
I am writing to urge your approval of the reprogramming request from the Department of Health and Human Services (HHS) to use \$350,000 from funds appropriated for the National AIDS Program Office (NAPO) to partially support the office of the National AIDS Policy Coordinator (NAPC).

The budget justification from the Department made clear that NAPO funds were intended to support the coordination efforts within the Public Health Service and the coordination efforts across Departments by the National AIDS Policy Coordinator. The Interdepartmental Task Force on AIDS is designed to assure that the public health efforts of the PHS are integrated into the activities of other departments.

Data released by the Centers for Disease Control and Prevention (CDC) released last week documented that "the magnitude of the epidemic is clearly greater than earlier statistics indicated." In my view, the Congress needs to work cooperatively with the Administration to do whatever is necessary to coordinate our national AIDS efforts.

Again, I urge you to approve the HHS reprogramming request and I look forward to working with you to respond to the many challenges created by the AIDS epidemic.

Dear Nancy:

I have enclosed for your review three pending reprogramming letters from two of our Departments. These letters were sent to the Subcommittee after Congress had adjourned last fall. The first letter is from the Department of Labor. It is a request to transfer \$3,806,000 from the State Unemployment Insurance and Employment Service Operations account to the Program Administration account of the Employment and Training Administration. The Program Administration account is the basic salaries and expenses account of the ETA. The funds would be transferred from excess postage funds in the State Operations account. The 1995 appropriations act provides the Department the legal authority to transfer money between appropriation accounts; there is an understanding, however, that any transfer would be treated as a reprogramming of funds.

The second letter is from the Department of Health and Human Services. It informs the Subcommittee of the Department's plans to use \$350,000 of funds appropriated to the National AIDS Program Office to partially support the National AIDS Policy Coordinator in the White House.

The third letter is also from the Department of Health and Human Services. It informs the Subcommittee of the Department's plans to use \$400,000 of funds appropriated to carry out a new crime prevention program authorized by last year's Crime Bill to partially support the Ounce of Prevention Council established by the Crime Bill.

This Council cuts across several Cabinet Departments and is to be chaired by the Vice President. It is supposed to oversee the coordination of crime prevention programs in the Executive Branch.

I am presently inclined to turn down all three of these requests. Please let me know if you feel strongly about any of these.

Dear Mr. Chairman

I am writing to inform you of our plans to use \$350,000 of FY 1995 funds appropriated for the National AIDS Program Office to partially support the National AIDS Policy Coordinator (NAPC). These funds were included within the appropriation account for the Office of the Assistant Secretary for Health.

I am fully aware that in your deliberations on the budget for this Office, a concern about the level of resources needed for directing and coordinating HIV/AIDS activities emerged. The Conference agreement specifies that \$1,750,000 is available for these purposes. As noted in our justification to the Committees, funding was requested to provide support to both the Assistant Secretary and the NAPC.

The \$350,000 identified for NAPC will be used to cover such expenses as rental of office space, communications, travel, supplies and equipment, and other support and contractual services. During FY 1995 the NAPC has been asked by the President to establish a new Interdepartmental Task Force on AIDS to ensure that HIV related activities of all Federal agencies are better coordinated and that inconsistencies in strategies and duplication of effort are eliminated.

I appreciate the Committee's continued interest in, and support of, this Department's response to the HIV/AIDS epidemic.
