A Troubling Question for the FBI

AS THE CLINTON White House and Republicans in Congress play "gotcha" with each other over the improper use of sensitive background investigation files, their political gamesmanship risks overshadowing a serious question that has emerged concerning the FBI. Do FBI agents falsify interviews they claim to have conducted? It is a troubling issue, and here is why we ask.

Last week Rep. William Clinger (R-Pa.), chairman of the House Government Reform Committee, took to the House floor and disclosed that an FBI background investigation of former White House personnel security chief Craig Livingstone contained a 1993 interview with then-White House Counsel Bernard Nussbaum conducted by FBI agent Dennis Sculimbrene. In it, Mr. Nussbaum is reported as saying that Mr. Livingstone had come "highly recommended to him" by Hillary Rodham Clinton. Agent Sculimbrene also reported that Mr. Nussbaum had said that Mrs. Clinton had known Mr. Livingstone's mother "for a longer period of time."

Mr. Nussbaum, who earlier had told Congress under oath that he never had discussed Mr. Livingstone with Mrs. Clinton, issued a statement denying that he had made any such remarks to Agent Sculimbrene. Mrs. Clinton also said she hardly knew Craig Livingstone, had nothing to do with his being hired and did not know his mother, Gloria Livingstone. Mrs. Livingstone issued a statement that she doesn't know the first lady and never has met or spoken with her. The

accuracy of Agent Sculimbrene's report, therefore, is in question and raises a major concern.

The fact that another FBI agent—Halbert Gary Harlow, who had assisted with White House background checks in 1994 and 1995—was charged and eventually convicted last year of falsifying at least 50 interviews that he claimed to have conducted is a shocking indication that false FBI reporting can occur. Each year, the FBI probes scores of citizens to help determine their suitability for government posts. Little wonder the specter of an FBI agent reporting a conversation that never took place is chilling.

FBI officials are scheduled to testify before the House Government Reform Committee tomorrow. Expect a Democratic rumpus over whether Rep. Clinger was right or wrong to divulge information from Craig Livingstone's FBI file on the House floor. The chairman had been invited to review the file by FBI Director Louis Freeh. But the White House and its congressional defenders contend that the chairman divulged restricted information that was false. Look, too, for GOP countercharges that the FBI improperly tipped off the White House about Agent Sculimbrene's potentially damaging interview with Mr. Nussbaum just prior to Rep. Clinger's review of Mr. Livingstone's file. Republicans also will assert that two FBI agents went to Agent Sculimbrene's home in an attempt to intimidate him.

All of those accusations deserve responses. But in light of what's known, an equally large question deserves answering. Can FBI background investigators be trusted?

FACT SHEET

Sculimbrene's allegations have been disputed by all parties:

- **Mrs. Livingstone states:** "I do not know Hillary Rodham Clinton, I have never met Mrs. Clinton, and I have never spoken with Mrs. Clinton. We are not, and never have been, personal friends." [Statement of Mrs. Gloria Livingstone, 7/25/96]
- **Mr. Nussbaum states:** "I never told FBI Agent Sculimbrene, or anyone else, that the First Lady recommended Craig Livingstone for his position in the White House or that the First Lady knew Livingstone's mother." [Statement of Mr. Bernard Nussbaum, 7/25/96]
- **Mrs. Clinton has stated:** "I did not know his mother. I did not know him. I did not have anything to do with his being hired." [First Lady Hillary Rodham Clinton's statement in Helsinki, Finland on 7/10/96]

Today Representative William Clinger, hiding behind the legal fig leaf of the Speech or Debate Clause, took the extraordinary step of divulging on the House floor highly confidential and completely false information from an FBI background investigation.

Congressman Clinger has failed utterly to prove that the White House ever improperly released any private information from FBI files. Thus, today's astonishing speech by Mr. Clinger represents the first and only disclosure of confidential FBI background information during this entire matter.

What is worse, Congressman Clinger divulged confidential information that is clearly false and that originates from a questionable source. Bernard Nussbaum has said that the alleged conversation between Mr. Nussbaum and FBI Agent Dennis Sculimbrene never took place. Mrs. Livingstone has said that she does not know the First Lady and has never even met or spoken with Mrs. Clinton. And the First Lady has said that she does not know Mrs. Livingstone.

In addition, Mr. Clinger surely knows that, according to a published report, an FBI agent informed his superiors that Agent Sculimbrene harbored "very bitter political feelings against the White House." This same FBI agent also charged Agent Sculimbrene with "irrational" behavior. (Washington Post, June 28, 1996.) Yet other published reports indicate that Agent Sculimbrene is involved in a continuing dispute with the FBI regarding his work assignments. And, in recent weeks another FBI agent who had been assigned to the White House and worked with Agent Sculimbrene published a book containing wild rumors and rank innuendo; that book was thoroughly and completely discredited.

Nonetheless, Representative Clinger took to the House floor and divulged false information from a confidential FBI report in a desperate attempt to grab attention for his faltering "investigation." Mr. Clinger's speech today will be seen by most Americans as a reckless, partisan act.

Dear Director Freeh:

As you may know, Congressman Clinger today divulged, on the House floor, an interview report from a confidential FBI background investigation that has been declared to be false by the person who was interviewed. I am writing to you to ask how we can work together to ensure continued public confidence in the accuracy of FBI investigations.

According to Mr. Clinger's statement today, the background investigation file on Mr. Craig Livingstone includes a report by Agent Dennis Sculimbrene on a conversation he says he had with White House Counsel Bernard Nussbaum concerning Mr. Livingstone's hiring. But, according to a statement issued by Mr. Nussbaum today, that conversation never took place.

This Administration and the American people have enormous confidence in the FBI, for good reason. And, the role that the agency plays in conducting background investigations and helping to ensure the suitability of appointees for their posts cannot be overstated. The President, you and the American people have a large stake indeed in the fairness and accuracy of this process.

That is why we are troubled, as we know you must be, by the implication that an FBI background investigation might include a false report. This matter is especially worrisome coming as it does on the heels of published reports of the conviction of one of the agents who did background checks at the White House on charges of falsifying at least 50 interviews that he claimed to have conducted.

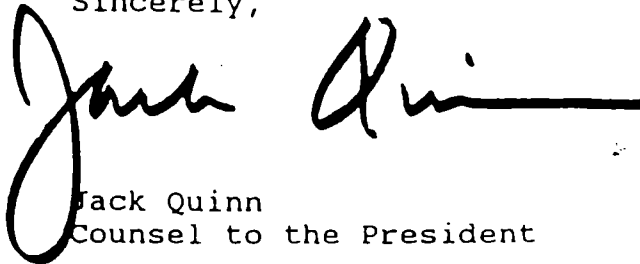
It is equally troubling that a Member of Congress can publicly reveal confidential FBI information, whether for partisan purposes or otherwise. It should not escape notice that this is done at a time when Members of Congress have expressed worry that employees of the executive branch might have sought out confidential FBI information about certain individuals and

planned to somehow use it publicly. While that charge has never been established against anyone in the executive branch, we now witness the same objectionable behavior by the very people who professed to be the guardians of privacy.

It is important that we take steps to ensure continuing confidence in the confidentiality and the integrity of the FBI clearance process. I look forward to your suggestions as to how we can work with you to that end.

'It's a Done Deal,' Counsel Allegedly Said

A former FBI agent assigned to the White House says he was told that Craig Livingstone was named head of personnel security despite a questionable background because Hillary wants him.

Writing in a new book, "Unlimited Access—An FBI Agent Inside the Clinton White House," the agent, Gary Aldrich, said then-associate White House counsel William H. Kennedy III told him in early 1993 that first lady Hillary Rodham Clinton wanted Livingstone in the job.

Kennedy, Aldrich wrote, asked him what the FBI thought of Livingstone as a replacement for a longtime veteran and "in particular what the FBI would think if there were character issues in his background."

"I responded gingerly, saying it was a post that should be filled with someone squeaky clean, before Kennedy cut me off: 'I guess I see your

point, but it doesn't matter. It's a done deal. Hillary wants him.'"

The embattled Livingstone announced his resignation Wednesday at a House hearing after a drumfire of criticism over his office's improper collection of sensitive FBI background reports on hundreds of Republicans from past administrations. One of the biggest mysteries left at the hearing was the question of who had hired Livingstone, a longtime political advance man with no background in security issues.

Aldrich was assigned to the White House to conduct background investigations for five years until he retired in June 1995. Angry to lose and laced with undocumented allegations, his book was published by a conservative house, Regnery Publishing Co. It was immediately denounced by the White House.

"On its face, this is trash for right-wing cash," said White House spokesman Mark Fabiani. Regnery, he said, has published books by former Los

Angeles police officer Steacy C. Roon and the National Rifle Association's executive vice president, Wayne LaPierre Jr. Published said publication of the Aldrich book "is a political act with zero credibility."

Earlier this month, Aldrich wrote a short article for the Wall Street Journal's editorial page. It alleged that permanent White House employees suspected of disloyalty were in for "special" attention, Hillary Clinton style—such as new background investigations before they were due. As FBI agent he worked with M. Dennis Sculmbrone, who alleged that White House political operatives prompted him for information contained in confidential FBI background files in an effort to root out career employees and replace them with Clinton supporters.

Those charges have led to an internal FBI investigation. The probe is focused on Aldrich's contentions that he told his superior, James Bourke, that the security system at the White House had been relaxed as those loyal to the Clintons could evade background checks. If Bourke was aware of such matters, the FBI inspectors will try to determine what, if anything, he did about them, sources

said. The inquiry is also directed at Sculmbrone's allegation that his FBI supervisors retaliated against him for testifying as a defense witness in the trial of fired White House travel chief Billy R. Dale. Dale was acquitted of embezzlement charges.

Sculmbrone has said he now reports to the FBI offices in Tysons Corner, where he has "no work, no assignments." In an August 1995 memo, David Bowie, another FBI agent who worked on the Dale case, told FBI higher-ups that Sculmbrone has "very bitter political feelings against the White House" and accused him of "irrational" behavior.

In his book, Aldrich said the new Clinton White House used temporary passes for many months to get around the need to provide the Secret Service with FBI background reports for permanent passes.

The White House counsel's office tightened security procedures in early 1994 after a review concluded that more than 100 employees were allowed to work for months without routine background investigations. White House officials acknowledged then that some White House staffers were found to have troublesome personal problems when the long-delayed investigations were finally completed.

Aldrich recounted meetings with Kennedy and with late White House deputy counsel Vincent Foster on the security problems, and said he told Foster the FBI had found character questions among staff members "in the highest levels" of the White House.

At one point, Aldrich wrote, he and Livingstone discussed the serious security problems, including staff members who should have been fired because of their backgrounds and the lack of cooperation from other White House staff members in even submitting to FBI interviews. Livingstone, wrote Aldrich, said Kennedy understood the problems but refused to deal with them.

The two men decided to go to higher-ups about the security problem, according to Aldrich. He wrote that he assumed they would discuss it with then-White House counsel Bernard Nussbaum. "Craig looked at me like I didn't have a brain. Nussbaum? It's not Nussbaum we gotta talk to. We'll be talking to Hillary."

Livingstone never mentioned the meeting with Hillary Clinton again, and it never came off, Aldrich wrote.

In his controversial new book, "Unlimited Access: an FBI Agent Inside the Clinton White House," Aldrich described his post as an elite assignment that afforded him the unique opportunity to look out the window and see "a king or a queen visiting the president."

But the FBI post at the White House has also been the subject of considerable controversy, particularly during the Clinton administration. One of the agents who helped with White House background checks in 1994 and 1995, Halbert Gary Harlow, was charged and eventually convicted last year of falsifying at least 50 interviews that he claimed to have conducted.

Aldrich was assigned to full-time duty at the White House with agent Dennis Sculimbrene, who almost lost his life in a 1995 accident, and has been quoted by another FBI agent as saying "he could get away with anything" because he was disabled. Sculimbrene is involved in a legal dispute with the FBI over his work assignments. He alleges he is being discriminated against because of his disability.

The FBI response to the allegations raised in Aldrich's book was a terse, two-paragraph statement saying that Aldrich had published his account without completing a required bureau review process.

As a condition of FBI employment, all employees and former employees are required to submit for review any publications that "could have been based on knowledge gained as a result of their employment," the FBI release said. "The purpose of this review is to ensure the integrity of the investigative or other official information employees learn as part of their official duties."

Jay Stephens, Aldrich's lawyer and former Republican U.S. attorney for Washington, said yesterday that over the last six months he and his client had worked closely with the FBI to address any concerns the agency may have about the manuscript.

"We substantially met all their concerns except for a couple of very limited passages that have become moot as a result of the hearings into problems in security clearances at the White House," Stephens said.

However, a senior bureau official disputed Stephens's account, saying that substantial issues remained unresolved before the book's publication.

Some senior bureau officials yesterday appeared caught in the position of trying to respond to a book with some credible allegations and other claims they considered undocumented rumor.

"Are we outraged by this behavior?" asked one senior bureau official. "Of course we are." But the official said that the bureau hasn't decided what to do about the book and noted that Aldrich does have First Amendment rights.

Should it decide to take action against Aldrich for publishing before the review process was completed, the bureau's only option is to pursue civil litigation to control profits of the book, said one source.

Upon first receiving the book, the FBI forwarded it to its Office Professional Responsibility as a part of routine procedure. Thus far the bureau has not been able to secure documents to substantiate Aldrich's claims about security procedures at the White House, sources said.

Aldrich first surfaced publicly two weeks ago, just after the controversy erupted over the White House's improper receipt of hundreds of FBI files, when he published an op-ed piece assailing the Clinton administration in the Wall Street Journal. In it, he accused the White House of thwarting security and background checks. He made no mention of the upcoming book.

The book describes the early Clinton White House as being in complete disarray, rife with staff members who had once been drug abusers, suffering from lax security clearance procedures and targeting employees that it wanted fired to make room for individuals who were viewed as loyal to the Clintons. He also claimed that the FBI ignored repeated complaints that the Clinton administration was allowing staff members to go long periods of time without permanent White House passes.

FBI sources said they had not yet been able to find any record of the complaints Aldrich said he had lodged.

Former Top FBI Agent at White House Raises Questions About Security Office

WASHINGTON — An FBI agent who was, until two months ago, the top FBI agent working in the White House, has raised new questions about the White House's personnel security office and its director, Craig Livingstone.

FBI agent Dennis Sculmbrene, who was recently transferred from the White House to FBI's Washington field office, has told investigators for the Senate Judiciary Committee that he raised complaints with his superiors about the chaotic management of the personnel security office two years ago and that he also had suggested that the office be run in a non-political manner. But Mr. Livingstone's hold on the job was secure because, the FBI agent said he was told, Mr. Livingstone's mother knew First Lady Hillary Rodham Clinton.

A White House spokeswoman and a lawyer for Mr. Livingstone both deny that Mrs. Clinton knows Mr. Livingstone's mother. Mr. Sculmbrene doesn't know why he was transferred from his post at the White House. He is currently embroiled in a legal dispute with the Federal Bureau of Investigation over work assignments.

During an unsworn interview Wednesday with the staff of the Senate Judiciary Committee, Mr. Sculmbrene alleged that Mr. Livingstone had some problems in his background and had said some untrue things to the FBI when he underwent an investigation for security clearance. He didn't tell investigators what the alleged problems in Mr. Livingstone's background or untrue statements were. Despite having no background in law enforcement, Mr. Livingstone was given the job and approved for security clearance.

Mr. Livingstone and an assistant improperly obtained FBI files on more than 400 people, including many Republicans. Congressional investigators and Independent Counsel Kenneth Starr are trying to determine whether the two men made an innocent mistake or were seeking to dig up dirt on political opponents. In private interviews with congressional investigators, Messrs. Livingstone and the assistant, Anthony Marceca, have said that the files were requested accidentally and weren't misused.

Mr. Livingstone, who is on leave from the White House post, referred questions to his attorneys. Mr. Livingstone's lawyer, David Cohen, declined to discuss the background investigation of Mr. Livingstone. "Background investigations are private matters," he said.

Slow Clearance Process

Mr. Sculmbrene, who worked at the White House for a decade and has conducted numerous background probes of presidential appointees, described his experience with the Clinton administration in a two-hour interview with Senate investigators. The security office problems started early in the Clinton White House, Mr. Sculmbrene said. The clearance process was moving very slowly, and many people were walking around the complex without proper passes, he said. Mr. Sculmbrene and another FBI agent at the White House, Gary Aldrich, repeatedly complained to their superiors about problems, and at one point Mr. Sculmbrene said he suggested turning over the security office to a professional rather than a political appointee.

In 1993, he thought he had a good candidate, Jackie Olmstead, who worked in the security office during the Carter administration. However, when he brought the idea to then-deputy White House counsel William Kennedy—who has since resigned—he says Mr. Kennedy told him that he was stuck with Mr. Livingstone. Mr. Sculmbrene told investigators that Mr. Kennedy knew there were problems in Mr. Livingstone's own background investigation, and another person familiar with the matter confirms this. Mr. Kennedy and his lawyer didn't respond to requests for comment.

According to Mr. Sculmbrene, both Mr. Kennedy and Mr. Livingstone told him that Mr. Livingstone's mother knew Mrs. Clinton, which seemed to explain his standing. However, Mr. Sculmbrene said he has no independent knowledge of whether the two women actually knew one another and suggested that Mr. Livingstone may have made it up in an attempt to inflate his status or protect his job. Another person who worked with Mr. Livingstone confirms that Mr. Livingstone boasted of ties between his mother and Mrs. Clinton.

'An Absolute Fabrication'

Mr. Cohen, Mr. Livingstone's lawyer, called this account "an absolute fabrication." White House officials said that Mr. Kennedy has denied telling Mr. Sculmbrene of any connection between Mrs. Clinton and Mr. Livingstone's mother. Jane Sherburne, White House special counsel, said Mrs. Clinton denies knowing Mrs. Livingstone.

Although Mr. Sculmbrene says his performance has been consistently rated as exceptional by the FBI, Senate investigators questioned him about events that could color his version of events. The FBI agent sustained a severe head injury two years ago that left him partly disabled, although he has returned to work. He is pursuing a discrimination complaint against the FBI, claiming he has been ordered to do work that contradicts his physician's recommendations. He said he is also under investigation for allegedly giving his son his government parking pass.

Mr. Sculmbrene also said he worries that he may be suffering retribution from superiors because he testified on behalf of former travel office director Billy Dale at Mr. Dale's embezzlement trial last year. Mr. Dale was acquitted. The firing of Mr. Dale and the rest of the travel office in 1993 led to a congressional inquiry and eventually to the disclosure that the White House had improperly obtained Mr. Dale's FBI file, along with more than 400 others.

Questions also were raised yesterday about whether Messrs. Livingstone and Marceca also collected confidential Internal Revenue Service data. According to a letter sent yesterday by Sen. Charles Grassley, an Iowa Republican, to FBI Director Louis Freeh, a box of documents removed from Mr. Livingstone's office by the FBI contained a folder full of papers bearing the IRS logo. Sen. Grassley asked the FBI director to describe what sort of documents are in the folder.

8 Mr. Sculimbrene. 703.

9 Mr. Larkin. Area code is what I meant to say.

10 Mr. Hubbard. Now, you said Craig Livingstone had this
11 job because who wanted him to have the job? --

12 Mr. Sculimbrene. Mrs. Clinton is apparently a friend
13 of Craig's mother.

14 Mr. Yoo. Mrs. Clinton is a friend of Craig's mother?

Dear Mr. Chairman:

I am writing about the Special Order you held on the House floor last night, in which you released information from Craig Livingstone's FBI file.

During your Special Order you said that former FBI agent Dennis Sculimbrene reported that Bernard Nussbaum and William H. Kennedy, III told him that the First Lady Hillary Rodham Clinton recommended Craig Livingstone for his job because she knew his mother. Prior to last night, at a committee hearing on June 26, 1996, Republican members repeatedly asked questions of the witnesses about a relationship between Hillary Rodham Clinton and Mr. Livingstone and his family -- although it was unclear at that time what the factual basis for those questions were.

As you know, Mrs. Clinton, Mr. Nussbaum, Mr. Kennedy, Mr. Livingstone, and Mr. Livingstone's mother, Gloria Livingstone, have all provided statements that Mr. Sculimbrene's account is untrue.

In a conversation between our staffs last night, your staff conceded that you have no tangible evidence that Mrs. Clinton and Mrs. Livingstone have ever met. In addition, and most surprisingly, your staff conceded that despite last night's charges you have made no attempts during the course of your long investigation to obtain any direct evidence from Gloria Livingstone about any relationship she might have with Mrs. Clinton. I understand, for example, that you and your staff have not even interviewed Mrs. Livingstone, that you have not asked your staff to obtain any relevant information to support the claim of a relationship between her and Mrs. Clinton, and that you have made no effort to discover how and under what circumstances Mrs. Clinton and Mrs. Livingstone might have first met and what subsequent contacts they might have had.

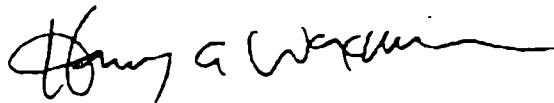
In addition, I object strongly to the refusal of my request yesterday to review the deposition Mr. Sculimbrene gave your staff last week. Early yesterday afternoon, your staff told my staff that the deposition was not available since it had not been concluded and was therefore not yet printed. Later in the day, however, indeed minutes before you began your Special Order, your staff called the Minority staff of the Government Reform and Oversight Committee from the House floor to indicate that he had been in error earlier and that a printed deposition was available.

I now understand that even though a printed copy is available to the Majority it is not being shared with Congressional Democrats or the public.

I am very troubled by this procedure. The allegations you raised last night, which have been denied by everyone with firsthand knowledge, depend on the veracity and credibility of Mr. Sculimbrene. Until we have an opportunity to review his deposition, we cannot get to the core of this matter. In addition, I request that Mr. Sculimbrene be called to testify before the committee before any other hearings are held on this matter.

I request a copy of Mr. Sculimbrene's deposition and that it also be made immediately available to the public given the seriousness of your allegations. Finally, I request that you verify by 5:00 P.M. today that you have no direct evidence of a relationship between Mrs. Clinton and Mrs. Livingstone and that you have made no attempts to acquire such information.

Even though Mr. Livingstone enjoyed an unusually long tenure in the White House counsel's office, surviving four White House counsels; and even though he enjoyed a 40-percent salary increase by touting his record as a team player while keeping bankers' hours; a month later, we still had no answers to the simple question of who brought Craig Livingstone into the Clinton inner circle as security chief?

Does Craig Livingstone really not know who hired him, or is he just not telling us? Who in the White House recommended that the counsel's office hire Craig Livingstone?

Seeking answers elsewhere for Craig Livingstone's "immaculate hiring," as it has been described, I directed my investigative staff to conduct depositions of the FBI agents assigned to the White House for background investigations. FBI Director Louis Freeh personally suggested that I review Mr.

Livingstone's FBI background investigation file, rather than question his agents directly on this subject.

Last Thursday, July 18th, I went to FBI headquarters, where I reviewed Mr. Livingstone's FBI file. During the course of an FBI background investigation, it is customary to interview an individual's supervisors. And among those interviewed for Craig Livingstone's background check was then-White House Counsel Bernard Nussbaum.

The interviews took place in early March; in the interview conducted -- of 1993 -- in the interview conducted by FBI Agent Dennis Sculimbrene, his report of this interview stated that: "Mr. Nussbaum advised" -- and I'm quoting -- "that he has known the appointee (of ?) REP. CLINGER: No, I will not yield. This 1993 statement calls into question Mr. Nussbaum's June 26th, 1996 statements made under oath before the Government Reform and Oversight Committee. When Congressman Steve Horn asked former Associate White House Counsel William Kennedy whether Mrs. Kennedy (sic) wanted Mr. Livingstone there at the White House, Mr. Kennedy testified that, and I'm quoting, "I can state that I have never discussed Mr. Livingstone with Mrs. Clinton in any way, shape, or form." Mr. Nussbaum immediately responded, "Nor did I." When I directly asked Mr. Nussbaum "Do you know who hired Craig Livingstone?" Mr. Nussbaum responded "I do not know who brought Mr. Livingstone into the White House."

if they were really concerned about the information discovered in Livingstone's background file?

The FBI agents conducting the interview told Mr. Sculimbrene that the White House was unhappy and concerned about this particular interview and about what had been said to -- about Bernie Nussbaum. Why after the attorney general herself said that it would be a conflict of interest for the FBI or the Justice Department to investigate anything related to this matter would FBI agents go to the home of such a critical witness?

Who directed these agents? Who approved and knew about these actions, and when did they know? Was the independent counsel informed? House Travel Office and FBI files matters, I am simultaneously forwarding this matter to Judge Starr's attention.

While our investigation is continuing, our focus is not, not on possible criminal activities, and I want to emphasize that I am not here to prejudge the veracity of any of the statements that I've referred to, but I am concerned about what appear to be very serious discrepancies. I believe, therefore, this issue must be addressed by a federal law enforcement office tasked to review these types of issues.

And I yield back the balance of my time.

I am mystified and outraged that someone would attribute to me something I never said.

Ex-FBI Agent: First Lady Wanted Livingstone on Staff 'It's a Done Deal,' Counsel Allegedly Said

A former FBI agent assigned to the White House says he was told that Craig Livingstone was named head of personnel security despite a questionable background because "Hillary wants him."

Writing in a new book, "Unlimited Access—An FBI Agent Inside the Clinton White House," the agent, Gary Aldrich, said then-associate White House counsel William H. Kennedy III told him in early 1993 that first lady Hillary Rodham Clinton wanted Livingstone in the job.

Kennedy, Aldrich wrote, asked him what the FBI thought of Livingstone as a replacement for a longtime veteran and "in particular what the FBI would think if there were character issues in his background."

"I responded gingerly, saying it was a post that should be filled with someone squeaky clean, before Kennedy cut me off: 'I guess I see your

point, but it doesn't matter. It's a done deal. Hillary wants him.'"

The embattled Livingstone announced his resignation Wednesday at a House hearing after a drumfire of criticism over his office's improper collection of sensitive FBI background reports on hundreds of Republicans from past administrations. One of the biggest mysteries left at the hearing was the question of who had hired Livingstone, a longtime political advance man with no background in security issues.

Aldrich was assigned to the White House to conduct background investigations for five years until he retired in June 1995. Angry in tone and laced with undocumented allegations, his book was published by a conservative house, Regnery Publishing Co. It was immediately denounced by the White House.

"On its face, this is trash for right-wing cash," said White House spokesman Mark Fabiani. Regnery, he said, has published books by former Los

 Angeles police officer Stacy C. Koon and the National Rifle Association's executive vice president, Wayne LaPierre Jr. Fabiani said publication of the Aldrich book "is a political act with zero credibility."

Earlier this month, Aldrich wrote a short article for the Wall Street Journal's editorial page. It alleged that permanent White House employees suspected of disloyalty were in for "special" attention, Hillary Clinton style—such as new background investigations before they were due. An FBI agent he worked with, M. Dennis Sculmbrene, has alleged that White House political operatives pumped him for information contained in confidential FBI background files in an effort to root out career employees and replace them with Clinton supporters.

Those charges have led to an internal FBI investigation. The probe is focused on Aldrich's contentions that he told his supervisor, James Bourke, that the security system at the White House had been relaxed so those loyal to the Clintons could evade background checks. If Bourke was aware of such matters, the FBI inspectors will try to determine what, if anything, he did about them, sources

said. The inquiry is also directed at Sculmbrene's allegation that his FBI supervisors retaliated against him for testifying as a defense witness in the trial of fired White House travel chief Billy R. Dale. Dale was acquitted of embezzlement charges.

Sculmbrene has said he now reports to the FBI offices in Tysons Corner, where he has "no work, no assignments." In an August 1995 memo, David Bowie, another FBI agent who worked on the Dale case, told FBI higher-ups that Sculmbrene has "very bitter political feelings against the White House" and accused him of "irrational" behavior.

In his book, Aldrich said the new Clinton White House used temporary passes for many months to get around the need to provide the Secret Service with FBI background reports for permanent passes.

The White House counsel's office tightened security procedures in early 1994 after a review concluded that more than 100 employees were allowed to work for months without routine background investigations. White House officials acknowledged then that some White House staffers were found to have troublesome personal problems when the long-delayed investigations were finally completed.

Aldrich recounted meetings with Kennedy and with late White House deputy counsel Vincent Foster on the security problems, and said he told Foster the FBI had found character questions among staff members "at the highest levels" of the White House.

At one point, Aldrich wrote, he and Livingstone discussed the serious security problems, including staff members who should have been fired because of their backgrounds and the lack of cooperation from other White House staff members in even submitting to FBI interviews. Livingstone, wrote Aldrich, said Kennedy understood the problems but refused to deal with them.

The two men decided to go to higher-ups about the security problem, according to Aldrich. He wrote that he assumed they would discuss it with then-White House counsel Bernard Nussbaum. "Craig looked at me like I didn't have a brain. 'Nussbaum? It's not Nussbaum we gotta talk to. We'll be talking to Hillary.'"

Livingstone never mentioned the meeting with Hillary Clinton again, and it never came off, Aldrich wrote.

To a number of his peers, was a competent FBI agent with strong conservative convictions who felt a kinship with the Bush administration and was openly disgusted when Bill Clinton captured the Oval Office.

"He was very cozy with most of the Bush staff," said an FBI agent who knows Aldrich and spoke on the condition of anonymity. There is "no doubt he has a phenomenal bias" against the Clintons.

"He was almost personally offended that the Clintons had won, and made no secret of that," the agent said. After Clinton was elected president, the agent said, Aldrich remarked, "I've never seen so many ponytailed, 50-year-old men in my life."

Aldrich, a 26-year veteran of the FBI, retired last year because, he has suggested, his experience in the Clinton White House soured him on the bureau. He had spent the last five years of his career as one of two FBI agents assigned to the White House, where he was responsible for conducting background investigations on White House personnel.

In his controversial new book, "Unlimited Access: an FBI Agent Inside the Clinton White House," Aldrich described his post as an elite assignment that afforded him the unique opportunity to look out the window and see "a king or a queen visiting the president."

But the FBI post at the White House has also been the subject of considerable controversy, particularly during the Clinton administration. One of the agents who helped with White House background checks in 1994 and 1995, Halbert Gary Harlow, was charged and eventually convicted last year of falsifying at least 50 interviews that he claimed to have conducted.

Aldrich was assigned to full-time duty at the White House with agent Dennis Sculimbrene, who almost lost his life in a 1995 accident, and has been quoted by another FBI agent as saying "he could get away with anything" because he was disabled. Sculimbrene is involved in a legal dispute with the FBI over his work assignments. He alleges he is being discriminated against because of his disability.

The FBI response to the allegations raised in Aldrich's book was a terse, two-paragraph statement saying that Aldrich had published his account without completing a required bureau review process.

As a condition of FBI employment, all employees and former employees are required to submit for review any publications that "could have been based on knowledge gained as a result of their employment," the FBI release said. "The purpose of this review is to ensure the integrity of the investigative or other official information employees learn as part of their official duties."

Jay Stephens, Aldrich's lawyer and former Republican U.S. attorney for Washington, said yesterday that over the last six months he and his client had worked closely with the FBI to address any concerns the agency may have about the manuscript.

"We substantially met all their concerns except for a couple of very limited passages that have become moot as a result of the hearings into problems in security clearances at the White House," Stephens said.

However, a senior bureau official disputed Stephens's account, saying that substantial issues remained unresolved before the book's publication.

Some senior bureau officials yesterday appeared caught in the position of trying to respond to a book with some credible allegations and other claims they considered undocumented rumor.

"Are we outraged by this behavior?" asked one senior bureau official. "Of course we are." But the official said that the bureau hasn't decided what to do about the book and noted that Aldrich does have First Amendment rights.

Should it decide to take action against Aldrich for publishing before the review process was completed, the bureau's only option is to pursue civil litigation to control profits of the book, said one source.

Upon first receiving the book, the FBI forwarded it to its Office Professional Responsibility as a part of routine procedure. Thus far the bureau has not been able to secure documents to substantiate Aldrich's claims about security procedures at the White House, sources said.

Aldrich first surfaced publicly two weeks ago, just after the controversy erupted over the White House's improper receipt of hundreds of FBI files, when he published an op-ed piece assailing the Clinton administration in the Wall Street Journal. In it, he accused the White House of thwarting security and background checks. He made no mention of the upcoming book.

The book describes the early Clinton White House as being in complete disarray, rife with staff members who had once been drug abusers, suffering from lax security clearance procedures and targeting employees that it wanted fired to make room for individuals who were viewed as loyal to the Clintons. He also claimed that the FBI ignored repeated complaints that the Clinton administration was allowing staff members to go long periods of time without permanent White House passes.

FBI sources said they had not yet been able to find any record of the complaints Aldrich said he had lodged.

Former Top FBI Agent at White House Raises Questions About Security Office

WASHINGTON — An FBI agent who was, until two months ago, the top FBI agent working in the White House, has raised new questions about the White House's personnel security office and its director, Craig Livingstone.

FBI agent Dennis Sculmbrene, who was recently transferred from the White House to FBI's Washington field office, has told investigators for the Senate Judiciary Committee that he raised complaints with his superiors about the chaotic management of the personnel security office two years ago and that he also had suggested that the office be run in a non-political manner. But Mr. Livingstone's hold on the job was secure because, the FBI agent said he was told, Mr. Livingstone's mother knew First Lady Hillary Rodham Clinton.

A White House spokeswoman and a lawyer for Mr. Livingstone both deny that Mrs. Clinton knows Mr. Livingstone's mother. Mr. Sculmbrene doesn't know why he was transferred from his post at the White House. He is currently embroiled in a legal dispute with the Federal Bureau of Investigation over work assignments.

During an unsworn interview Wednesday with the staff of the Senate Judiciary Committee, Mr. Sculmbrene alleged that Mr. Livingstone had some problems in his background and had said some untrue things to the FBI when he underwent an investigation for security clearance. He didn't tell investigators what the alleged problems in Mr. Livingstone's background or untrue statements were. Despite having no background in law enforcement, Mr. Livingstone was given the job and approved for security clearance.

Mr. Livingstone and an assistant improperly obtained FBI files on more than 400 people, including many Republicans. Congressional investigators and Independent Counsel Kenneth Starr are trying to determine whether the two men made an innocent mistake or were seeking to dig up dirt on political opponents. In private interviews with congressional investigators, Messrs. Livingstone and the assistant, Anthony Marceca, have said that the files were requested accidentally and weren't misused.

Mr. Livingstone, who is on leave from the White House post, referred questions to his attorneys. Mr. Livingstone's lawyer, David Cohen, declined to discuss the background investigation of Mr. Livingstone. "Background investigations are private matters," he said.

Slow Clearance Process

Mr. Sculmbrene, who worked at the White House for a decade and has conducted numerous background probes of presidential appointees, described his experience with the Clinton administration in a two-hour interview with Senate investigators. The security office problems started early in the Clinton White House, Mr. Sculmbrene said. The clearance process was moving very slowly, and many people were walking around the complex without proper passes, he said. Mr. Sculmbrene and another FBI agent at the White House, Gary Aldrich, repeatedly complained to their superiors about problems, and at one point Mr. Sculmbrene said he suggested turning over the security office to a professional rather than a political appointee.

In 1993, he thought he had a good candidate, Jackie Dinwiddle, who worked in the security office during the Carter administration. However, when he brought the idea to then-deputy White House counsel William Kennedy—who has since resigned—he says Mr. Kennedy told him that he was stuck with Mr. Livingstone. Mr. Sculmbrene told investigators that Mr. Kennedy knew there were problems in Mr. Livingstone's own background investigation, and another person familiar with the matter confirms this. Mr. Kennedy and his lawyer didn't respond to requests for comment.

According to Mr. Sculmbrene, both Mr. Kennedy and Mr. Livingstone told him that Mr. Livingstone's mother knew Mrs. Clinton, which seemed to explain his standing. However, Mr. Sculmbrene said he has no independent knowledge of whether the two women actually knew one another and suggested that Mr. Livingstone may have made it up in an attempt to inflate his status or protect his job. Another person who worked with Mr. Livingstone confirms that Mr. Livingstone boasted of ties between his mother and Mrs. Clinton.

'An Absolute Fabrication'

Mr. Cohen, Mr. Livingstone's lawyer, called this account "an absolute fabrication." White House officials said that Mr. Kennedy has denied telling Mr. Sculmbrene of any connection between Mrs. Clinton and Mr. Livingstone's mother. Jane Sherburne, White House special counsel, said Mrs. Clinton denies knowing Mrs. Livingstone.

Although Mr. Sculmbrene says his performance has been consistently rated as exceptional by the FBI, Senate investigators questioned him about events that could color his version of events. The FBI agent sustained a severe head injury two years ago that left him partly disabled, although he has returned to work. He is pursuing a discrimination complaint against the FBI, claiming he has been ordered to do work that contradicts his physician's recommendations. He said he is also under investigation for allegedly giving his son his government parking pass.

Mr. Sculmbrene also said he worries that he may be suffering retribution from superiors because he testified on behalf of former travel office director Billy Dale at Mr. Dale's embezzlement trial last year. Mr. Dale was acquitted. The firing of Mr. Dale and the rest of the travel office in 1993 led to a congressional inquiry and eventually to the disclosure that the White House had improperly obtained Mr. Dale's FBI file, along with more than 400 others.

Questions also were raised yesterday about whether Messrs. Livingstone and Marceca also collected confidential Internal Revenue Service data. According to a letter sent yesterday by Sen. Charles Grassley, an Iowa Republican, to FBI Director Louis Freeh, a box of documents removed from Mr. Livingstone's office by the FBI contained a folder full of papers bearing the IRS logo. Sen. Grassley asked the FBI director to describe what sort of documents are in the folder.

Former Top FBI Agent at White House Raises Questions About Security Office

WASHINGTON - An FBI agent who was, until two months ago, the top FBI agent working in the White House, has raised new questions about the White House's personnel security office and its director, Craig Livingstone.

FBI agent Dennis Sculmbrene, who was recently transferred from the White House to FBI's Washington field office, has told investigators for the Senate Judiciary Committee that he raised complaints with his superiors about the chaotic management of the personnel security office two years ago and that he also had suggested that the office be run in a non-political manner. But Mr. Livingstone's hold on the job was secure because, the FBI agent said he was told, Mr. Livingstone's mother knew First Lady Hillary Rodham Clinton.

A White House spokeswoman and a lawyer for Mr. Livingstone both deny that Mrs. Clinton knows Mr. Livingstone's mother. Mr. Sculmbrene doesn't know why he was transferred from his post at the White House. He is currently embroiled in a legal dispute with the Federal Bureau of Investigation over work assignments.

During an unsworn interview Wednesday with the staff of the Senate Judiciary Committee, Mr. Sculmbrene alleged that Mr. Livingstone had some problems in his background and had said some untrue things to the FBI when he underwent an investigation for security clearance. He didn't tell investigators what the alleged problems in Mr. Livingstone's background or untrue statements were. Despite having no background in law enforcement, Mr. Livingstone was given the job and approved for security clearance.

Mr. Livingstone and an assistant improperly obtained FBI files on more than 400 people, including many Republicans. Congressional investigators and Independent Counsel Kenneth Starr are trying to determine whether the two men made an innocent mistake or were seeking to dig up dirt on political opponents. In private interviews with congressional investigators, Messrs. Livingstone and the assistant, Anthony Marceca, have said that the files were requested accidentally and weren't misused.

Mr. Livingstone, who is on leave from the White House post, referred questions to his attorneys. Mr. Livingstone's lawyer, David Cohen, declined to discuss the background investigation of Mr. Livingstone. "Background investigations are private matters," he said.

Slow Clearance Process

Mr. Sculmbrene, who worked at the White House for a decade and has conducted numerous background probes of presidential appointees, described his experience with the Clinton administration in a two-hour interview with Senate investigators. The security office problems started early in the Clinton White House, Mr. Sculmbrene said. The clearance process was moving very slowly, and many people were walking around the complex without proper passes, he said. Mr. Sculmbrene and another FBI agent at the White House, Gary Aldrich, repeatedly complained to their superiors about problems, and at one point Mr. Sculmbrene said he suggested turning over the security office to a professional rather than a political appointee.

In 1993, he thought he had a good candidate, Jackie Dinwiddie, who worked in the security office during the Carter administration. However, when he brought the idea to then-deputy White House counsel William Kennedy—who has since resigned—he says Mr. Kennedy told him that he was stuck with Mr. Livingstone. Mr. Sculmbrene told investigators that Mr. Kennedy knew there were problems in Mr. Livingstone's own background investigation, and another person familiar with the matter confirms this. Mr. Kennedy and his lawyer didn't respond to requests for comment.

According to Mr. Sculmbrene, both Mr. Kennedy and Mr. Livingstone told him that Mr. Livingstone's mother knew Mrs. Clinton, which seemed to explain his standing. However, Mr. Sculmbrene said he has no independent knowledge of whether the two women actually knew one another and suggested that Mr. Livingstone may have made it up in an attempt to inflate his status or protect his job. Another person who worked with Mr. Livingstone confirms that Mr. Livingstone boasted of ties between his mother and Mrs. Clinton.

'An Absolute Fabrication'

Mr. Cohen, Mr. Livingstone's lawyer, called this account "an absolute fabrication." White House officials said that Mr. Kennedy has denied telling Mr. Sculmbrene of any connection between Mrs. Clinton and Mr. Livingstone's mother. Jane Sherburne, White House special counsel, said Mrs. Clinton denies knowing Mrs. Livingstone.

Although Mr. Sculmbrene says his performance has been consistently rated as exceptional by the FBI, Senate investigators questioned him about events that could color his version of events. The FBI agent sustained a severe head injury two years ago that left him partly disabled, although he has returned to work. He is pursuing a discrimination complaint against the FBI, claiming he has been ordered to do work that contradicts his physician's recommendations. He said he is also under investigation for allegedly giving his son his government parking pass.

Mr. Sculmbrene also said he worries that he may be suffering retribution from superiors because he testified on behalf of former travel office director Billy Dale at Mr. Dale's embezzlement trial last year. Mr. Dale was acquitted. The firing of Mr. Dale and the rest of the travel office in 1993 led to a congressional inquiry and eventually to the disclosure that the White House had improperly obtained Mr. Dale's FBI file, along with more than 400 others.

Questions also were raised yesterday about whether Messrs. Livingstone and Marceca also collected confidential Internal Revenue Service data. According to a letter sent yesterday by Sen. Charles Grassley, an Iowa Republican, to FBI Director Louis Freeh, a box of documents removed from Mr. Livingstone's office by the FBI contained a folder full of papers bearing the IRS logo. Sen. Grassley asked the FBI director to describe what sort of documents are in the folder.

RE: More Publicity about Bernie Nussbaum

Last Thursday's New York Times reported that White House aides were "infuriated" when the Department of Justice requested Independent Counsel Kenneth Starr to investigate whether Bernie Nussbaum made false statements with respect to the hiring of Craig Livingstone. A number of you have asked for a more detailed explanation. To understand the White House reaction, it is necessary to understand the circumstances leading up to the Justice Department referral to the Independent Counsel and the nature of that referral.

A. Congressman Clinger's First Attack on Bernie and the Response by Democrats

The story begins on June 5, 1996 when Republican Congressman William Clinger of Pennsylvania, who chairs the House Government Reform and Oversight Committee (the "Committee"), held a press conference. He accused Bernie of having illegally obtained FBI background files of a former White House employee while he was White House Counsel. The sole basis for this accusation was a printed government information-request form that had Bernie's name typed on it.

As Bernie and others explained to the Committee at a June 26 hearing, the typewritten form that served as the basis for Clinger's accusation had been in use in the White House for thirty years. Although the printed name of the White House Counsel appears on the form, he is not the person actually requesting the information and that is understood by all involved in the process of requesting files.

Bernie added that Representative Clinger would have been aware of these facts if he or a member of his staff had called Bernie before going on national television to accuse him of wrongful conduct. In light of these circumstances -- and the fact that Bernie knew absolutely nothing about the requests for these files -- Bernie believed he was entitled to an apology from Representative Clinger. Despite repeated oral and

written requests from the Democratic members of his Committee, the Congressman refused to apologize or acknowledge any error.

B. Congressman Clinger's Next Attack on Bernie and on FBI General Counsel Howard Shapiro and the Democratic Response

Four weeks later, on July 25, 1996, Representative Clinger took to the floor of the House of Representatives. Under the protection of the Speech or Debate Clause (which insulates members of Congress from defamation claims), he accused Bernie of having committed yet another illegal act, again without ever first calling Bernie.

Referring to a recently discovered "insert" to an FBI report supposedly memorializing Agent Dennis Sculimbrene's interview of Bernie in connection with the background investigation of Craig Livingstone, Representative Clinger accused Bernie of having perjured himself during his testimony before the Committee. The insert -- an undated page purporting to summarize interviews in 1993 with Bernie and two other people -- stated that Bernie had told Sculimbrene that Livingstone had been "recommended" by Hillary Clinton "who has known [Livingstone's] mother for a long time." Bernie had testified at the June 26 Committee hearing that he did not know "who brought Mr. Livingstone into the White House," and had never discussed Mr. Livingstone with Mrs. Clinton.

After Chairman Clinger made his July 25 comments, Bernie issued a statement making clear that he had never told Agent Sculimbrene, or anyone else, that Mrs. Clinton had recommended Livingstone for his White House position or that she knew Livingstone's mother. Mrs. Livingstone also responded immediately stating that she and Hillary Clinton do not know each other. (Statement of Gloria Livingstone, 7/25/96.) The First Lady likewise stated that she does "not know [Mr. Livingstone's] mother" and that she "did not have anything to do with his being hired." (First Lady's Discussion with Travelling Press in Helsinki, Finland, 7/10/96.)

House Democrats promptly denounced Clinger's accusations. They pointed out that Clinger's assertions were unverified and suggested that he had gone to the House floor to make these accusations to avoid subjecting himself to a defamation action. They also noted that Clinger's accusations omitted vitally important facts.

For example, Clinger made no mention of the fact that Agent Sculimbrene had already been interviewed by the Senate Judiciary Committee and had attributed the information about Livingstone's hiring to Livingstone himself and William Kennedy, not Bernie. (Interview of M. Dennis Sculimbrene, June 19, 1996 at 61, 64.) Clinger similarly omitted the fact

that, at his House deposition, Sculimbrene testified that Livingstone -- not Bernie -- "claimed that his mother knew Hillary Clinton," and that others had told him that they had also heard this from Livingstone. (Deposition of M. Dennis Sculimbrene, July 15, 1996 at 59-60.) The same information had also appeared in the Wall Street Journal on June 25 and had been attributed to Craig Livingstone and William Kennedy. In addition, FBI Agent Gary Aldrich, Sculimbrene's partner at the White House, wrote that he had learned from Kennedy that Mrs. Clinton had wanted Livingstone to be hired. (Unlimited Access at 36.)

Upon the July 15 discovery of the Sculimbrene insert in the FBI's files, FBI General Counsel Howard Shapiro simultaneously notified all affected parties, including the White House, the Justice Department and Majority and Minority members of the Committee about the existence of the insert. In his July 25 speech on the House floor, Clinger was sharply critical of Shapiro, accusing him of providing an inappropriate "heads up" about the insert to the White House.

As the Minority members of the Committee pointed out, however, what most disturbed Clinger was that the notification to the White House permitted the White House and Bernie to be in a position promptly to respond to Clinger's July 25 charges and submit their own statements contradicting his accusations. (See Investigation Into the White House and Department of Justice on Security of FBI Background Investigation Files, Nineteenth Report by the Committee on Government Reform and Oversight, Sept. 28, 1996 (the "Report") at 120.)

As a result of his efforts to be evenhanded in advising all relevant parties of the existence of the insert, FBI General Counsel Shapiro was himself deposed by Clinger's staff. He was required to defend himself at a subsequent Committee hearing against Republican charges of partisanship and demands for his resignation.

Interestingly, Shapiro's testimony further undermined the notion that the statement in Sculimbrene's insert actually came from Bernie. According to Shapiro, Sculimbrene told two FBI agents who interviewed him that he had no memory of having been told by Bernie that Hillary Clinton and Mrs. Livingstone were acquaintances and in fact had no recollection of interviewing Bernie in connection with the background investigation of Livingstone at all. (Deposition of Howard M. Shapiro, July 30, 1996 at 69, 169.) Moreover, Sculimbrene could not locate any notes of his alleged interview with Bernie.

On September 28, the Republican members of the Committee issued their Report on the status of their investigation of the FBI files. The Majority's Report repeated Clinger's July 25 allegations of perjury and stated that on July 30 the Committee had referred the matter of Bernie's statements to the

Independent Counsel. The Democratic members of the Committee published their separate views, taking Chairman Clinger and the Majority members to task for the way the investigation was conducted.

Among other things, the Minority criticized the Committee's treatment of Bernie. It noted that the only purpose for Clinger to have made his charges on the House floor was "to plant in the minds of the American people the unsubstantiated thought that the First Family and all of their lawyers were lying about this matter...." Report at 119. The Minority also stated that Clinger "very publicly -- and wrongly -- accused Mr. Nussbaum of possible criminal behavior without conducting even a minimal amount of investigation. Whether those accusations were incorrect or intentional, the record clearly demonstrates that they were false." Report at 125 (emphasis added).

The Minority also pointed out that Congressman Clinger provided neither the House members present nor the public all the pertinent information available. The Minority emphasized that the Majority Report failed to take into account Sculimbrene's statements to the House, Senate and FBI interviewers, in which he repeatedly attributed the information linking Mrs. Clinton to Mrs. Livingstone to Livingstone himself and to Kennedy, and never to Bernie. See Report at 120.*

The Minority further addressed the propriety of the FBI's having shared the substance of the insert with the White House. It noted that the Majority is "angry at Mr. Shapiro only because his efforts to act in a fair and nonpartisan manner thwarted its attempt to score points in the press." Report at 117.

C. The Justice Department's Self-Protective Reaction

While this background may give you a sense of why the White House is disturbed by the Attorney General's referral to

* The Minority also noted that there was no mention of the existence of an FBI memorandum raising substantial issues about Sculimbrene's credibility and mental stability. In this memo, another Special Agent stated that, based upon an FBI interview of Sculimbrene, he found Sculimbrene's behavior to be "abnormal," "indeed irrational" and "clearly outside the norm." Report at 123. Sculimbrene is also reported to have articulated "very bitter political feelings against the Clinton White House", and the memo's author suggests that Sculimbrene may be in need of therapy. Id.

the Independent Counsel, the legal papers prepared by the Justice Department provide further grounds for the White House's reaction.

On October 24, in response to a request from Clinger for a referral to the Independent Counsel, the Justice Department filed its Notification to the Court and Application pursuant to 28 U.S.C. § 593(c)(1) for the Expansion of the Jurisdiction of an Independent Counsel (the "Application") to investigate whether Bernie may have made false statements to the Committee during his June 26 testimony. The bare-bones Application refers to Bernie's testimony that he did not know who brought Livingstone into the White House and had never discussed him with Mrs. Clinton. It contrasts that testimony to the statements allegedly recorded in the Sculimbrene insert. The Application notes an apparent inconsistency and states that the investigation "necessarily will involve an inquiry into statements allegedly made by a former senior member of the White House staff to the FBI concerning the role of the First Lady in a controversial personnel decision."

Conspicuously absent from the Application is any of the exculpatory information discussed above and compiled by the Committee's Minority members. There is no mention of the fact that the insert is an undated, unsigned, uninitialed document and that the agent's investigatory notes cannot be found. There also is no mention of the fact that Sculimbrene himself has no memory of talking to Bernie about Livingstone and has suggested that Livingstone himself and Kennedy may have supplied the information. Also omitted is the fact that the information contained in Sculimbrene's report is demonstrably false: Mrs. Livingstone and Mrs. Clinton have stated unequivocally that they have never met or spoken.

The Application makes no effort fairly to lay out the known facts relevant to the referral. This failure is particularly egregious in light of the specific request contained in the Justice Department application that the Court authorize public disclosure of the Application in order to "serve the public interest." It is noteworthy that the Justice Department made no effort to contact Bernie and obtain his side of the story before making the referral.

This is particularly unfortunate, since the Justice Department would have learned that the requested "expansion" of the Independent Counsel's jurisdiction was a needless formality. In June 1996, the Court of Appeals had expanded Mr. Starr's jurisdiction to include investigation of whether there was any violation of law relating to requests made by the White House to the FBI between December 1993 and February 1994 for background investigation reports and materials. That expansion was broad enough to cover the hiring of Mr. Livingstone and testimony with respect to that issue. Indeed, on October 3, three weeks before the Application, Bernie met with Mr. Starr's

staff, discussed the Sculimbrene insert, and told them what he knew about Craig Livingstone and the circumstances of his hiring. (Notwithstanding certain misleading press reports, there is absolutely no indication in the Application or in anything else that Mr. Starr requested this unnecessary expansion of his jurisdiction.)

* * *

In light of the numerous facts showing that Sculimbrene's insert is inaccurate, this was a case where non-referral could easily have been justified. However, we expect that what may have angered the White House most of all in this matter was the Justice Department's request for public disclosure of its Application when the document itself is so one-sided.

The public referral of this matter has undoubtedly raised questions at the White House about whether senior officials at the Department were motivated primarily by a desire to avoid the kind of public criticism of themselves that the Clinger Committee Republicans have visited on people like Howard Shapiro who attempt to act in a fair and nonpartisan fashion.

Dear Director Freeh:

As you may know, Congressman Clinger today divulged, on the House floor, an interview report from a confidential FBI background investigation that has been declared to be false by the person who was interviewed. I am writing to you to ask how we can work together to ensure continued public confidence in the accuracy of FBI investigations.

According to Mr. Clinger's statement today, the background investigation file on Mr. Craig Livingstone includes a report by Agent Dennis Sculimbrene on a conversation he says he had with White House Counsel Bernard Nussbaum concerning Mr. Livingstone's hiring. But, according to a statement issued by Mr. Nussbaum today, that conversation never took place.

This Administration and the American people have enormous confidence in the FBI, for good reason. And, the role that the agency plays in conducting background investigations and helping to ensure the suitability of appointees for their posts cannot be overstated. The President, you and the American people have a large stake indeed in the fairness and accuracy of this process.

That is why we are troubled, as we know you must be, by the implication that an FBI background investigation might include a false report. This matter is especially worrisome coming as it does on the heels of published reports of the conviction of one of the agents who did background checks at the White House on charges of falsifying at least 50 interviews that he claimed to have conducted.

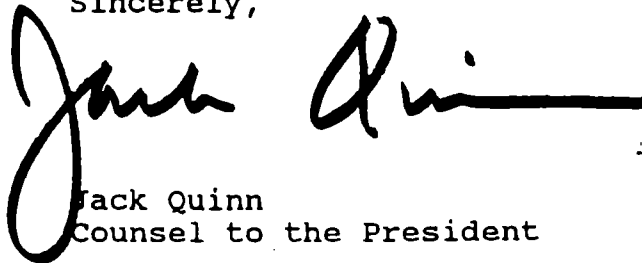
It is equally troubling that a Member of Congress can publicly reveal confidential FBI information, whether for partisan purposes or otherwise. It should not escape notice that this is done at a time when Members of Congress have expressed worry that employees of the executive branch might have sought out confidential FBI information about certain individuals and

planned to somehow use it publicly. While that charge has never been established against anyone in the executive branch, we now witness the same objectionable behavior by the very people who professed to be the guardians of privacy.

It is important that we take steps to ensure continuing confidence in the confidentiality and the integrity of the FBI clearance process. I look forward to your suggestions as to how we can work with you to that end.

Today Representative William Clinger, hiding behind the legal fig leaf of the Speech or Debate Clause, took the extraordinary step of divulging on the House floor highly confidential and completely false information from an FBI background investigation.

Congressman Clinger has failed utterly to prove that the White House ever improperly released any private information from FBI files. Thus, today's astonishing speech by Mr. Clinger represents the first and only disclosure of confidential FBI background information during this entire matter.

What is worse, Congressman Clinger divulged confidential information that is clearly false and that originates from a questionable source. Bernard Nussbaum has said that the alleged conversation between Mr. Nussbaum and FBI Agent Dennis Sculimbrene never took place. Mrs. Livingstone has said that she does not know the First Lady and has never even met or spoken with Mrs. Clinton. And the First Lady has said that she does not know Mrs. Livingstone.

In addition, Mr. Clinger surely knows that, according to a published report, an FBI agent informed his superiors that Agent Sculimbrene harbored "very bitter political feelings against the White House." This same FBI agent also charged Agent Sculimbrene with "irrational" behavior. (Washington Post, June 28, 1996.) Yet other published reports indicate that Agent Sculimbrene is involved in a continuing dispute with the FBI regarding his work assignments. And, in recent weeks another FBI agent who had been assigned to the White House and worked with Agent Sculimbrene published a book containing wild rumors and rank innuendo; that book was thoroughly and completely discredited.

Nonetheless, Representative Clinger took to the House floor and divulged false information from a confidential FBI report in a desperate attempt to grab attention for his faltering "investigation." Mr. Clinger's speech today will be seen by most Americans as a reckless, partisan act.

Dear Director Freeh:

As you may know, Congressman Clinger today divulged, on the House floor, an interview report from a confidential FBI background investigation that has been declared to be false by the person who was interviewed. I am writing to you to ask how we can work together to ensure continued public confidence in the accuracy of FBI investigations.

According to Mr. Clinger's statement today, the background investigation file on Mr. Craig Livingstone includes a report by Agent Dennis Sculimbrene on a conversation he says he had with White House Counsel Bernard Nussbaum concerning Mr. Livingstone's hiring. But, according to a statement issued by Mr. Nussbaum today, that conversation never took place.

This Administration and the American people have enormous confidence in the FBI, for good reason. And, the role that the agency plays in conducting background investigations and helping to ensure the suitability of appointees for their posts cannot be overstated. The President, you and the American people have a large stake indeed in the fairness and accuracy of this process.

That is why we are troubled, as we know you must be, by the implication that an FBI background investigation might include a false report. This matter is especially worrisome coming as it does on the heels of published reports of the conviction of one of the agents who did background checks at the White House on charges of falsifying at least 50 interviews that he claimed to have conducted.

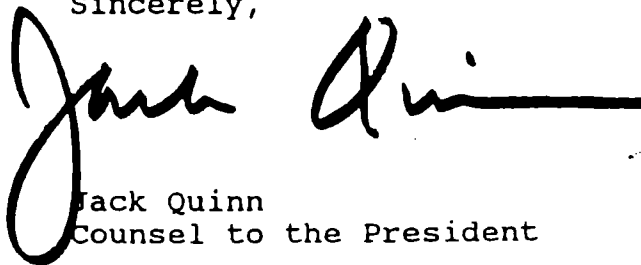
It is equally troubling that a Member of Congress can publicly reveal confidential FBI information, whether for partisan purposes or otherwise. It should not escape notice that this is done at a time when Members of Congress have expressed worry that employees of the executive branch might have sought out confidential FBI information about certain individuals and

planned to somehow use it publicly. While that charge has never been established against anyone in the executive branch, we now witness the same objectionable behavior by the very people who professed to be the guardians of privacy.

It is important that we take steps to ensure continuing confidence in the confidentiality and the integrity of the FBI clearance process. I look forward to your suggestions as to how we can work with you to that end.

'It's a Done Deal,' Counsel Allegedly Said

A former FBI agent assigned to the White House says he was told that Craig Livingstone was named head of personnel security despite a questionable background because "Hillary wants him."

Writing in a new book, "Unlimited Access—An FBI Agent Inside the Clinton White House," the agent, Gary Aldrich, said then-associate White House counsel William H. Kennedy III told him in early 1993 that first lady Hillary Rodham Clinton wanted Livingstone in the job.

Kennedy, Aldrich wrote, asked him what the FBI thought of Livingstone as a replacement for a longtime veteran and "in particular what the FBI would think if there were character issues in his background."

"I responded gingerly, saying it was a post that should be filled with someone squeaky clean, before Kennedy cut me off. 'I guess I see your

point, but it doesn't matter. It's a done deal. Hillary wants him.'"

The embattled Livingstone announced his resignation Wednesday at a House hearing after a drumfire of criticism over his office's improper collection of sensitive FBI background reports on hundreds of Republicans from past administrations. One of the biggest mysteries left at the hearing was the question of who had hired Livingstone, a longtime political advance man with no background in security issues.

Aldrich was assigned to the White House to conduct background investigations for five years until he retired in June 1995. Angry in tone and laced with undocumented allegations, his book was published by a conservative house, Regnery Publishing Co. It was immediately denounced by the White House.

"On its face, this is trash for right-wing cash," said White House spokesman Mark Fabiani. Regnery, he said, has published books by former Los

Angeles police officer Stacey C. Koon and the National Rifle Association's executive vice president, Wayne LaPierre Jr. Fabiani said publication of the Aldrich book "is a political act with zero credibility."

Earlier this month, Aldrich wrote a short article for the Wall Street Journal's editorial page. It alleged that permanent White House employees suspected of disloyalty were in for "special" attention, "Hillary Clinton style"—such as new background investigations before they were due. An FBI agent he worked with, M. Dennis Sculmbrene, has alleged that White House political operatives prompted him for information contained in confidential FBI background files in an effort to root out career employees and replace them with Clinton supporters.

Those charges have led to an internal FBI investigation. The probe is focused on Aldrich's contentions that he told his supervisor, James Bourke, that the security system at the White House had been relaxed as those loyal to the Clintons could evade background checks. If Bourke was aware of such matters, the FBI inspectors will try to determine what, if anything, he did about them, sources

said. The inquiry is also directed at Sculmbrene's allegation that his FBI supervisors retaliated against him for testifying as a defense witness in the trial of fired White House travel chief Billy R. Dale. Dale was acquitted of embezzlement charges.

Sculmbrene had said he now reports to the FBI offices in Tysons Corner, where he has "no work, no assignments." In an August 1995 memo, David Bowls, another FBI agent who worked on the Dale case, told FBI higher-ups that Sculmbrene has "very bitter political feelings against the White House" and accused him of "irrational" behavior.

In his book, Aldrich said the new Clinton White House used temporary passes for many months to get around the need to provide the Secret Service with FBI background reports for permanent passes.

The White House counsel's office tightened security procedures in early 1994 after a review concluded that more than 100 employees were allowed to work for months without routine background investigations. White House officials acknowledged then that some White House staffers were found to have troublesome personal problems when the long-delayed investigation were finally completed.

Aldrich recounted meetings with Kennedy and with late White House deputy counsel Vincent Foster on the security problems, and said he told Foster the FBI had found character questions among staff members "at the highest levels" of the White House.

At one point, Aldrich wrote, he and Livingstone discussed the serious security problems, including staff members who should have been fired because of their backgrounds and the lack of cooperation from other White House staff members in even submitting to FBI interviews. Livingstone, wrote Aldrich, said Kennedy understood the problems but refused to deal with them.

The two men decided to go to higher-ups about the security problem, according to Aldrich. He wrote that he assumed they would discuss it with then-White House counsel Bernard Nussbaum. "Craig looked at me like I didn't have a brain. Nussbaum? It's not Nussbaum we gotta talk to. We'll be talking to Hillary."

Livingstone never mentioned the meeting with Hillary Clinton again, and it never came off, Aldrich wrote.

Aldrich, a 26-year veteran of the FBI, retired last year because, he has suggested, his experience in the Clinton White House soured him on the bureau. He had spent the last five years of his career as one of two FBI agents assigned to the White House, where he was responsible for conducting background investigations on White House personnel.

In his controversial new book, "Unlimited Access: an FBI Agent Inside the Clinton White House," Aldrich described his post as an elite assignment that afforded him the unique opportunity to look out the window and see "a king or a queen visiting the president."

But the FBI post at the White House has also been the subject of considerable controversy, particularly during the Clinton administration. One of the agents who helped with White House background checks in 1994 and 1995, Halbert Gary Harlow, was charged and eventually convicted last year of falsifying at least 50 interviews that he claimed to have conducted.

Aldrich was assigned to full-time duty at the White House with agent Dennis Sculimbrene, who almost lost his life in a 1995 accident, and has been quoted by another FBI agent as saying "he could get away with anything" because he was disabled. Sculimbrene is involved in a legal dispute with the FBI over his work assignments. He alleges he is being discriminated against because of his disability.

The FBI response to the allegations raised in Aldrich's book was a terse, two-paragraph statement saying that Aldrich had published his account without completing a required bureau review process.

As a condition of FBI employment, all employees and former employees are required to submit for review any publications that "could have been based on knowledge gained as a result of their employment," the FBI release said. "The purpose of this review is to ensure the integrity of the investigative or other official information employees learn as part of their official duties."

Jay Stephens, Aldrich's lawyer and former Republican U.S. attorney for Washington, said yesterday that over the last six months he and his client had worked closely with the FBI to address any concerns the agency may have about the manuscript.

"We substantially met all their concerns except for a couple of very limited passages that have become moot as a result of the hearings into problems in security clearances at the White House," Stephens said.

However, a senior bureau official disputed Stephens's account, saying that substantial issues remained unresolved before the book's publication.

Some senior bureau officials yesterday appeared caught in the position of trying to respond to a book with some credible allegations and other claims they considered undocumented rumor.

"Are we outraged by this behavior?" asked one senior bureau official. "Of course we are." But the official said that the bureau hasn't decided what to do about the book and noted that Aldrich does have First Amendment rights.

Should it decide to take action against Aldrich for publishing before the review process was completed, the bureau's only option is to pursue civil litigation to control profits of the book, said one source.

Upon first receiving the book, the FBI forwarded it to its Office Professional Responsibility as a part of routine procedure. Thus far the bureau has not been able to secure documents to substantiate Aldrich's claims about security procedures at the White House, sources said.

Aldrich first surfaced publicly two weeks ago, just after the controversy erupted over the White House's improper receipt of hundreds of FBI files, when he published an op-ed piece assailing the Clinton administration in the Wall Street Journal. In it, he accused the White House of thwarting security and background checks. He made no mention of the upcoming book.

The book describes the early Clinton White House as being in complete disarray, rife with staff members who had once been drug abusers, suffering from lax security clearance procedures and targeting employees that it wanted fired to make room for individuals who were viewed as loyal to the Clintons. He also claimed that the FBI ignored repeated complaints that the Clinton administration was allowing staff members to go long periods of time without permanent White House passes.

FBI sources said they had not yet been able to find any record of the complaints Aldrich said he had lodged.

Former Top FBI Agent at White House Raises Questions About Security Office

WASHINGTON — An FBI agent who was, until two months ago, the top FBI agent working in the White House, has raised new questions about the White House's personnel security office and its director, Craig Livingstone.

FBI agent Dennis Sculmbrene, who was recently transferred from the White House to FBI's Washington field office, has told investigators for the Senate Judiciary Committee that he raised complaints with his superiors about the chaotic management of the personnel security office two years ago and that he also had suggested that the office be run in a non-political manner. But Mr. Livingstone's hold on the job was secure because, the FBI agent said he was told, Mr. Livingstone's mother knew First Lady Hillary Rodham Clinton.

A White House spokeswoman and a lawyer for Mr. Livingstone both deny that Mrs. Clinton knows Mr. Livingstone's mother. Mr. Sculmbrene doesn't know why he was transferred from his post at the White House. He is currently embroiled in a legal dispute with the Federal Bureau of Investigation over work assignments.

During an unsworn interview Wednesday with the staff of the Senate Judiciary Committee, Mr. Sculmbrene alleged that Mr. Livingstone had some problems in his background and had said some untrue things to the FBI when he underwent an investigation for security clearance. He didn't tell investigators what the alleged problems in Mr. Livingstone's background or untrue statements were. Despite having no background in law enforcement, Mr. Livingstone was given the job and approved for security clearance.

Mr. Livingstone and an assistant improperly obtained FBI files on more than 400 people, including many Republicans. Congressional investigators and Independent Counsel Kenneth Starr are trying to determine whether the two men made an innocent mistake or were seeking to dig up dirt on political opponents. In private interviews with congressional investigators, Messrs. Livingstone and the assistant, Anthony Marceca, have said that the files were requested accidentally and weren't misused.

Mr. Livingstone, who is on leave from the White House post, referred questions to his attorneys. Mr. Livingstone's lawyer, David Cohen, declined to discuss the background investigation of Mr. Livingstone. "Background investigations are private matters," he said.

Slow Clearance Process

Mr. Sculmbrene, who worked at the White House for a decade and has conducted numerous background probes of presidential appointees, described his experience with the Clinton administration in a two-hour interview with Senate investigators. The security office problems started early in the Clinton White House, Mr. Sculmbrene said. The clearance process was moving very slowly, and many people were walking around the complex without proper passes, he said. Mr. Sculmbrene and another FBI agent at the White House, Gary Aldrich, repeatedly complained to their superiors about problems, and at one point Mr. Sculmbrene said he suggested turning over the security office to a professional rather than a political appointee.

In 1993, he thought he had a good candidate, Jackie Dinwiddie, who worked in the security office during the Carter administration. However, when he brought the idea to then-deputy White House counsel William Kennedy—who has since resigned—he says Mr. Kennedy told him that he was stuck with Mr. Livingstone. Mr. Sculmbrene told investigators that Mr. Kennedy knew there were problems in Mr. Livingstone's own background investigation, and another person familiar with the matter confirms this. Mr. Kennedy and his lawyer didn't respond to requests for comment.

According to Mr. Sculmbrene, both Mr. Kennedy and Mr. Livingstone told him that Mr. Livingstone's mother knew Mrs. Clinton, which seemed to explain his standing. However, Mr. Sculmbrene said he has no independent knowledge of whether the two women actually knew one another and suggested that Mr. Livingstone may have made it up in an attempt to inflate his status or protect his job. Another person who worked with Mr. Livingstone confirms that Mr. Livingstone boasted of ties between his mother and Mrs. Clinton.

'An Absolute Fabrication'

Mr. Cohen, Mr. Livingstone's lawyer, called this account "an absolute fabrication." White House officials said that Mr. Kennedy has denied telling Mr. Sculmbrene of any connection between Mrs. Clinton and Mr. Livingstone's mother. Jane Sherburne, White House special counsel, said Mrs. Clinton denies knowing Mrs. Livingstone.

Although Mr. Sculmbrene says his performance has been consistently rated as exceptional by the FBI, Senate investigators questioned him about events that could color his version of events. The FBI agent sustained a severe head injury two years ago that left him partly disabled, although he has returned to work. He is pursuing a discrimination complaint against the FBI, claiming he has been ordered to do work that contradicts his physician's recommendations. He said he is also under investigation for allegedly giving his son his government parking pass.

Mr. Sculmbrene also said he worries that he may be suffering retribution from superiors because he testified on behalf of former travel office director Billy Dale at Mr. Dale's embezzlement trial last year. Mr. Dale was acquitted. The firing of Mr. Dale and the rest of the travel office in 1993 led to a congressional inquiry and eventually to the disclosure that the White House had improperly obtained Mr. Dale's FBI file, along with more than 400 others.

Questions also were raised yesterday about whether Messrs. Livingstone and Marceca also collected confidential Internal Revenue Service data. According to a letter sent yesterday by Sen. Charles Grassley, an Iowa Republican, to FBI Director Louis Freeh, a box of documents removed from Mr. Livingstone's office by the FBI contained a folder full of papers bearing the IRS logo. Sen. Grassley asked the FBI director to describe what sort of documents are in the folder.

A Troubling Question for the FBI

AS THE CLINTON White House and Republicans in Congress play "gotcha" with each other over the improper use of sensitive background investigation files, their political gamesmanship risks overshadowing a serious question that has emerged concerning the FBI. Do FBI agents falsify interviews they claim to have conducted? It is a troubling issue, and here is why we ask.

Last week Rep. William Clinger (R-Pa.), chairman of the House Government Reform Committee, took to the House floor and disclosed that an FBI background investigation of former White House personnel security chief Craig Livingstone contained a 1993 interview with then-White House Counsel Bernard Nussbaum conducted by FBI agent Dennis Sculimbrene. In it, Mr. Nussbaum is reported as saying that Mr. Livingstone had come "highly recommended to him" by Hillary Rodham Clinton. Agent Sculimbrene also reported that Mr. Nussbaum had said that Mrs. Clinton had known Mr. Livingstone's mother "for a longer period of time."

Mr. Nussbaum, who earlier had told Congress under oath that he never had discussed Mr. Livingstone with Mrs. Clinton, issued a statement denying that he had made any such remarks to Agent Sculimbrene. Mrs. Clinton also said she hardly knew Craig Livingstone, had nothing to do with his being hired and did not know his mother, Gloria Livingstone. Mrs. Livingstone issued a statement that she doesn't know the first lady and never has met or spoken with her. The

accuracy of Agent Sculimbrene's report, therefore, is in question and raises a major concern.

The fact that another FBI agent—Halbert Gary Harlow, who had assisted with White House background checks in 1994 and 1995—was charged and eventually convicted last year of falsifying at least 50 interviews that he claimed to have conducted is a shocking indication that false FBI reporting can occur. Each year, the FBI probes scores of citizens to help determine their suitability for government posts. Little wonder the specter of an FBI agent reporting a conversation that never took place is chilling.

FBI officials are scheduled to testify before the House Government Reform Committee tomorrow. Expect a Democratic rumpus over whether Rep. Clinger was right or wrong to divulge information from Craig Livingstone's FBI file on the House floor. The chairman had been invited to review the file by FBI Director Louis Freeh. But the White House and its congressional defenders contend that the chairman divulged restricted information that was false. Look, too, for GOP countercharges that the FBI improperly tipped off the White House about Agent Sculimbrene's potentially damaging interview with Mr. Nussbaum just prior to Rep. Clinger's review of Mr. Livingstone's file. Republicans also will assert that two FBI agents went to Agent Sculimbrene's home in an attempt to intimidate him.

All of those accusations deserve responses. But in light of what's known, an equally large question deserves answering. Can FBI background investigators be trusted?

Today Representative William Clinger, hiding behind the legal fig leaf of the Speech or Debate Clause, took the extraordinary step of divulging on the House floor highly confidential and completely false information from an FBI background investigation.

Congressman Clinger has failed utterly to prove that the White House ever improperly released any private information from FBI files. Thus, today's astonishing speech by Mr. Clinger represents the first and only disclosure of confidential FBI background information during this entire matter.

What is worse, Congressman Clinger divulged confidential information that is clearly false and that originates from a questionable source. Bernard Nussbaum has said that the alleged conversation between Mr. Nussbaum and FBI Agent Dennis Sculimbrene never took place. Mrs. Livingstone has said that she does not know the First Lady and has never even met or spoken with Mrs. Clinton. And the First Lady has said that she does not know Mrs. Livingstone.

In addition, Mr. Clinger surely knows that, according to a published report, an FBI agent informed his superiors that Agent Sculimbrene harbored "very bitter political feelings against the White House." This same FBI agent also charged Agent Sculimbrene with "irrational" behavior. (Washington Post, June 28, 1996.) Yet other published reports indicate that Agent Sculimbrene is involved in a continuing dispute with the FBI regarding his work assignments. And, in recent weeks another FBI agent who had been assigned to the White House and worked with Agent Sculimbrene published a book containing wild rumors and rank innuendo; that book was thoroughly and completely discredited.

Nonetheless, Representative Clinger took to the House floor and divulged false information from a confidential FBI report in a desperate attempt to grab attention for his faltering "investigation." Mr. Clinger's speech today will be seen by most Americans as a reckless, partisan act.

Dear Director Freeh:

As you may know, Congressman Clinger today divulged, on the House floor, an interview report from a confidential FBI background investigation that has been declared to be false by the person who was interviewed. I am writing to you to ask how we can work together to ensure continued public confidence in the accuracy of FBI investigations.

According to Mr. Clinger's statement today, the background investigation file on Mr. Craig Livingstone includes a report by Agent Dennis Sculimbene on a conversation he says he had with White House Counsel Bernard Nussbaum concerning Mr. Livingstone's hiring. But, according to a statement issued by Mr. Nussbaum today, that conversation never took place.

This Administration and the American people have enormous confidence in the FBI, for good reason. And, the role that the agency plays in conducting background investigations and helping to ensure the suitability of appointees for their posts cannot be overstated. The President, you and the American people have a large stake indeed in the fairness and accuracy of this process.

That is why we are troubled, as we know you must be, by the implication that an FBI background investigation might include a false report. This matter is especially worrisome coming as it does on the heels of published reports of the conviction of one of the agents who did background checks at the White House on charges of falsifying at least 50 interviews that he claimed to have conducted.

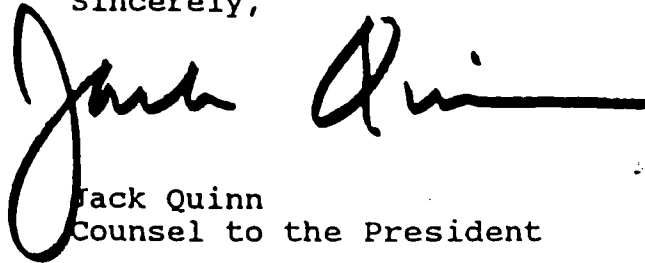
It is equally troubling that a Member of Congress can publicly reveal confidential FBI information, whether for partisan purposes or otherwise. It should not escape notice that this is done at a time when Members of Congress have expressed worry that employees of the executive branch might have sought out confidential FBI information about certain individuals and

planned to somehow use it publicly. While that charge has never been established against anyone in the executive branch, we now witness the same objectionable behavior by the very people who professed to be the guardians of privacy.

It is important that we take steps to ensure continuing confidence in the confidentiality and the integrity of the FBI clearance process. I look forward to your suggestions as to how we can work with you to that end.

'It's a Done Deal,' Counsel Allegedly Said

A former FBI agent assigned to the White House says he was told that Craig Livingstone was named head of personnel security despite a questionable background because Hillary wants him.

Writing in a new book, "Unlimited Access—An FBI Agent Inside the Clinton White House," the agent, Gary Aldrich, said then-associate White House counsel William H. Kennedy III told him in early 1993 that first lady Hillary Rodham Clinton wanted Livingstone in the job.

Kennedy, Aldrich wrote, asked him what the FBI thought of Livingstone as a replacement for a longtime veteran and "in particular what the FBI would think if there were clearance issues in his background."

"I responded gingerly, saying it was a post that should be filled with someone squeaky clean, before Kennedy cut me off: 'I guess I see your

point, but it doesn't matter. It's a done deal. Hillary wants him.'"

The embattled Livingstone announced his resignation Wednesday at a House hearing after a drumfire of criticism over his office's improper collection of sensitive FBI background reports on hundreds of Republicans from past administrations. One of the biggest mysteries left at the hearing was the question of who had hired Livingstone, a longtime political advance man with no background in security issues.

Aldrich was assigned to the White House to conduct background investigations for five years until he retired in June 1995. Angry in tone and laced with undocumented allegations, his book was published by a conservative house, Regnery Publishing Co. It was immediately denounced by the White House.

"On its face, this is trash for right-wing cash," said White House spokesman Mark Fabiani. Regnery, he said, has published books by former Los

Angeles police officer Stanley C. Koon and the National Rifle Association's executive vice president, Wayne LaPierre Jr. Published said publication of the Aldrich book "is a political act with zero credibility."

Earlier this month, Aldrich wrote a short article for the Wall Street Journal's editorial page. It alleged that prominent White House employees suspected of disloyalty were in for "special" attention, Hillary Clinton style—such as new background investigations before they were due. As FBI agent he worked with M. Dennis Sculimbrene, who alleged that White House political operatives pressed him for information contained in confidential FBI background files in an effort to root out paper employees and replace them with Clinton supporters.

Those charges have led to an internal FBI investigation. The probe is focused on Aldrich's contentions that he told his supervisor, James Bourke, that the security system at the White House had been relaxed so those loyal to the Clintons could evade background checks. If Bourke was aware of such matters, the FBI inspectors will try to determine what, if anything, he did about them, sources

said. The inquiry is also directed at Sculimbrene's allegation that his FBI supervisors retaliated against him for testifying as a defense witness in the trial of fired White House travel chief Billy R. Dale. Dale was acquitted of embezzlement charges.

Sculimbrene had said he now reports to the FBI offices in Tysons Corner, where he has "no work, no assignments." In an August 1995 memo, David Bowie, another FBI agent who worked on the Dale case, told FBI higher-ups that Sculimbrene has "very bitter political feelings against the White House" and accused him of "irrational" behavior.

In his book, Aldrich said the new Clinton White House used temporary passes for many months to get around the need to provide the Secret Service with FBI background reports for permanent passes.

The White House counsel's office tightened security procedures in early 1994 after a review concluded that more than 100 employees were allowed to work for months without routine background investigations. White House officials acknowledged then that some White House staffers were found to have troublesome personal problems when the idag-dehayed investigations were finally completed.

Aldrich recounted meetings with Kennedy and with late White House deputy counsel Vincent Foster on the security problems, and said he told Foster the FBI had found character questions among staff members "in the highest levels" of the White House.

At one point, Aldrich wrote, he and Livingstone discussed the serious security problems, including staff members who should have been fired because of their backgrounds and the lack of cooperation from other White House staff members in even submitting to FBI interviews. Livingstone, wrote Aldrich, said Kennedy understood the problems but refused to deal with them.

The two men decided to go to higher-ups about the security problem, according to Aldrich. He wrote that he assumed they would discuss it with then-White House counsel Bernard Nussbaum. "Craig looked at me like I didn't have a brain. Nussbaum? It's not Nussbaum we gotta talk to. We'll be talking to Hillary."

Livingstone never mentioned the meeting with Hillary Clinton again, and it never came off, Aldrich wrote.

To a number of his peers, was a competent FBI agent with strong conservative convictions who felt a kinship with the Bush administration and was openly disgusted when Bill Clinton captured the Oval Office.

"He was very cozy with most of the Bush staff," said an FBI agent who knows Aldrich and spoke on the condition of anonymity. There is "no doubt he has a phenomenal bias" against the Clintons.

"He was almost personally offended that the Clintons had won, and made no secret of that," the agent said. After Clinton was elected president, the agent said, Aldrich remarked, "I've never seen so many ponytailed, 50-year-old men in my life."

Aldrich, a 26-year veteran of the FBI, retired last year because, he has suggested, his experience in the Clinton White House soured him on the bureau. He had spent the last five years of his career as one of two FBI agents assigned to the White House, where he was responsible for conducting background investigations on White House personnel.

In his controversial new book, "Unlimited Access: an FBI Agent Inside the Clinton White House," Aldrich described his post as an elite assignment that afforded him the unique opportunity to look out the window and see "a king or a queen visiting the president."

But the FBI post at the White House has also been the subject of considerable controversy, particularly during the Clinton administration. One of the agents who helped with White House background checks in 1994 and 1995, Halbert Gary Harlow, was charged and eventually convicted last year of falsifying at least 50 interviews that he claimed to have conducted.

Aldrich was assigned to full-time duty at the White House with agent Dennis Sculimbrene, who almost lost his life in a 1995 accident, and has been quoted by another FBI agent as saying "he could get away with anything" because he was disabled. Sculimbrene is involved in a legal dispute with the FBI over his work assignments. He alleges he is being discriminated against because of his disability.

The FBI response to the allegations raised in Aldrich's book was a terse, two-paragraph statement saying that Aldrich had published his account without completing a required bureau review process.

As a condition of FBI employment, all employees and former employees are required to submit for review any publications that "could have been based on knowledge gained as a result of their employment," the FBI release said. "The purpose of this review is to ensure the integrity of the investigative or other official information employees learn as part of their official duties."

Jay Stephens, Aldrich's lawyer and former Republican U.S. attorney for Washington, said yesterday that over the last six months he and his client had worked closely with the FBI to address any concerns the agency may have about the manuscript.

"We substantially met all their concerns except for a couple of very limited passages that have become moot as a result of the hearings into problems in security clearances at the White House," Stephens said.

However, a senior bureau official disputed Stephens's account, saying that substantial issues remained unresolved before the book's publication.

Some senior bureau officials yesterday appeared caught in the position of trying to respond to a book with some credible allegations and other claims they considered undocumented rumor.

"Are we outraged by this behavior?" asked one senior bureau official. "Of course we are." But the official said that the bureau hasn't decided what to do about the book and noted that Aldrich does have First Amendment rights.

Should it decide to take action against Aldrich for publishing before the review process was completed, the bureau's only option is to pursue civil litigation to control profits of the book, said one source.

Upon first receiving the book, the FBI forwarded it to its Office Professional Responsibility as a part of routine procedure. Thus far the bureau has not been able to secure documents to substantiate Aldrich's claims about security procedures at the White House, sources said.

Aldrich first surfaced publicly two weeks ago, just after the controversy erupted over the White House's improper receipt of hundreds of FBI files, when he published an op-ed piece assailing the Clinton administration in the Wall Street Journal. In it, he accused the White House of thwarting security and background checks. He made no mention of the upcoming book.

The book describes the early Clinton White House as being in complete disarray, rife with staff members who had once been drug abusers, suffering from lax security clearance procedures and targeting employees that it wanted fired to make room for individuals who were viewed as loyal to the Clintons. He also claimed that the FBI ignored repeated complaints that the Clinton administration was allowing staff members to go long periods of time without permanent White House passes.

FBI sources said they had not yet been able to find any record of the complaints Aldrich said he had lodged.

Former Top FBI Agent at White House Raises Questions About Security Office

WASHINGTON — An FBI agent who was, until two months ago, the top FBI agent working in the White House, has raised new questions about the White House's personnel security office and its director, Craig Livingstone.

FBI agent Dennis Scullmbrene, who was recently transferred from the White House to FBI's Washington field office, has told investigators for the Senate Judiciary Committee that he raised complaints with his superiors about the chaotic management of the personnel security office two years ago and that he also had suggested that the office be run in a non-political manner. But Mr. Livingstone's hold on the job was secure because, the FBI agent said he was told, Mr. Livingstone's mother knew First Lady Hillary Rodham Clinton.

A White House spokeswoman and a lawyer for Mr. Livingstone both deny that Mrs. Clinton knows Mr. Livingstone's mother. Mr. Scullmbrene doesn't know why he was transferred from his post at the White House. He is currently embroiled in a legal dispute with the Federal Bureau of Investigation over work assignments.

During an unsworn interview Wednesday with the staff of the Senate Judiciary Committee, Mr. Scullmbrene alleged that Mr. Livingstone had some problems in his background and had said some untrue things to the FBI when he underwent an investigation for security clearance. He didn't tell investigators what the alleged problems in Mr. Livingstone's background or untrue statements were. Despite having no background in law enforcement, Mr. Livingstone was given the job and approved for security clearance.

Mr. Livingstone and an assistant improperly obtained FBI files on more than 400 people, including many Republicans. Congressional investigators and Independent Counsel Kenneth Starr are trying to determine whether the two men made an innocent mistake or were seeking to dig up dirt on political opponents. In private interviews with congressional investigators, Messrs. Livingstone and the assistant, Anthony Marceca, have said that the files were requested accidentally and weren't misused.

Mr. Livingstone, who is on leave from the White House post, referred questions to his attorneys. Mr. Livingstone's lawyer, David Cohen, declined to discuss the background investigation of Mr. Livingstone. "Background investigations are private matters," he said.

Slow Clearance Process

Mr. Scullmbrene, who worked at the White House for a decade and has conducted numerous background probes of presidential appointees, described his experience with the Clinton administration in a two-hour interview with Senate investigators. The security office problems started early in the Clinton White House, Mr. Scullmbrene said. The clearance process was moving very slowly, and many people were walking around the complex without proper passes, he said. Mr. Scullmbrene and another FBI agent at the White House, Gary Aldrich, repeatedly complained to their superiors about problems, and at one point Mr. Scullmbrene said he suggested turning over the security office to a professional rather than a political appointee.

In 1993, he thought he had a good candidate, Jackie Dinwiddie, who worked in the security office during the Carter administration. However, when he brought the idea to then-deputy White House counsel William Kennedy—who has since resigned—he says Mr. Kennedy told him that he was stuck with Mr. Livingstone. Mr. Scullmbrene told investigators that Mr. Kennedy knew there were problems in Mr. Livingstone's own background investigation, and another person familiar with the matter confirms this. Mr. Kennedy and his lawyer didn't respond to requests for comment.

According to Mr. Scullmbrene, both Mr. Kennedy and Mr. Livingstone told him that Mr. Livingstone's mother knew Mrs. Clinton, which seemed to explain his standing. However, Mr. Scullmbrene said he has no independent knowledge of whether the two women actually knew one another and suggested that Mr. Livingstone may have made it up in an attempt to inflate his status or protect his job. Another person who worked with Mr. Livingstone confirms that Mr. Livingstone boasted of ties between his mother and Mrs. Clinton.

'An Absolute Fabrication'

Mr. Cohen, Mr. Livingstone's lawyer, called this account "an absolute fabrication." White House officials said that Mr. Kennedy has denied telling Mr. Scullmbrene of any connection between Mrs. Clinton and Mr. Livingstone's mother. Jane Sherburne, White House special counsel, said Mrs. Clinton denies knowing Mrs. Livingstone.

Although Mr. Scullmbrene says his performance has been consistently rated as exceptional by the FBI, Senate investigators questioned him about events that could color his version of events. The FBI agent sustained a severe head injury two years ago that left him partly disabled, although he has returned to work. He is pursuing a discrimination complaint against the FBI, claiming he has been ordered to do work that contradicts his physician's recommendations. He said he is also under investigation for allegedly giving his son his government parking pass.

Mr. Scullmbrene also said he worries that he may be suffering retribution from superiors because he testified on behalf of former travel office director Billy Dale at Mr. Dale's embezzlement trial last year. Mr. Dale was acquitted. The firing of Mr. Dale and the rest of the travel office in 1993 led to a congressional inquiry and eventually to the disclosure that the White House had improperly obtained Mr. Dale's FBI file, along with more than 400 others.

Questions also were raised yesterday about whether Messrs. Livingstone and Marceca also collected confidential Internal Revenue Service data. According to a letter sent yesterday by Sen. Charles Grassley, an Iowa Republican, to FBI Director Louis Freeh, a box of documents removed from Mr. Livingstone's office by the FBI contained a folder full of papers bearing the IRS logo. Sen. Grassley asked the FBI director to describe what sort of documents are in the folder.

21 Mr. Sculimbrene. I don't--I am getting at the gray
22 area here now.

23 Ms. Owens. No, no. You are fine there. If I lean
24 forward, it is because he had mentioned derogatory in
25 reference to Livingstone's file, and I am concerned

1 about--that reflects the results of an investigation when he
2 said that there was derogatory, and I would just assume--

3 Mr. Larkin. And we will, like, strike that, okay, for
4 the record.

5 Ms. Owens. That was the only area I had concern in,
6 and they have been very good about the leading things or
7 problematic.

8 Mr. Larkin. We are trying. We are trying.

9 Mr. Hubbard. Can I follow up on this?

10 Mr. Yoo. What day'did--do you remember when Mr.
11 Livingstone made that comment to you about her mother?

12 Mr. Sculimbrene. This was during my several interviews
13 with him in the process of doing his background
14 investigation.

15 Mr. Hubbard. You said that he told you several things
16 that you now know to be untrue. Can you tell us what they
17 are?

18 Mr. Sculimbrene.. Mr. Livingstone or Mr. Kennedy?

19 Mr. Hubbard. Mr. Livingstone.

20 Mr. Sculimbrene. Well, we are going to get into--

21 Ms. Owens. Are they in connection with the background
22 investigation when he was interviewed?

23 Mr. Sculimbrene. Yes.

24 Mr. Larkin. We will pass.

- In an insert in Mr. Livingstone's FBI background investigation, Agent Sculimbrene reports of an interview with Bernard Nussbaum in which Mr. Nussbaum purportedly said "Mr. Livingstone had come highly recommended to him by Hillary Clinton, who has known his mother for a longer period of time." Congressional Record, Statement by Congressman Clinger, July 25, 1996 at H8520.
- "According to Mr. Sculimbrene, both Mr. Kennedy and Mr. Livingstone told him that Mr. Livingstone's mother knew Mrs. Clinton, which seemed to explain his standing. However, Mr. Sculimbrene said he has no independent knowledge of whether the two women actually knew one another and suggested that Mr. Livingstone may have made it up in an attempt to inflate his status or protect his job." Wall Street Journal, June 25, 1996.
- [Q] Let me ask you, though, do you ... remember any conversations where you were told that Mr. Livingstone got the job because he was connected with Mrs. Clinton?

[A] Yes. Kennedy told me that.

Testimony of M. Dennis Sculimbrene before the Senate Judiciary Committee, June 19, 1996.

- [Q] In Mr. Livingstone's conversations about his political background ... do you recall any specific stories that he might have told you ... as relevant to the kind of job he did at the White House Security Office?
- [A] Well, he claimed that his mother knew Hillary Clinton.

[Q] Is there any other information such as whether or not Mr. Livingstone's mother knew the First Lady that you heard from Mr. Livingstone but didn't put in his background investigation?

[A] I heard others tell me that that was the case; that he had told them that his mother knew Mrs. Clinton.

[Q] And was that Bill Kennedy?

[A] Only by inference.
