Pursuant to Rule 3(b) of the Federal Rules of Appellate Procedure, we have consolidated these two appeals, which raise identical issues. The district courts below dismissed the plaintiffs' actions, finding them to be totally groundless. We have studied the plaintiffs' appeal papers, and concur in the district courts' findings that these are totally groundless lawsuits. Accordingly, we affirm. See Circuit Rule 14(f)(1).

Not only are the underlying actions groundless, but these appeals are completely frivolous; the appellants' briefs contain little besides scandalous allegations of misconduct directed against the district judges and the appellees. The appellants' abuse of their right of access to the federal courts is unpardonable. We invite the appellees to file with this court a motion for just damages under Rule 38 of the Federal Rules of Appellate Procedure.

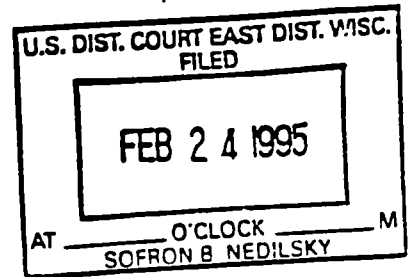

Judge writes attorney general complaining about prosecutors

US attorney's office
is pursuing the wrong
cases, Evans says

Chief Federal Judge Terence Evans is bringing longstanding criticisms of the US attorney's office to the attention of US Atty. Gen. Janet Reno, saying "all is not well" in the Federal Courthouse in Milwaukee.

In a letter to Reno dated March 25 and in an earlier interview, Evans has invited scrutiny of an office that he contends is overstaffed with sometimes overpaid lawyers pursuing the wrong types of cases.

Evans is not the only judge who is troubled. Federal Judge J.P. Stadtmueller, a former US attorney, was even more critical than Evans in comments during public court proceedings last January and February. The Journal has learned.

Between them, the two judges — Evans a Democratic appointee and Stadtmueller a Republican appointee — have criticized everything from disparity in charging decisions made in the office to the abilities of some assistant US attorneys.

Stadtmueller, in unusually harsh comments made in open court, also said there was a "definitive lack of leadership" in the US attorney's office and that "we could certainly in this district be just as effective with about 25% less assistant US attorneys for a whole lot of rea-

sons." The US attorney in Milwaukee, John Fryatt, was appointed by President Reagan in 1988. He is due to be replaced by a Clinton administration choice, and he announced last week that he would take a new job as chief of law enforcement for the state Department of Natural Resources.

During an interview Monday, Fryatt declined to "respond in kind" to any criticisms, but he repeatedly stressed the quality and accomplishments of his staff, part of which he inherited from Stadtmueller, his predecessor, in 1988.

"If [Stadtmueller] wants to criticize our staff, that is his prerogative... I am extremely proud of our staff and its accomplishments."

Fryatt defended himself almost reluctantly. He intimated that the judges' comments were unfair, but for the most part held his tongue.

Deputy US Atty. R. Jeffrey Wagner said that Fryatt unfairly

I hope you can act immediately on these matters.

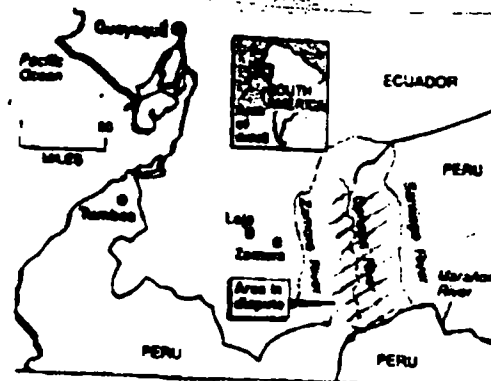

ON CONDOR, COCAINE AND CHEMICAL WEAPONS

Sir--Contrary to your suggestion that Ecuador should give up the Condor mountains ("WARNING FROM THE ANDES," Feb 18th) the opposite will be in the best interest of the region and specially the rich countries of the northern hemisphere. In the article, you say nothing about the vital economic interests of anti-social elements in the Condor region. The fantasy and talk about gold, uranium and petroleum really camouflages the much more profitable cocaine production and trade in northern Peru and its potential expansion to the areas under Ecuador which are drug free. The mountainous region between the Zamora and Santiago rivers is of great potential for the cultivation of coca plant because of its eco-geography, and the producers know that. Until now, neither the native Shuar Indians nor their Ecuadorean democratic government have allowed cultivation of the plant on those forests. On the other hand, as Miami El Herald (2-7-95) reports, one of the main reasons of Peru attack to Ecuador is that "before the attack a group of narcos was capture in Peru and was discovered their implications with a close associate of Vladimiro Montesinos, Presidential Advisor (called in Peru Fujimori's "Rasputin")." Also, there are reports of implications of high level Peruvian Arm Forces members in cocaine related businesses. By the way, the Peruvian Arm Forces, General de Bari Hermosa was buying armament to Cuba during his President's attendance to the "Miami Summit", violating the economic blockade to the Castro government. As a professional working in both sides of that border, I know that Andean people use the coca plant since approx. 3,000 B.C. During the Colonial period, Spain received more revenues from coca than from gold and silver, as Peru's economy reportedly does today. With the implementation of Philip II Indians Law, in the 17th and 18th centuries only one Spanish colony, that under the Royal Audience of Quito's territory (Ecuador now), was an exception to this. Quito was able to practically eradicate coca production and use. But, since its Independence from Spain, in 1824, Ecuador repeatedly lost its land to the Peruvian conquerors, and coca has been replanted in those grounds. It is not a secret that during this conflict foreign journalists have been allowed, by the Ecuadorean authorities under President Duran-Ballen, to freely go to the battle front to do their job, while Fujimori's Government did not permit foreign reporters to go to their side of the border. Is it because Fujimori's government is hiding the coca of the north? or what is even worse, are his military generals hiding and using their chemical weapons? (violating the Geneva Convention and cease fire agreement). Unfortunately, in Fujimori's desperate attempt to get re-elected he is trying to invade a drug free Condor symbolized by Ecuador's

Tiwintza. In the global battle against drugs, financed in Peru, partly with American taxpayers money, the countries in this hemisphere can not remain indifferent to what is happening in this remote area in the Eastern Andean Cordillera. They must act quickly and decisively to keep the Condor region coca free. It is time for them to preassure Peru Government to settle the border dispute in a peaceful and just way, recognize the international legal rights of Ecuador to a border on the east of the Zamora-Cenepa-Santiago regions. This permanent border will not only benefit the hemispheric economic relations, but will also prove beneficial to the western societies as a whole by avoiding enlargement of coca production, trade and associated corruption and violence in the Americas.

SIR—I have been surprised in recent weeks by your slipshod use of the word “Islamic”, which, rather than meaning simply Muslim, is apparently intended as shorthand for “radical” or “fundamentalist”. A notable example is your article “If Islamists rule Algeria” (February 25th). Its first paragraph begins: “Eventually, Algeria will probably become an Islamic state.” Algeria has, of course, been an Islamic state since 1962. What you presumably mean is that it will probably become a radical, fundamentalist Islamic state, or a theocracy along the lines of Iran.

The insidious assimilation of the notion of radical Islam into the term Islamic, whether out of laziness or calculation, can only serve to reinforce prejudices that are discouragingly commonplace in the West.

SIR—I am appalled at the one-sidedness of your analysis of the conflict between Ecuador and Peru (“A warning from the Andes”, February 18th). To blame this border dispute, which concerns a 78-kilometre (not, as you state, 68-kilometre) stretch of land, mainly on Latin American nationalism misses the mark. Your insinuation that social inequalities, intensified by liberal economic policies, may lie at its root is also misguided. Although it is true that the popu-

larity of Sixto Duran, Ecuador's president, has declined recently, this is even truer of Alberto Fujimori, his Peruvian counterpart. Mr Fujimori badly needs a military trophy to boost his chances of re-election in April.

You also fail to mention that high-ranking officers in the Peruvian armed forces have recently been implicated in narcotics dealings. A military victory, the generals hope, might restore their tarnished image. Poor countries such as Peru and Ecuador need to dedicate their scarce resources towards peaceful and constructive ends. Generals, however, are not great enthusiasts of curtailed defence budgets.

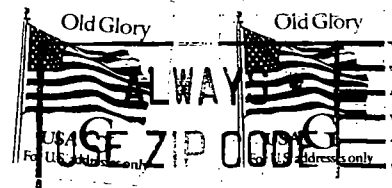

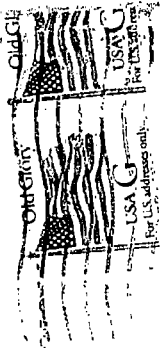

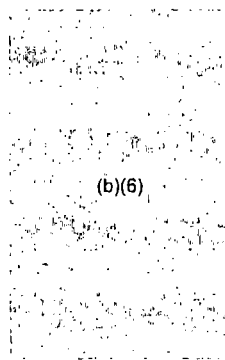

When Simon Wiesenthal, founder of the Jewish Documentation Center in Vienna, addressed a graduating class at John Jay College of Criminal Justice (where we had recently established an *Institute for the Study of Genocide*), he repeated a point he had frequently made about the true function of trials of genocidal criminals. "The purpose," he said, "was not revenge - but rather "the education of future generations."

As all the world knows, the United Nations has commissioned a Tribunal to try the perpetrators of atrocities in the former Republic of Yugoslavia. When Judge Goldstone, the Tribunal's humane and most able prosecutor, requested photographic evidence possessed by the United States, a White House spokesman, Michael D. McMurray, turned the him down. This refusal compromises not only the prosecutorial role of the Tribunal, but its more fundamental educational role as well.

According to a New York Times report by Elaine Sciolino (November 8th) Mr. McMurray based the U.S. decision on "national security reasons". Nevertheless, according to the reporter, a complaint by Judge Goldstone "suggests the impression that the United States is withholding evidence out of a concern that it could jeopardize the peace talks."

Two hypotheses suggest themselves as alternatives to our transparent pretext of "national security". The more generous would argue that the U.S. is conditionally withholding the evidence in order to hold it over the heads of the Serbs - in effect, to blackmail them

into making peace. The problem is, if the blackmail is accepted, we will be honor-bound to live up to our part of the deal, and continue to withhold that evidence - in effect, protecting the accused.

A less generous hypothesis would suggest that the United States may have decided to add respectability to any agreement by participating in a white-wash of the alleged perpetrators. This strategy would require the U.S. to define them as statesmen and "peace-makers" rather than plotters of mass atrocities.

Neither of these strategies is compatible with our commitment to international decency and international law. And neither holds promise on pragmatic grounds. Changing the image of killers will not change their character. There is little reason to expect that those who waded to their objectives in blood will abandon murder as a policy once that policy has been rewarded.

AUGUST 16, 1995, 4:00 p.m. EDT**

SITUATION:

Gale force winds are approaching the coastal waters of North Carolina. At noon today 45 mph winds were reported at Alligator Bridge, North Carolina. Winds in Norfolk and Cape Hatteras have been reported at 30 mph. Coastal areas of North Carolina and Virginia have been evacuating since yesterday.

WEATHER REPORT/FORECAST:

At 2:00 p.m. EDT the center of Hurricane Felix was located near latitude 34.8 north, longitude 73.0 west or about 150 miles east-southeast of Cape Hatteras, North Carolina.

Felix is moving slowly toward the west-northwest at 12 mph with a decrease in forward speed expected during the next 24 hours. Maximum sustained winds are near 80 mph, with little significant change in strength likely over the next 24 hours.

Hurricane warnings are in effect from New River Inlet North Carolina northward to Chincoteague, Virginia. This includes Albemarle and Pamlico Sounds and Chesapeake Bay from Windmill Point southward.

As of 2:00 p.m. a hurricane watch is in effect from Chincoteague, Virginia to Cape Henlopen, Delaware.

A tropical storm warning is in effect from Chincoteague, Virginia to Manasquan Inlet, New Jersey.

STATUS OF FEDERAL OPERATIONS:

Region III ROC will be activated at 4:00 p.m. today. Contact person is Darryl Hammons at 215-931-5652.

Region IV ROC opened on August 16. The contact person is Robert E. McBeth at 404-853-4540.

The Advanced Elements of the Emergency Response Team (ERT-A) have arrived in Richmond and are being briefed on the situation. Bob Gunther, from Region III, is the contact person. The ERT-A will be located in a room adjacent to Virginia EOC. Dave Hall is serving as the Commonwealth of Virginia FEMA liaison.

Joe Zagone is the FEMA liaison in Maryland.

The MATTS team consisting of four personnel and four vehicles from Mt. Weather has arrived at the Virginia State EOC in Richmond and will be fully operational this afternoon. A mobile Ku-Band satellite and communications vans, support vehicle with generators and a passenger vehicle were sent. MERS Maynard deployed to the Naval Air Station at Willow Grove, Pennsylvania. Twenty-three personnel and 20 vehicles including a multiradio van, video broadcast capability, ADP cartruck, 400 kw generators, an uninterruptible power supply, HVAC and cargo trucks. Thomasville MERS deployed to the mobilization center (MOB) at Ft. Bragg, North Carolina with 37 personnel and 30 vehicles including multi-radio van, video broadcast capability, an ADP cargo truck, 400 kw generators, uninterruptible power supply, HVAC and cargo trucks.

ESF Status: ESP05 is activated. All other eleven ESPs will be activated as of 8:00 a.m. August 17.

STATUS OF STATE OPERATIONS

North Carolina - Reports that 200,000 people were evacuated from the outer banks. Areas A and C are activated, with a FEMA liaison dispatched to the EOC. The American Red Cross opened shelters on August 15. A MERS team has been deployed to Ft. Bragg with 3 trailer loads of generators and 550 rolls of plastic sheeting. FEMA has also sent 2 instructors to assist the North Carolina SPEED (Rapid Assessment) teams. The State EOC FEMA contact is Ginger Edwards at 919-733-9091.

Virginia - A state of emergency was declared on August 15. The State EOC activated at 8:00 a.m. Full staff and 15 agencies are represented at the EOC. The ERT-A was activated at 1:00 p.m. on August 15. Evacuation of Virginia Beach and Norfolk was voluntary. Flooding in the Norfolk area could affect abilities of mass care facilities.

District of Columbia - The Mayor has been briefed and the National Guard notified of the situation. No shelter problems are anticipated.

Maryland - Departments and agencies and a FEMA representative are in the State EOC. No evacuations have been ordered. An emergency declaration is on standby. The National Guard has been alerted.

Delaware - Reports minimal evacuation of beach areas. All ESFs are on standby. The National Guard has been alerted and an emergency Declaration is in place for the Governor's signature.

South Carolina - ESFs were activated on August 15. Currently, they have been returned home.

UNHEARD OF AUDIO AND VIDEO COMMUNICATION

On April 7 I sent you a 3x5 memo stating that I have taken my story and its claims as far as it can go with the pen. Now I have to figure how I can talk to someone at someplace. As I mentioned I have never discussed my story in any verbal way with anyone at any time. I have no telephone and no telephone credit card and anyone I would converse with should be conditioned in the same way as those on the mailing list. It is not easy to prove myself without cooperation.

During the years in which I lived and worked in New York City and Washington, D.C., I probably would have been unreceptive to Peter Brimelow's new book, "Alien Nation."

Like the free-market conservatives whom I greatly admire including Jack Kemp, William Bennett and Bob Bartley of The Wall Street Journal, I held fast to the tenet that immigration was an unqualified boon to the U.S. economy.

Then I moved to San Diego, where year after year a half-million aspiring immigrants are arrested as they try to steal across the U.S. border from Mexico.

Another 100,000 or so illegals manage to evade arrest by outmanned Immigration and Naturalization Service agents. They cost California taxpayers more than \$2 billion a year, after factoring in whatever contribution they make to the state economy.

My heroes, Kemp and Bennett and Bartley, are barely willing to acknowledge that illegal immigration amounts to a clear and present national crisis (although their perspective might change if, say, a half-million Chinese boat people paddled into New York Harbor every year, or if flotillas of Haitian refugees were regularly sighted on the Potomac).

So I know that they strongly disagree with Brimelow's argument that legal immigration also has gotten out of control.

But Brimelow, a senior editor for Forbes and National Review, and a British expatriot, has the weight of evidence on his side. And he lays it out, exhaustively, in "Alien Nation."

He says that America is experiencing its greatest wave of immigration ever, taking in almost half the world's immigrants. What makes this present wave different from those that have passed before, Brimelow warns, is that the latest immigrants are less educated, less skilled, more prone to trouble with the law and less likely to share American culture or values.

The author does not exaggerate. Indeed, government numbers show that a

higher percentage of immigrants are on the welfare rolls than native-born Americans. That immigrants have more than twice the high-school dropout rate as native-borns. And that immigrants make up one-fourth of the federal prison population.

The present immigration crisis is not so much a matter of quantity — as Brimelow suggests — given that immigration as a proportion of population is less than a fifth of what it was at the turn of the century.

It is more a matter of quality, what with only 4 percent of people legally immigrating to America each year allowed in because of their skills, compared with 96 percent who are admitted because they have relations here.

Whether the majority of immigrants today are of Latin, Asian, African or (as Brimelow apparently prefers) European extract is not as important as the author makes out.

What matters is what they have to offer this country. America certainly can use more doctors and engineers and scientists.

The real problem is that too many of the immigrants who cross our borders are contributing little if anything to America's gross domestic product. Too many are tax burdens rather than taxpayers. And too many are flouting our nation's immigration laws.

Here's the way federal lawmakers can address each of these problems, as I suspect Brimelow would agree. Give priority to immigrants who speak our native tongue and who have skills to offer.

Make immigrants ineligible for welfare and other benefits until they have spent at least five years on American soil and have obtained U.S. citizenship. And, finally, repatriate any and all immigrants who cross our border illegally.

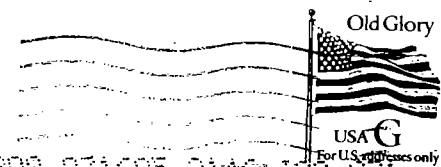
