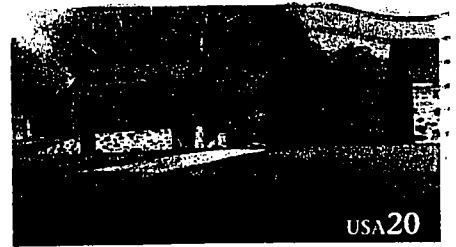

A New Solution for the CIA

I. F. Stone

Stalin did establish one useful precedent. He made it a practice to bump off whoever served as head of his secret police. He never let anybody stay in the job too long. As a successful dictator, Stalin seems to have felt that anybody who had collected so many secrets would be a No. 1 menace to security if he ever went sour. Stalin thought it safer not to wait.

I think we ought to take Stalin's example one step further. I think we ought to get rid of the CIA altogether, lock, stock, and burglar's kit.

We know from recent revelations how J. Edgar Hoover in his lifetime tenure as FBI chief collected dossiers on the sexual and drinking habits of congressmen and high officials. The mere rumor that such secrets were in his files made Hoover the most feared man in the capital, the untouchable of US politics. A similar character could build up a similar empire of fear in and through the CIA.

Those who think it enough to establish new oversight committees should remember that there have been CIA committees in Congress since the agency's formation and they have invariably overlooked the abuses they were supposed to oversee. As for forbidding the agency to engage in "dirty tricks," how enforce such a restriction against an agency so secretive, so far-flung, and so habituated to doing-in political leaders of whom it disapproves? It is hard enough to keep a tight rein on public agencies right here in Washington. How to control, some-

times 10,000 miles away, the kind of adventurers, screwballs, and intriguers an agency like the CIA naturally attracts?

The US government is inundated daily by tidal waves of intelligence. We have a mysterious electronic NSA which taps and tapes all the communications systems of the world; its huge "ears" in Pakistan and Turkey record the slightest Kremlin sneeze. Even in remotest Siberia, no *babushka* can milk her cow without being caught on candid camera from US satellites on eternal patrol.

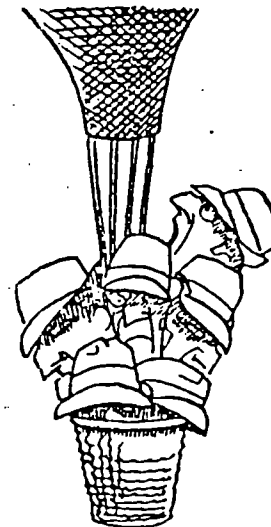
In the Pentagon are separate intelligence branches of the army, air force, and navy, each with its own military attachés abroad, and over all of them is a defense intelligence agency, a DIA. The State Department has its own intelligence and research division; the Foreign Service is its eyes and ears abroad. The departments of Commerce, Labor, and Agriculture have attachés of their own in many US embassies. Businessmen and Washington correspondents who use their publicly available studies on countries and commodities know how much more reliable they are than the spooks.

The Treasury has its narcotics and other agents. Internal Revenue, Customs, and the Post Office have their own gumshoe men. There is the FBI and there is the Secret Service. Nobody seems to know how much all this costs or how many are employed. Congress does know that CIA expenditures hidden in certain crevices of the budget add up to several billions of dollars. The exact amount is unknown.

Originally we were told when the CIA was established by Truman in 1947 that it was necessary—as its name implied—to "centralize" all these intelligence activities and summarize for the White House the information flowing in from them. We were not told, and perhaps Truman never intended, that the CIA would soon be engaged in James Bond melodrama around the world, making and unmaking governments not to our liking, and in the process sentencing other nations' leaders like Mossaddeq of Iran and Allende of Chile to death. Watergate has already shown us that to practice such crime-as-politics abroad is to invite its application sooner or later to politics at home.

As an intelligence service the CIA has been a bust. The Bay of Pigs and the Vietnam war are only the most dramatic demonstrations that public officials would have been better informed—and adopted wiser policies—if they had simply read the newspapers and put all that "classified" information in the wastebasket. The CIA has made the US look like the world's biggest Mafia while helping to trap it into one serious mistake after another. Never have so many billions been squandered on so much misinformation. In its twenty-seven years of existence—even at \$2 billion a year—this giddy operation must have cost upward of \$50 billion. Why not get rid of it before it can do more damage?

Even when, occasionally, the CIA analyses were accurate they have gone into the bureaucratic wastebaskets because they conflicted with



what officials higher up wanted to hear. One example is the sour reports about the Vietnam war which turned up in the Pentagon Papers. Another example (see the exclusive in *The Christian Science Monitor*, January 23, 1975) was the studies showing there was "no evidence to suggest" that the anti-Vietnam war movement was instigated from abroad. The Nixon White House nonetheless ordered the agency to go ahead and compile a list of 10,000—no less—peaceniks suspected of being foreign agents.

A government, like an individual, hates to hear what it doesn't want to believe. This is why no intelligence agency in any society ever really understands—or can afford to let itself understand—what is going on. The bigger the intelligence agency the more powerfully its sheer inertial weight reinforces the misconceptions of the ruling class it serves. Hence the paradox: the more "intelligence" a government buys the less intelligently it operates. The CIA will go down in the books as a vain attempt to change history by institutionalizing assassination. It deserves a dose of its own favorite medicine. □

Later in the trip we went on a hike. The last three miles were completed after dark. The trail had several types of markers on it, including paint on trees and aluminum markers nailed onto trees. If anyone asks, the aluminum trail markers are better because they're easier to spot with a flashlight when finding your way back in the dark.

The antique automobile museum up that way is interesting too, but what really captured my imagination were the old tourist stops on the road between the interstate and Fayetteville. They're built on an overlook which now contains a hang-gliding ramp. Intact structures from the late 40's and early 50's are interesting because many commercial properties in existence today have been renovated a number of times since then, especially here in Washington suburbs.

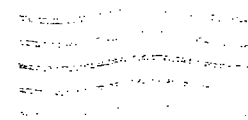

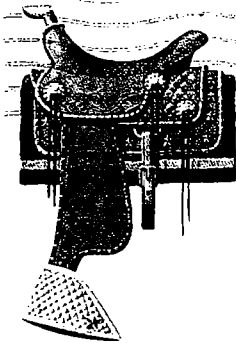

Like the criticism that Dan Quayle received after spelling "potato" wrong; you may find yourself defending yourself over a silly thing. Let me explain.

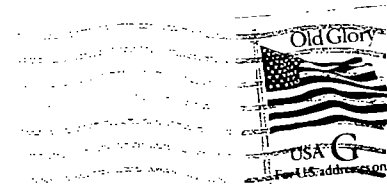

Not a weapon.

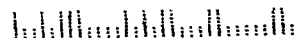

I wonder when Dee Dee Myers will write a book and you will be called one to rebut her stories.

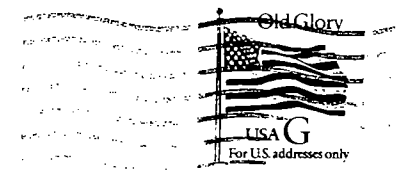

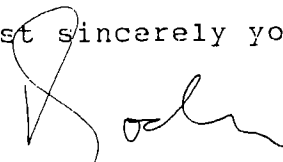
Dear Mike,

TAXPAYERS RIP SENATE BILL 446 AS PHILIP/DEANGELIS VERSION OF MICHIGAN'S DEVASTATING "PROPOSAL A" \$8 BILLION TAX HIKE

The head of Illinois' largest taxpayer organization today blasted **Senate Bill 446**, currently on the Illinois Senate floor, as a dangerous version of Michigan's "**Proposal A**," which claimed to be a "tax-shift bill" and ended up raising total state revenues over \$8 billion a year, becoming the largest tax hike in Michigan's history.

"According to published reports, Senate President **James 'Pate' Philip** (R-23, Elmhurst) admires Michigan's Proposal A and can't wait to pass his own version of the overwhelmingly-rejected Netsch plan," said **Jim Tobin**, President of **National Taxpayers United of Illinois** (NTU). "Senate Bill 446, now in its final reading in the Illinois Senate, would prohibit school districts from levying any property taxes, and would up a committee of politicians and pro-tax bureaucrats to find alternate sources of tax funds."

"In other words, property owners would get temporary property tax cuts and individuals and corporations would get huge, permanent hikes of at least \$10 billion in their state income and sales taxes. The current corporate income tax of 7.3 percent would probably become the highest in the nation. The state sales tax of 6.25 percent, second highest in the nation, probably would be substantially increased."

"If Michigan is any indication, Illinois politicians will permanently raise state taxes at least \$10 billion after temporarily lowering property taxes about \$6 billion."

"In Michigan, property taxes were temporarily cut \$3.5 billion, but Proposal A turned out to be the largest tax hike in Michigan history. Total state revenues in Michigan rose from \$20.8 billion in fiscal year 1994 to an estimated \$28.8 billion for 1995. If Sen. Pate Philip and Senate Revenue Committee Chairman Sen. **Aldo DeAngelis** (R-40, Chicago Hts.) have their way, state income and sales taxes in Illinois would skyrocket."

"If S.B. 446 is approved by the Senate, I call upon House Republicans to quickly put it out of its misery. House and Senate Republicans were elected the majority party last November to cut taxes, not pass huge tax increases masquerading as tax-shifts."

"S.B. 446 was passed the Senate Revenue Committee by a six-to-two vote on March 9. It is a scandal that three of the six votes to pass S.B. 446 were by Republicans. The three Republicans who betrayed their constituents by voting for this dangerous, misleading tax-hike bill were: Sen. **Aldo DeAngelis** (R-40, Chicago Hts.), Sen. **Beverly Fawell** (R-20, Glen Ellyn) and **Harry 'Babe' Woodyard** (R-53, Chrisman)."

"The three Democrats who voted for S.B. 446 were: Sen. **Thomas Dunn** (D-43, Joliet), Sen. **Arthur Berman** (D-9, Chicago) and Sen. **William O'Daniel** (D-54, Mt. Vernon)."

"Taxpayers owe a debt of gratitude to the two State Senators who voted 'No' on March 9. They showed great courage in opposing the tax-hike plans of their respective party leadership. They are Sen. **William Peterson** (R-26, Long Grove) and Sen. **Alice Palmer** (D-13, Chicago)."

"Senate Republicans must find the backbone to vote 'No' on this Philip/DeAngelis tax-hike scam bill. And House Republicans must make it very clear that they will not go along with any such tax hike bill masquerading as tax reform."

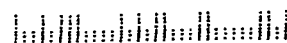
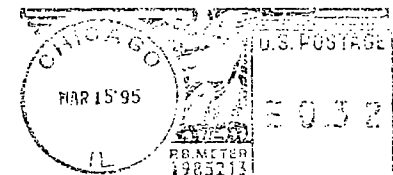

Recently, the Executive Order on Affirmative Action (11246) has become part of the debate on affirmative action. Along with the Voting Rights Act of 1965, the Executive Order on Affirmative Action is perhaps the nation's most important and effective civil rights program over the past thirty years. Literally millions of women and minorities have been given an opportunity to compete in the workplace thanks to the Executive Order. The heart and soul of the Executive Order, the provision for goals and timetables and the prohibition of quotas, is the model on which almost all other affirmative action programs are based.

Some pertinent facts about the Executive Order on Affirmative Action:

- Affirmative Action programs under the Executive Order consist essentially of three elements, all of which are prepared by the employer. If the employer receiving federal funds determines that there is an underutilization of women and minorities in the workforce, the employer must establish goals and timetables and then must make good faith efforts to meet them. Failure to meet a goal does not subject one to sanctions as long as there were good faith efforts.
- The Executive Order on Affirmative Action prohibits quotas.
- The goals and timetables language was added to the 1965 Johnson Executive Order by President Richard Nixon and Secretary of Labor George Shultz in 1970. The business community recommended this "management by objectives" concept to the Nixon Administration in the late 1960s.
- Private and public studies, including one done by the Reagan Labor Department, have shown that the Executive Order program has worked well and does not lead to quotas.
- The Executive Order has always had strong business community support.
- The Executive Order has always had strong bipartisan support. Indeed, 69 Senators and more than half of the Reagan Cabinet opposed the efforts of Ed Meese, Brad Reynolds, and Clarence Thomas to gut the Executive Order in 1985 by deleting the goals and timetables provision.

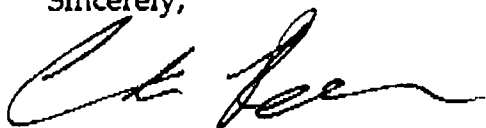

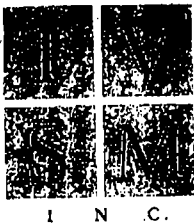

As I've stated in past, this short interview would cover a range of subjects regarding media and its use as a tool of information and education.

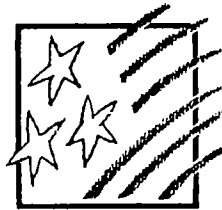

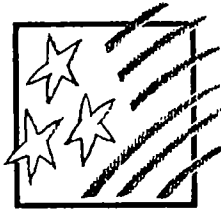
