
Dear Mike:

# Conoco to develop oil in Iran; U.S. officials to scrutinize deal

A major U.S. oil company said yesterday that it had been awarded a contract by Iran to develop a huge offshore oil field in the Persian Gulf, the first energy agreement involving Iran and the United States since Washington severed relations with Tehran in 1980.

U.S. companies are permitted to buy oil from Iran, but they may not resell it in the United States. The contract by Conoco Inc. goes far beyond buying oil to sell to a third party, and the arrangement to develop oil and gas sources in Iran indicates a long-term relationship.

The announcement of the deal came despite growing support in Congress for a bill to impose economic sanctions against Iran. The bill would forbid all economic and financial transactions, banning U.S. companies from buying Iranian oil.

Although the financial details of the Conoco deal were not disclosed, some oil analysts estimated that the project could be worth \$1 billion.

The contract was signed after three years of negotiations, according to Jim Felder, a spokesman for Conoco, which is based in Houston and owned by the chemical giant E.I. du Pont de Nemours & Co., of Wilmington, Del.

Felder said he would be briefing the Clinton administration on the deal in the next few days. He said some officials in Washington knew that Conoco was pursuing it.

Administration officials confirmed that Conoco had informed them that they were planning a deal with Iran and said they planned to meet with Conoco to discuss it. They did not try to hide their displeasure with the agreement, although they were reluctant to criti-

cize it publicly.

Officials said they were seeking more details of the proposed transaction to determine whether it violated prohibitions against providing loans with below-market interest rates or transferring advanced technology that can be used by Iran's military.

Christine Shelly, a State Department spokeswoman, said the administration had sought to exert economic pressure on Iran and had focused on trying to limit arms transfers, government-to-government loans and sales of advanced technologies.

Last year, the Clinton administration protested Iran's membership in an \$8-billion oil consortium of mostly Western companies in Azerbaijan, a former Soviet republic.

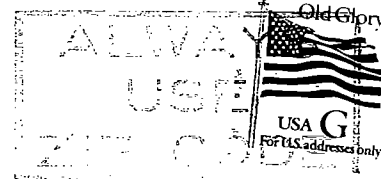

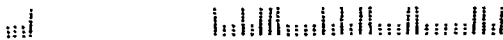

A REPORTER'S DILEMMA

I'm one of the few accredited African Reporters in D.C. for the past 15 years making me perhaps the most visible African journalist. On August 3, 1993, that's 18 months ago I was arrested and charged under the Federal Espionage Act (18 USC 793e) in the District Court, for allegedly being found in possession of State Dept. Classified cables "leaked" to reporters and the public by a govt. employee. The indictment also alleges that I transmitted same information to a fourth party who wasn't entitled to receive such information.

Details of my dilemma are contained in the attached "Summary", "Extreme Prejudice" and "Conclusion" of a 12-page letter addressed to the President and dated February 24, 1995. Like most of my correspondence I'm not sure the letter has reached its destination. For lack of writing materials and xerox facilities, I'm unable to forward a copy of the entire letter to you at this point in time. I do however believe that the enclosed documents provide highlights of my dilemma.

I decided to write to the President because I don't know what else to do as I continue to fight a herculean battle alone except, of course, with God's guidance. I wrote to the President, not to circumvent the Law but to bring to his attention as Father of this Great Nation, the plight of a little one crying in the wilderness for justice

and a fair trial which I'm being refused. I believe the 18 months I have spent in jail without trial haven't served the end of justice and so I plead with the President to effect my release. I also seek the intervention of the services of an independent counsel to investigate the criminal and illegal conducts that have surfaced in this bizarre case of espionage. This include a series of break-ins of my apartment/office without a warrant; the destruction or hiding of vital pieces of evidence and the fabrication, concoction and transplant of others to incriminate me even when I was already chafing in D.C. jail. Also who set up the criminal hoax of espionage against me and why?

At the moment and as the case drags on ad infinitum, I'm in limbo. I'm with no legal representation. Also the nature of my incarceration makes it unable for me to arrange for an independent attorney of my choice. The last Court Appointed Attorney withdrew from the case on February 23 for personal reasons and my plea with the Court to represent myself so as to accelerate the process and get this nightmare behind me, hasn't received any response.

I wrote to the President also because I believe I have been a positive African voice in D.C. I'm perhaps not only the most visible African reporter but also perhaps the most visible community activist of all contemporary African immigrants residing in D.C. whose activities have touched many Washingtonians and those who pass through the Metro Area before August 3, 1993, date of my incarceration. Prominent on the list is the Mayor of the City, Marion Barry who in 1989 personally presented my company, the African Cultural Organization (ACO) in the presence of his former wife Effi and other dignitaries, with a Proclamation of the City at a gala launching our annual events at the Departmental Auditorium. The last African Cultural Festival-ACO organized was attended by among other VIPs (1) Ambassador Herman and Mrs. Cohen, then Assistant Secretary of State for African Affairs under President Bush; (2) Ambassador T. Kalonji of Namibia; (3) Ambassador Paul Pondo of

Cameron, then Dean of the Washington Diplomatic Corps; (4) South Africa Ambassador Harvey and Mrs. Schwarz; (5) Counselor Mrs. Lindvine Audrey Ntlatotsi of the Embassy of Swaziland; and (6) The Cultural Counselor from the Embassy of Jamaica.

As editor of The Continent Newspaper which became the voice of Africans in the USA, I have interviewed such prominent officials as Vice President Dan Quayle after his African tour of late 1991 and retired Chairman of the House African sub-Committee, M. Dymally (D-CA). I have attended numerous press conferences with African leaders including President Mandela of South Africa; Senegal Diop; Zimbabwe Mugabe and Cameroon's Paul Biya.

I'm a Christian (Catholic) originally from Cameroon. I'm 45 years old. I studied at the Johns Hopkins University School of Advanced International Studies (JHU-SAIS) 1980-82 for an MA and Howard University Graduate School of Arts and Sciences, Department of African Studies, for a Ph.D. in 1993. I also have an African, British, and French educational background with certificates from Cambridge and London Universities.


I believe the length of my incarceration hasn't served the end of justice. For example, the community has been deprived of the seasonal employment, entertainment and services provided by my organization. The African/DC Hotline which provided the community with weekly updates of African related activities and events in the area, sponsored by the D.C. Commission for the Arts, Folklore Program, was abruptly shut-down without notice to our over 20 daily listeners. So was The Continent Newspaper. Also postponed was our annual Cultural Festival supported by major Federal and District Arts and Folklore Programs, e.g. The Smithsonian Institution; The National Endowment for the

Arts; and the D.C. Committee to Promote Washington. This event which brings tourists as far away as Africa, Europe and within the USA was suddenly postponed. The occasional employment and exposure provided to, e.g. vendors, models and traditional artists, musicians and dancers were deprived of our annual events. A joint educational program between my organization and the International Monetary Fund (IMF) Visitors' Center entitled, "Monthly African Country Profile" was also suspended despite a successful launching with a profile of ~~Madagascar~~ Madagascar. Furthermore, my scholastic aspiration have suffered. To be left to vegetate in this hole with a Ph.D for 18 months because of a fabricated/concocted criminal scenario, is a terrible tragedy.

Thanks in advanced for presenting my case to the President. I can assure you that my indictment and incarceration for allegedly accepting newsworthy government information leaked to the media and the public by a government employee, is a terrible mistake.

I'm hoping that with your assistance, my freedom will be restored.

WASHINGTON — President Clinton, who as a college student opposed and avoided the war in Vietnam, says he feels vindicated by former Defense Secretary Robert S. McNamara's disclosure that he viewed the war as a terrible mistake.

Asked if he felt vindication from McNamara's new book, Clinton replied, "Yes, I do; I know that sounds self-serving, but I do."

CNN correspondent Wolf Blitzer recounted the conversation, which occurred off-camera Thursday following a taped television interview.

Press secretary Mike McCurry, paraphrasing Clinton's comments, said Friday the president "thought it took a lot of courage to write the book and, on balance, it was a good thing that the former defense secretary had written the book."

"He thought that, on balance, the information in the book and the argument that McNamara makes certainly vindicates the views of millions of Americans, including President Clinton, that the Vietnam War was a sorry episode in American history and that those who opposed the war had good grounds for doing so."

Blitzer said Clinton reminisced about his days as a student at Georgetown University, when he worked for Sen. J. William Fulbright, chairman of the

Senate Foreign Relations Committee. Blitzer said Clinton suggested that his job made him privy to documents about the war and that "he knew more about what was going on than the public really knew at the time."

Clinton, in finding vindication in McNamara's conclusion that the war was a mistake, called attention anew to his own behavior in that period — a matter that came up repeatedly during his election campaign in 1992 and could arise again in 1996, especially if Sen. Bob Dole, a wounded war hero, is his Republican opponent.

In 1969, when Clinton was most vulnerable to being drafted, he, like thousands of other young men, was tormented by the war; he opposed it philosophically and feared its potential impact on his life. While a graduate student at Oxford University in England, he

give up his deferment, Maraniss wrote.

That December, the country switched to a draft lottery and Clinton's birthday drew a high number, making remote the chance that he would be called.

McNamara has come under renewed criticism this week from some who view the war as a mistake. They argue that he should have made his views known while the war was still going on and he might have been able to alter its course.

In an interview Thursday night, McNamara declined to respond to that view. He said he and others in the Johnson administration were influenced by

Secretary of State Dean Rusk's argument that the appearance of appeasement in Vietnam

could invite communist aggression elsewhere, ultimately leading to a third world war.

A woman convicted of welfare fraud is paying back the money she stole from taxpayers — with cash she's again getting from welfare!

"It's absolutely outrageous, but there's nothing in the rules and regulations to prevent it," fumed James Hmurovich, director of Indiana's Division of Family and Children.

## Holy cow! We eat more beef today than 25 years ago

The average American consumes about 209 pounds of meat a year — up 15 pounds since 1970.

But chicken consumption has increased too, from 37 pounds a year in 1962 to 70 pounds in 1994. So Americans may be substituting lower-in-fat chicken for red meat, reports the newsletter Health and You.

And the woman herself, 39-year-old Kathy McCutcheon, admitted to The ENQUIRER: "It's not right, is it? But that's the way they've set up the system, so why shouldn't I take advantage of it?"

McCutcheon, of Mooresville, Ind., applied for welfare in 1991, saying her husband was gone and she had five children to support.

But after she'd received nearly \$10,000 in benefits, officials discovered she'd lied — her husband was living with her and had a job in a local factory.

In March 1993 McCutcheon

pleaded guilty to welfare fraud. She was sentenced to a year in jail and ordered to pay back \$9,366.

The cheat spent 60 days in the slammer and served the rest of her sentence in home detention. She was required to remain at home except for attending approved activities —

and was ordered by the court to find work. McCutcheon got a job as a restaurant cashier.

But in July 1994 — just one week after her detention ended — she quit her job, claiming she was suffering from depression and anxiety.

Her brazenly applied for welfare again for herself

and her five children, aged 10 to 17. And she got it!

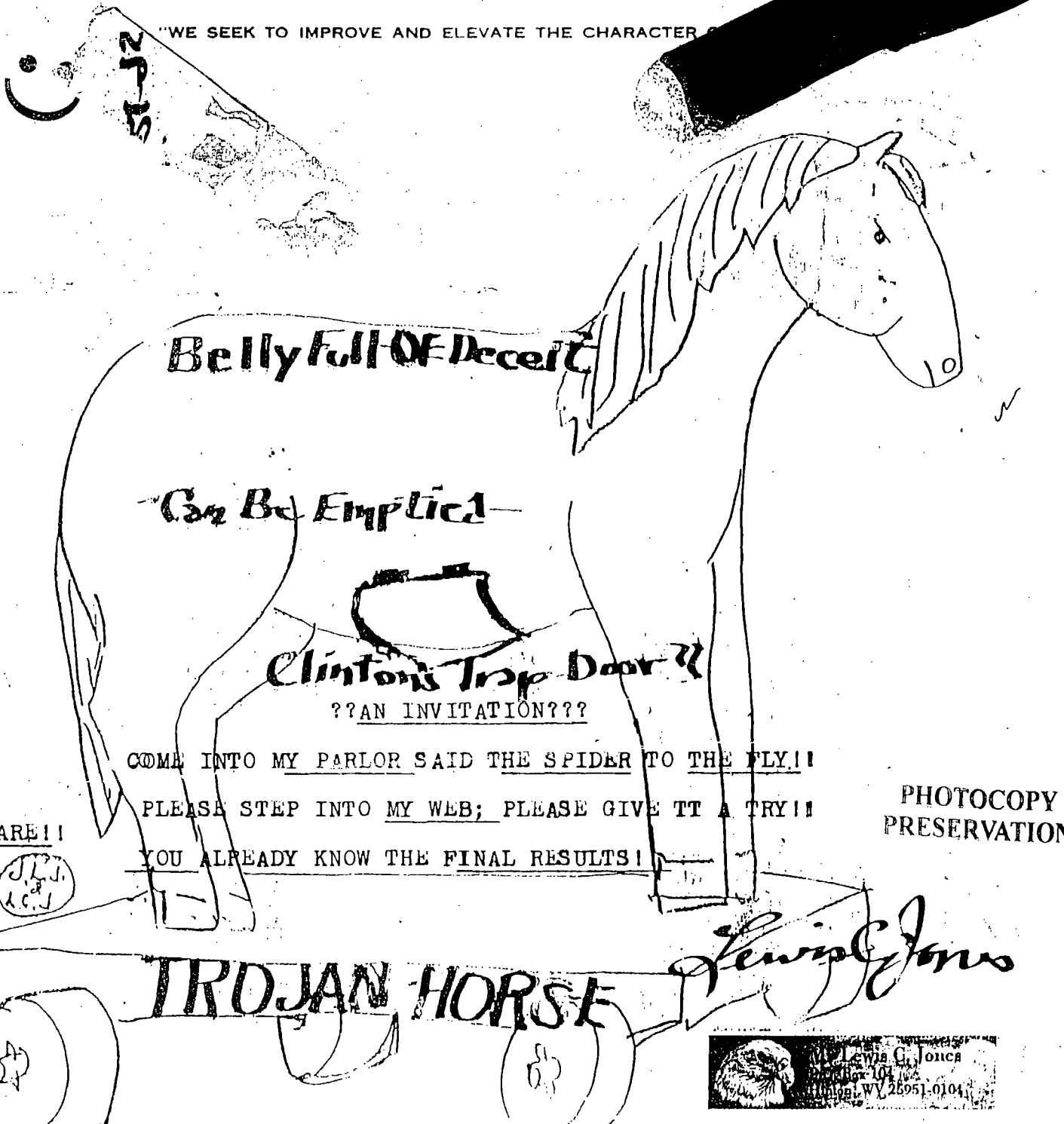

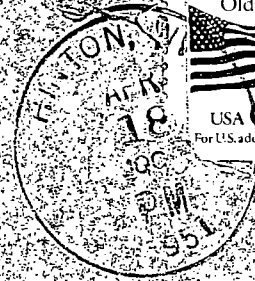

# Some black leaders spout vile racism

A couple of weeks ago I wrote a column cautioning that blacks are the last people who should indulge in the type of bigotry and hate-mongering that's speculated to be at the root of the arson attack on Freddy's Fashion Mart in Harlem.

The perpetrator, apparently, was a black man who, along with seven innocent people, died in the fire he set. Prior to this tragedy black community leaders had led protests against the Jewish-owned store.

I saw a direct link between the hateful rhetoric against Freddy's owner — who was characterized by African-American activist Al Sharpton as a Jewish interloper on Harlem's 125th Street — and the actions of this black man. He was one of many street vendors banned earlier in the year from 125th Street for not paying taxes.

My comments resulted in an invitation to talk about hate speech on PBS-TV's "The News Hour with Jim Lehrer." Others on the panel were Judge Robert H. Bork, Nadine Strossen, president of the American Civil Liberties Union, and Wilbert Tatum, publisher and editor-in-chief of New York's Amsterdam News, an African-American community newspaper.

Strossen and Tatum espoused the epitome of white and black liberal dogma. After encountering them I have concluded that they are in complete denial about a very dangerous force of evil in America today.

When asked whether he thought the anti-white and anti-Jewish rhetoric of Sharpton and Morris Powell, another local African-American activist, had any impact on the attack on Freddy's, Tatum replied flatly, "no."

Tatum then tried to reduce the incident to little more than a landlord-tenant dispute that got out of hand.

How then, pray tell, did a black street vendor get embroiled in the controversy?

According to Tatum, it was Mayor Rudolph Giuliani's fault.

He said it was the mayor's decree to remove the illegal vendors from 125th Street which impelled this demented man's deadly actions. I wonder why he didn't burn down the mayor's mansion then.

Strossen pushed liberal permissiveness to the limit in her exchanges of legalese with Bork. According to her, yes, the hate speech leading up to the Freddy's blaze was abominable, but we cannot be sure it caused the incident, so it is protected by the Constitution.

African-American leaders rant and rave and spout anti-Semitism and white racism in front of a Jewish-owned establishment. A black man, who apparently believes his oppression is fostered by this Jewish merchant's success, burns the place down.

Is it not common sense that one act leads to another?

I said on the TV show and I will repeat it here: The good people of America are being encouraged by black apologists and white liberals to bury their heads in the sand while the expanse between blacks and whites, and Christians and Jews in this country is being exploited by self-serving African Americans.

Eight people are dead in Harlem because men such as Sharpton declared open season on Jews. What happened was ugly, hideous and shameful.

But like the German people who tried to absolve themselves of responsibility for the atrocities against Jews in Hitler's Germany, African Americans in Harlem are

doing everything in their power to disavow themselves from having ignited the fever of the mob.

Here's how I answered them on Lehrer's news broadcast:

"Won't we ever step up to the podium and take responsibility for our actions? I'm talking not just about the black community, but also about the media and all Americans black and white who accept this type of rabble-rousing by a select group of black people going back as far as the Korean merchant situation in Brooklyn. We have allowed a precedent of accepting this kind of hateful rhetoric to be established.

"The liberals and the black apologists can try to scrub it up, try to deny it, all they want.

"But the bottom line is that a monster of anti-Semitism and racial hatred is growing in this country. Mindless black people were led to stand up in broad daylight on 125th Street in Harlem against some mythological encroachment of the infamous Jew. And the result was death in the heart of New York City.

"We have pogroms being committed again — this time in the United States of America. And they are not being committed by white Aryan, goose-stepping Nazis.

"This time, they are being committed by the sons of former slaves who should know better than most what racism and bigotry and hatred has wrought against us as a people. The people who will not speak out against this are nothing more than apologists and I will not let them off the hook.

"Deny it all you want. But unless we dig our heels in now and say no, we are going to be a country torn asunder."

# Freddy's Desperate Call for Legal Help

The following are excerpts from affidavits given in support of the attempt by the owner of Freddy's in New York Supreme Court to get a restraining order against protesters outside the store. Mr. Brunner died in the attack.

## KAREEM BRUNNER

I am a black security guard, who has been employed by corporate plaintiff since July 1, 1995. ...

Defendants have been "protesting" outside of my employer's premises since November 25, 1995 and on a daily basis. At any time the following remarks were made by them and which I personally heard:

a. "Kill the crackers" (meaning white people);

b. "Get the Jew bastards" (the president of corporate plaintiff, Fred Harari is Jewish);

c. "Burn the place down" meaning the store;

d. "This block for blacks only, get the Jew owners out."

On November 29, 1995 the conduct escalated and I ... filed a complaint.

I repeated what I had heard that morning which had convinced me that the problem was not going to subside, but instead would escalate, namely that the protestors were threatening all white people, calling them "crackers" and that they were going to get "20 more niggers to loot and set fire to the merchandise both inside and outside the store." They then screamed out that the windows of the store "looked expensive, about a thousand apiece, and we will smash each one of them."

After I gave the report to the police they then came back to the store with me to see firsthand what was going on. They then erected a police barricade of approximately five feet from the store entrance through the use of wooden saw-horses. Even this was not enough, and the police threatened some of the protestors with arrest if they did not demonstrate peacefully. However, whenever the police left, the protestors continued to ignore the "wooden horses" the police had erected in the front of the store, threatening customers up close and personal.

I took these threats as directed against me personally also. I was told by them many times that I was a "cracker lover" and "would get mine as a traitor" (to the black race). One of the police officers asked the manager of corporate plaintiff if he wanted the police to give "DATs" ("desk appearance tickets) to the protestors since they did not have a permit,

were inciting a riot, disturbing the peace, and otherwise acting disorderly. Plaintiff declined, fearful that would only cause more problems and instead decided to proceed through civil avenues instead of criminal ones.

Customers who came to the store, especially black customers, were likewise told they "would get theirs" for being "cracker lovers" or "traitors." I saw some customers then turn and leave, before even entering the store, as soon as they heard these threats.

I have tried to reassure the customers that the "demonstrators" in front of the business premises held no harm for them, and that the police were nearby if any problems arose, but this failed to work for the most part. While this worked for some of the customers, many of them did not want to get involved and instead simply turned and walked away from the business when the threats were hurled at them.

Late last week a hidden camera with audio was placed over the entrance to the store by the store, upon advice of both our counsel and the police. On Saturday, the Bias Squad came to the business and took the Friday tape that had been made.

I have not reviewed the tape from Friday, but have reviewed one of the tapes from Saturday. On the Saturday tape you can clearly see one of the protestors gesturing as if he was striking a match and throwing it at the store. I have seen that same protestor do similar acts myself, but scream "burn Cracker burn" when doing it.

...The acts of defendants are serious and could escalate into a riot at any time.

## STEVE BRODSKY

I am one of the managers of corporate plaintiff above named.

Tuesday, November 27, 1995

I was in the lobby section of the store, assisting a customer when one of the extremely vocal male demonstrators who calls himself "Shabazz" started ranting and raving at her screaming, "Don't shop at Freddy's. Don't give the [expletive] Jew Bastard one dime, he doesn't have no respect for black women."

When I asked him why he was using racial threats in an obviously polarized neighborhood, he confronted me, up front and threatening and stated "go [expletive] yourself white boy, you fat bastard."

Due to the proximity of Shabazz to me, and his physical size, I felt

extremely threatened and broke off any further encounter between us. I verily believed that Shabazz was on the verge of a physical attack upon my person if I had persisted to question him about what he was doing.

Wednesday, November 28, 1995

At about 3 p.m. I was standing in front of the store attempting to greet customers and alleviate the effects of the boycott. Again Shabazz confront-

ed each customer with his own greeting that they should "go in the store now because next week they won't be there" while making a motion of striking a match and throwing it into the store. This physical expression was repeated daily at one time or another by Shabazz and sometimes others of the demonstrators. On this one occasion, however, Shabazz forced his way into the store itself, physically brushing me aside, and proceeded to shout that "I will be back to burn the Jew store down, burn, burn, burn."

Thursday, November 28, 1995

While I was accepting a delivery from United Parcel Service, a male who said he was Morris Powell ... started pacing back and forth in front of Freddy's. He then proceeded to unleash a tirade of racial epithets at the pedestrians on the block, screaming:

"Keep right on by Freddy's, he's one of the greedy Jew Bastards killing our people. Don't give the Jew a dime. ...[Expletive] the Jews."

These phrases were then repeated almost in chant-like fashion over the next few days by the other demonstrators, the main theme being that Freddy is a Jewish-owned store that the black community should drive out of its neighborhood, and if need be, burn out if it did not voluntarily shut down.

Sunday, December 2, 1995

At about 2:30 p.m., defendant Shange and Powell started picketing in front of Freddy's yelling "Boycott, Boycott — if a black store came to a Jewish neighborhood the JDL (Jewish Defense League) would burn them out, do the same here, don't be scared." Both of them then started to scream that the black church (our landlord) was an Uncle Tom and that

they will burn with Freddy's." Shange then told me he would go to Freddy's other location at Third Avenue and Fordham Road to picket there also.

## FRED HARARI

I am both the president of corporate plaintiff and the individual named plaintiff.

I must first give to the Court a brief history of the events that led up to this application. ... Last summer I informed Defendant Shange that I would not be renewing his sublease which is scheduled to expire on December 31, 1995, since I was going to expand Freddy's Clothing store into the space he had subleased, as well as that of another store abutting mine. Defendant Shange threatened me, hired some people to picket at that time, and stopped his rent payments.

At the same time I approached my landlord, the United Houses of Prayer for all People, and asked if they could relocate Defendant Shange to another store on the block. The Church agreed and even went so far as to prepare a lease for the corner store, but, they demanded to put in the lease that Mr. Shange was a probationary tenant for the first year of his lease due to his prior boycotting of my store. ...

Defendant Shange has refused to accept any of these alternative arrangements, and has instead on or about November 25, 1995, commenced a boycott of Freddy's, threatening me with loss of my holiday sales.

The "demonstrations" have harassed my customers as well as potential customers, have been vulgar, obscene, and always menacing. There have been instances where the store entrance has been physically blocked to customers by some of the protestors.

In this case, however, the demonstrators have been ensuring the success of their "boycott" through continuing harassment, the threat of physical assault and, threats of arson to burn down my store. These latest threats of arson have caused my employees to be ever vigilant and is placed them in fear of their lives.

The demonstrators have even recently threatened to burn down or blow up my business.
