# Unsolicited Advice From an Erstwhile Consultant

*Clinton Should Stay on Domestic Issues and Above Fray, Morris Volunteers*

In the weeks since political guru Dick Morris departed President Clinton's reelection campaign, Clinton has been off-stride. He's been talking too much about foreign policy, and he's been making the mistake of responding to Republican nominee Robert J. Dole's charges instead of gliding above them.

Who says? None other than Morris, who left the team three weeks ago after published reports that he had a year-long relationship with a \$200-an-hour call girl and let her listen in on phone calls with the president.

Clinton used to pay handsomely to hear Morris's insights and criticism, but now he can get them for free. The consultant has joined the ranks of experts commenting on the campaign.

That's a crowded field, to be sure. But no one else has quite the vantage point of Morris, who almost never talked to reporters on the record when he was enmeshed in every important decision on the direction of the campaign, and many decisions about the direction of the government. And no ordinary pundit has Morris's ability to set stomachs churning inside the Clinton camp.

But no one should be surprised. After Morris hastily resigned as Clinton's strategist last month, he signaled his availability to news organizations to comment on this year's election scene. When a Washington Post reporter called to chat late Wednesday afternoon, Morris offered a detailed critique of where his former boss is falling short.

Clinton has been "too focused on

foreign policy," Morris said, "and he needs to move back to domestic."

Another blunder: "He is getting absorbed in the daily give and take of campaign rhetoric" when he should be assuming a presidential pose, leaving it to TV commercials to respond to Dole's charges. Clinton's speeches should be devoted to "laying out a positive agenda," he said.

Most voters assume Clinton is go-

ing to win reelection, Morris reasoned. His goal should be to "give Americans something to be interested in other than the election." The way to do that, he offered, is to create a "sense of excitement" by talking about policies, just like in last January's State of the Union address—a speech, not coincidentally, that heavily reflected Morris's hand.

Clinton aides were plainly less than ecstatic to learn of their former colleague's emergence as a sideline critic, but struck a pose of weary nonchalance.

White House deputy chief of staff Harold Ickes, who clashed often with Morris, noted that the campaign's polling numbers are as good as or better than they were when Morris left. "I'm not sure the basis for the sour grapes," he said.

"News organizations will take his commentary with whatever grain of

salt they choose to pour," White House press secretary Michael McCurry said yesterday.

"My guess is that this is just Washington withdrawal symptoms," said James Carville, the strategist for Clinton's 1992 campaign and an informal adviser now. Offering views to reporters that he once gave the president, Carville said, "is the political equivalent of methadone."

Carville made publicly the point that other administration advisers expressed privately: The fact that Clinton is spending a lot of time talking about Iraq lately is not exactly a matter of campaign strategy. "It's kind of hard to commit American troops and launch American missiles," Carville said, "and not talk about foreign policy."

While Clinton hasn't engaged in anything like a point-by-point exchange with Dole over drugs, he has spoken out on the issue in remarks plainly aimed at rebutting the Republican's accusations that Clinton has taken a lax attitude toward drugs, and that this is responsible for statistics showing a marked increase in teenage drug use. By seeking to rebut the criticism, Morris said, Clinton is only calling attention to it.

Since his consulting career came to grief in the pages of the Star, a tabloid newspaper, Morris has repaired to his home in Connecticut and is busy working on his book, which is to come out after the election. He said he has no idea what the thinking is behind Clinton's recent moves because he is not talking with anyone on his team.

That's fine by the White House. McCurry said White House Chief of Staff Leon E. Panetta directed that staff members not communicate with Morris.

We would encourage them each to choose their own program title and write their own topic description for conference advertising.

CALPELRA would offer each speaker a \$1,500 honorarium. CALPELRA would also pay for both speakers' round trip air tickets, their meals, and their accommodations.

CALPELRA is a professional non-profit California association established in 1975, comprised of public sector management representatives responsible for their organizations' labor relations programs. CALPELRA members are the people who hire, train, discipline, and dismiss employees for their organizations. They participate in labor negotiations and collectively contribute to the health of labor relations throughout California. CALPELRA is formally affiliated with the National Public Employer Labor Relations Association ("NPELRA"). CALPELRA produces its largest annual conference during early November in Monterey, California. More than 450 members from all over California attend these conferences. A

## CALPELRA Membership Categories

- **Active** — Open to the person employed by the State of California, county or municipal governments, school districts, or special districts on a full-time basis, to whom is assigned a primary function and responsibility for the jurisdiction's labor relations activity. Active members shall have full voting privileges.
- **Associate** — Open to persons employed by the state, county or municipal governments, school districts, or special districts on a full-time basis, to whom is assigned a support function or subordinate responsibility for the jurisdictions labor relations activity, and at least one active membership has already been issued to the agency. Associate members shall have no voting privileges.
- **Affiliate** — Open to law firms, consulting firms, or persons retained by the state, county or municipal government, school district, or special districts to represent management interests *exclusively* in the area of labor relations. This type of membership is a firm membership and not an individual membership. Affiliate members shall be entitled to one vote per firm. They shall not be eligible to serve as an officer or member of the Board of Directors.

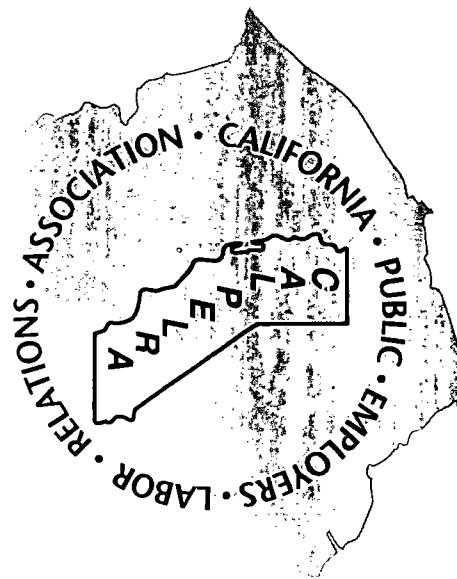
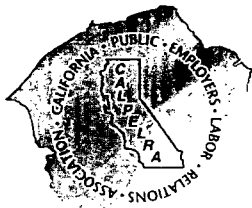

## Why is no one checking these suspicious deaths?

IT APPEARS being connected with Bill Clinton may be hazardous to your health.

According to a letter to Congress written by former Rep. William Dannemeyer, between July 1992 and June 1994, 24 people linked to the president died in unnatural circumstances, including White House Counsel Vince Foster. Fifteen of these deaths occurred in 1993, the first year of the Clinton presidency.

Among the deceased are eight former bodyguards and Larry Parks, head of Governor Clinton's security team in Little Rock, Ark.

Seven of the dead served in Clinton's presidential campaign, most of them involved with campaign finances. Three were investigators into irregularities during Clinton's Arkansas governorship.

Two were advisers to Hillary's health-care task force. One was a former business associate of Mack McLarty, then Clinton White House chief of staff.

Kathy Ferguson, ex-wife of "Troopergate" figure Danny Ferguson, was shot in the head in May 1994. Her boyfriend, Bill Shelton, met the same fate 29 days later.

Nine of these people were killed by gunshots. Light aircraft accidents accounted for nine more (the plane carrying Herschell Friday, a member of the Presidential Finance Committee, exploded in mid-air).

An auto accident and a skiing accident claimed one person each. Jon Walker, RTC White-water investigator, fell off a 22-story building in August 1993.

Cause of death is a mystery in three cases, including Paul Tully, Democratic National Committee political director. His body was found in a Little Rock hotel during the 1992 campaign.

This is an astonishing string of events. Even more amazing is the fact that the American press has shown so little curiosity about them.

# Stockdale Says War Protesters

## Such as Clinton Cost Lives

Those comrades of mine that died - the extra 10, 15, 20 thousand - that blood is on your hands, you war protesters," Stockdale said in an interview published yesterday by the Idaho Statesman in Boise. "You bring it out."

Stockdale, a bomber pilot in the war, was held prisoner for eight years, including four in solitary confinement.

Clinton, the Democratic presidential nominee, has said that he strongly opposed the war and took part in several protests against it, including organizing a teach-in while a student in England.

Stockdale said in the interview, "we would hear that they had one of these big galas of the sort that Clinton was arranging here and there in the world. 'Huh,' we'd say. 'Another year in this place. We're not going to get out of here until we bomb Hanoi.' And they couldn't do that until they beat that opposition down."

The United States bombed Hanoi for two weeks beginning in December 1972 to bring North Vietnam to peace talks. After the peace accord was signed, the last U.S. forces left South Vietnam in 1973, and South Vietnam surrendered to the Communists.

Asked whether Stockdale was speaking for Perot campaign spokeswoman Sharon Holman said only that the comments reflected Stockdale's views. "As a former POW, he would feel strongly about anti-war protest," she said.

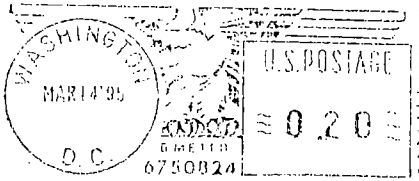
Call your congressman and ask for a copy of the bill. It is really easy to check the facts and it is necessary because the media are not doing any checking on anything.

(Washington, D.C.) - A decision is expected soon in the appeal of a Freedom of Information Act lawsuit against the U.S. Central Intelligence Agency for the release of over 200 documents on Unidentified Flying Objects.

The legal effort is being pressed by Ground Saucer Watch, Inc. of Arizona and Citizens Against UFO Secrecy, a Washington-area public interest organization.

The organizations are appealing a Federal District Court decision which allows the agency to keep over 200 pages of UFO documents secret. A hearing in the appeal took place on May 1 in the U.S. Court of Appeals in Washington.

Part of the cost of the litigation was provided by the Fund for UFO Research, Inc., a scientific, nonprofit organization which channels public contributions into UFO research and education projects.

"Organizers of the Fund await the court's decision with extreme interest", says Chairman Bruce Maccabee, a physicist.

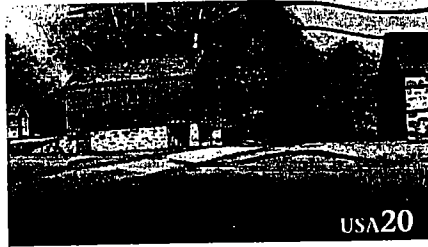

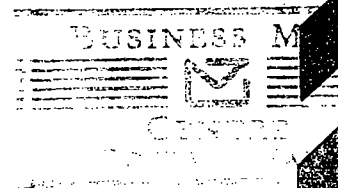

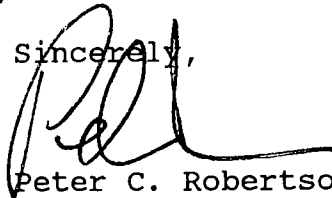

President Clinton will deliver the Liz Sutherland Distinguished Lecture at The University of Texas at Austin next Monday. The National Issues Convention and the prospect of the President's endorsement and attendance are very big things in Austin. It is my bet that he'll get questions on the event while here.

I know that the President is not yet an official candidate, but it seems to me that he could do both himself and the event a great deal of good by lauding the effort, including the quality of the organizers (MacNeil-Lehrer, etc.), and how it is definitely a solid step toward the civilized, informed discourse he advocated in his Georgetown speech last summer.

As to his attendance, why not say that if he does become a candidate, he would certainly want to attend this pathbreaking event but it is too early to make specific commitments. He will, however, block that date out on his calendar on the assumption that things will work out positively.

Mack, I'm bothering you too often on this, but it will help us greatly to have the President all but committed next Monday, especially in nailing down the many PBS stations which we hope will carry the 11 hours of network time devoted to NIC. I see no downside for the President but a big upside for the event and, in fact, a pretty good upside for him.

I am in Austin this week at 512-261-6485. Can someone call me on this? Incidentally, our old friend, Rich Oppel, formerly of Knight-Ridder in Washington, is now editor of the *Austin American-Statesman* and would provide an excellent avenue for bringing the President's views on NIC to the public.
