- o As you know, we agreed in Geneva to hold experts-level meetings on three topics before another round of U.S.-DPRK talks.
 - o Let me briefly review our understanding of the expert meetings we will need to hold.
 - o One expert-level meeting will address technical issues involved in establishing representation in each other's capitals. Specifically, this group would explore the issues involved with the establishment of liaison offices.
- As an initial step, we are prepared to send a U.S. team to Pyongyang to start these discussions.
- o A second expert-level group would deal with energy issues, specifically, the replacement of your graphite-moderated reactors with light water-reactors and the provision of interim energy alternatives.
 - o We would like to invite a team of your experts to the United States for those discussions. As part of that visit, we are prepared to offer familiarization visits to U.S. light-water reactor facilities for your experts.
 - o We would also like to discuss U.S. laws and regulations covering peaceful nuclear cooperation, the regulatory environment we have established for the safe operation of LWRs, our thinking on the LWR package, and interim energy arrangements.
 - o We suggest that the experts' talks on interim energy supply be convened on the margins of the DPRK side's visit to Washington to discuss the LWR project and to tour a nuclear power plant.
 - o We think it important that the counterpart group on the DPRK side also include officials who are expert in non-nuclear energy technologies.
 - o Third, we agreed in Geneva that experts would discuss the safe storage and disposition of spent fuel. Pending agreement on more permanent arrangements for that spent fuel, we would like to send a team of experts to visit North Korea to discuss extending the lifetime of the spent fuel rods in wet storage.
 - o We believe that, working with your experts, such a team could provide you with valuable assistance in ensuring that those rods do not present a safety/radiological hazard while they are in wet storage.

- o On timing of these experts meetings, we would like to propose the week of September 5. We believe that it is important to hold these discussions at least a few weeks before we resume talks September 23. That will allow sufficient time so the results of the experts discussions can be considered in Geneva.
- o I would emphasize that, from our perspective, all of these experts teams will deal only with their specific technical issues. They will not be authorized to hold further discussions on resolving the nuclear issue or other issues of concern to our governments. Those discussions will be held at our next round of talks beginning September 23.
