This responds to your inquiry dated September 17, 1996, concerning the status of individuals listed on several attachments to your memo.

We have researched those lists against our data base, against records at the PBS White House Field Office, and against the personal recollection of key employees at the Field Office. Based on that analysis, we have learned that most of the individuals listed are current or former GSA employees. Some are employees of GSA contractors. Others, based on personal recollection, have a past relationship with us, and still others are unknown and unlisted in any of our records.

Each of the employees on the lists you provided is represented in the attachment according to his or her status as we were able to make a determination.

For purposes of clarification, one listed individual, Patricia Kristeen Ballard, has changed her name to Ludlow. Other names on the list have minor spelling differences in our data base but, in all cases, social security numbers match.

I hope this information is helpful. Please call me if we may be of further assistance.

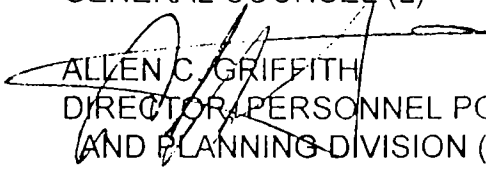

Based on that analysis, we have learned that most of the individuals listed are current or former GSA employees. Some are employees of GSA contractors. Others, based on personal recollection, have a past relationship with us, and still others are unknown and unlisted in any of our records.

Each of the employees on the lists you provided is represented in the attachment according to his or her status as we were able to make a determination.

For purposes of clarification, one listed individual, Patricia Kristeen Ballard, has changed her name to Ludlow. Other names on the list have minor spelling differences in our data base but, in all cases, social security numbers match.

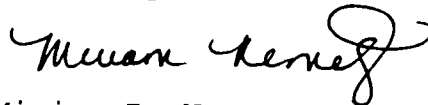
