SUBJECT: ADA meeting

Harold (according to Amu Issacs of the ADA) agreed to address their national board meeting on January 6, 1996, at 10am. It's at the Washington Court Hotel at 525 New Jersey Ave.

They are sending me an agenda, which I will copy you guys on, so you can see who is going before and after him. Either Jack Sheinkman or Henry Berger will introduce Harold. He is expected to give the pitch for the President.

This should consist of three things:

1. Historic references to the role of the ADA and its importance as a unwaveringly progressive yet practical organization. Ann Lewis is putting together 2-3 bullets on this -- things like the ADA was founded because Eleoanor Roosevelt and Walter Reuther knew that the post world war world needed a visionary progressive and also practical (read -- anti-communist) organization. Also, Arthur Schlessinger and John Kenneth Galbraith appealed to the ADA in 1960, speaking out for Kennedy. Etc -- Ann knows this history and I most certainly do not. If you don't see these bullets by Jan 3, call her. I'll get them to you if she gets them here before the weekend.
2. Harold's pitch that he can do in his sleep about how this election is the most important in his lifetime, and the accomplishments of POTUS and the contrasts with the Republicans.
3. A pitch for the importance of the labor/progressive alliance. Lots of labor leaders are on the board and labor types will be in the audience. I will send over a few bullets on our labor accomplishments so H can talk about Clinton's labor alliance over the past 3 years, and why it needs to continue.

That's it.

After he's done, someone will formally nominate the President. Harold is going to talk to Cong. Barney Frank about doing it when he sees him tomorrow. You don't need to worry about this.



The Bylaws of Americans for Democratic Action, Inc.

These Bylaws are part and parcel of the Constitution of Americans for Democratic Action, Inc.

Article V
Endorsement of Candidates for President and
Vice President of the United States

Section 2: The rules that will apply at a National Board meeting or convention at which the endorsement of a presidential candidate is considered shall be in accordance with following:

- a) The chair shall establish time limits on debate and nominating speeches.
- b) Nominations may be made from the floor by any member present.
- c) A three-fifths (3/5) affirmative vote by those present and voting shall be required for an endorsement.
- d) All votes must be cast in person.
- e) Fractions shall be rounded down to the nearest whole number.
- f) If on any ballot no candidate receives 60 percent or more of the vote, on each subsequent ballot, the lowest vote-getter shall be removed from consideration, provided that at least two candidates remain.
- g) If the balloting has been narrowed down to two candidates and neither candidate receives 60% or more of the vote in three (3) successive ballots, there shall be no endorsement.
- h) Votes for "no endorsement" shall be counted in every round against the total number of votes from which the 60% is counted.
