Dear Mr. President:

Ms. Elsa Riano, a constituent of my Congressional district, has contacted my office regarding her brother, Gustavo L. Riano, who is being held in Guantanamo Bay Naval Base.

Ms. Riano states that her brother was a Lieutenant Colonel with the Cuban Armed Forces and, if he is returned to Cuba to wait for a visa to enter the United States, a firing squad awaits him.

Ms. Riano respectfully urges that an immediate visa be issued for him to enter the United States. Aside from the humanitarian reasons for his visa, Col. Riano may provide the United States with military information regarding the morale and mood of the Cuban military, which may well be the moving force for any future change in Cuba.
