RE: REQUEST FOR POLICE PROTECTION/KKK PROTEST

Dear Mr. President Elect:

Mr. John Varela of the Ku Klux Klan (KKK) has been issued a conditional permit to hold a KKK "protest" at the East Ventura County Courthouse in Simi Valley on February 20, 1993. In light of the counter-demonstrator violence at two white supremacist events in Simi Valley last year, there is a paramount need for police protection beyond the capabilities of the Simi Valley Police Department.

Accordingly, to ensure Mr. Varela's Federal and State Constitutional Rights, we must receive outside police assistance from those levels of government which are responsible for assuring those rights; thus this letter to you.

Please inform us not later than Monday, February 15, 1993, of the Federal Government's ability and commitment to provide Mr. Varela police protection to ensure the safety of the public generally as well as his safety and the exercise of his Federal and State Constitutional Rights.
