WE HAVE LEARNT WITH DEEP SORROW OF THE SHOOTING
INCIDENT AT THE COLUMBINE HIGH SCHOOL WHICH OCCURRED
YESTERDAY.

IN THE AFTERMATH OF THIS GREAT LOSS OF INNOCENT
LIVES, THE GOVERNMENT AND PEOPLE OF SEYCHELLES JOIN
ME IN EXPRESSING TO YOU, THE GOVERNMENT, THE PEOPLE
OF THE UNITED STATES OF AMERICA AND THE FAMILIES OF
THE VICTIMS, OUR PROFOUND SADNESS AND HEARTFELT
CONDOLENCES.

PLEASE ACCEPT, EXCELLENCY, THE ASSURANCES OF MY
HIGHEST CONSIDERATION.
