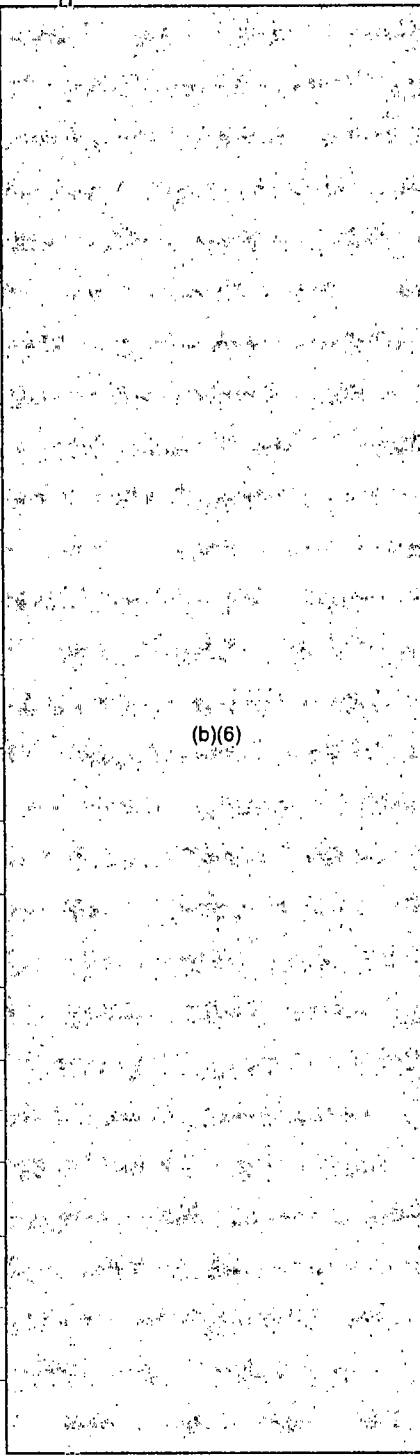

More children and families are benefiting from Smart Start now than ever before and parents have more choices today in the quality of care they choose for their children than when Smart Start began, according to the latest Smart Start quarterly report.

In fact, below are the latest results since Smart Start began:

- Early intervention/preventive screenings: 206,659
- Children in child care programs with quality enhancements: 190,961
- Parents receiving parent and health education: 135,139
- New child care spaces created: 40,855
- Children receiving subsidies: 82,352
- Volunteer hours: more than \$1 million
- Private contributions: more than \$70 million
