First lady's top aide accepted donation

WASHINGTON — The White House acknowledged Wednesday that first lady Hillary Rodham Clinton's chief of staff accepted a \$50,000 campaign contribution from a Taiwanese-American under investigation for his campaign donations.

The chief of staff, Maggie Williams, accepted the check from California businessman Johnny Chung in the White House, perhaps after Chung had his picture taken with Hillary Clinton.

Chung's contribution to the Democratic National Committee was later returned because of concerns about its legality.

Williams' acceptance of a campaign donation could increase pressure on Attorney General Janet Reno to recommend an independent counsel be appointed to investigate the mushrooming campaign finance controversy.

Although the White House defended Williams' action as legal, federal employees are typically warned never to accept or solicit campaign contributions.

Indeed, former White House counsel Abner Mikva, a former

federal judge, issued a memo to White House employees in April 1995 saying they could not "ever knowingly solicit, accept or receive a political contribution from any person."

Such contributions, he wrote, should be taken to one particular employee on the White House complex.

White House spokeswoman Ann Lewis defended Williams, contending that because she turned the check over to the Democratic National Committee her actions were lawful.

Lewis said the Hatch Act, which prohibits federal employees from engaging in a number of political activities, draws a distinction between "receiving" a contribution and "handling" one. "This," Lewis said, "is handling."

Williams' acceptance of a campaign contribution is just the latest in a series of recent revelations. A number of members of Congress have called on Reno to appoint a special prosecutor to investigate allegations that include Vice President Gore's use of White House telephones to solicit contributions.

# Bill should nix pardon and let Hillary face music: poll

By a 4-1 margin Americans think President Clinton should not pardon his wife Hillary if she is indicted in the Whitewater scandal, a new poll has found.

On another controversial issue, a majority of those surveyed think the president is lying about the Filagate scandal.

The Fox Sunday News/Opinion Dynamics poll of 914 likely voters found them strongly opposed to any presidential pardons for Clinton associates in the scandal over the failed real estate venture.

Only 9 percent of those surveyed believe Clinton should pardon anyone involved in Whitewater, compared with 75 percent who are opposed to pardons.

The remaining 16 percent were unsure. The poll has a margin of error of 3 percent.

Asked whether Hillary should be pardoned if indicted, 66 percent were opposed and 16 percent were in favor. Another 18 percent were not sure.

Mrs. Clinton is believed to be under investigation for her legal work on a sham real estate deal, her role in the purge of White House Travel Office employees and the search of White House lawyer Vince Foster's office after his suicide.

So far, three Clinton associates, former Arkansas governor Jim Guy Tucker, James McDougal and his ex-wife Susan, have been convicted of Whitewater-related crimes.

In the course of the Whitewater probe, another Clinton insider, former Justice Department official Webster Hubbell, was convicted of bilking law firm clients.

This week White House lawyer I. Sherburne

predicted new indictments in February, after James McDougal is finished cooperating with independent counsel Kenneth Starr. She later said her comments were taken out of context.

Among those mentioned as possible targets of the special prosecutor are Mrs. Clinton, her chief of staff Maggie Williams, former White House counsel Bernard Nussbaum, senior Clinton aides Bruce Lindsey and David Watkins, and Craig Livingstone, the former White House chief

of security being probed in the Filagate scandal.

Americans also told the pollsters they were concerned about Filagate and don't believe Clinton is telling the truth about it.

Clinton has said he did not read the 900 confidential FBI background files the White House staff improperly obtained on former Reagan and Bush Administration officials and others.

But 69 percent of those polled think the president is lying about reading the

files, compared with only 13 percent who believe he is telling the truth.

Asked how significant Filagate is to them, 32 percent of those surveyed said "very important."

Another 19 percent called it "important" and 23 percent said "only somewhat important."

Twenty percent called it "unimportant" according to the poll, whose results will be reported at 9 a.m. tomorrow on Ch. 5/WNYW. The remaining 6 percent were unsure.

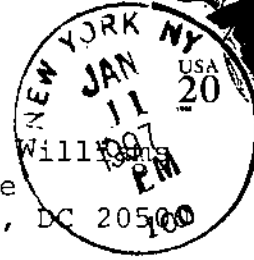

# Your own Lincoln Bedroom

Mr. Answer Man, what's all this fuss about the Lincoln Bedroom?

**T**he Lincoln Bedroom is a national treasure, but the room has been an underutilized, poorly performing asset for years. The Clintons, thank goodness, are running it efficiently. In only 1,500 days, people who stayed in the Lincoln and other guest rooms paid \$10 million, or almost \$7,000 per night, including all those off-days when they weren't able to rent any space. Why, right across the street the Hay-Adams is only getting \$300 or \$400 per night, so you can readily see what they achieved.

I guess it's OK, if they don't go any further with this.

Oh, but they must. The next logical step is to exploit brand-name recognition by franchising the product. Motels around the country could build replica Lincoln Bedrooms, bringing that White House experience to the masses at affordable rates. Maybe they could get Johnny Chung to hang around a lot, just like at the real White House, and a cat that looks like Socks could roam the halls. "Think Lincoln" would be the ad campaign and President Clinton could do commercials, saying, "We're ready to start your overnights right away!" Imagine, tens of thousands of people phoning home every night saying, "Mom, you'll never guess where I'm staying."

But—

In the morning, they could get a cup of real Clinton coffee for only \$10 or \$20. At the real White House, getting caffeinated like that by the president could run you \$50,000 or so.

Mr. Answer Man, what is the exact function of Johnny Chung?

Here's a guy who managed to talk his way into the White House 49 times, even though a National Security Council official said he was exploiting his friendship with the Clintons to impress Chinese business associates. Was it a good idea to have him around?

Again, you're just not watching the numbers. Chung and his associates chipped in \$366,000 to the Democrats, or about \$7,500 for each of the 49 Chung visits. The Democrats had to return it—it was all funny money. But still, \$7,500 per visit is great, and he never tied up any of the bedrooms.

What about Vice President Gore? Didn't he violate the law by making fund-raising phone calls from the White House?

Not at all. He was using a Democratic credit card, so though he appeared to be making those calls from the White House,

he was actually making them from Democratic-rented outer phone space. Understand?

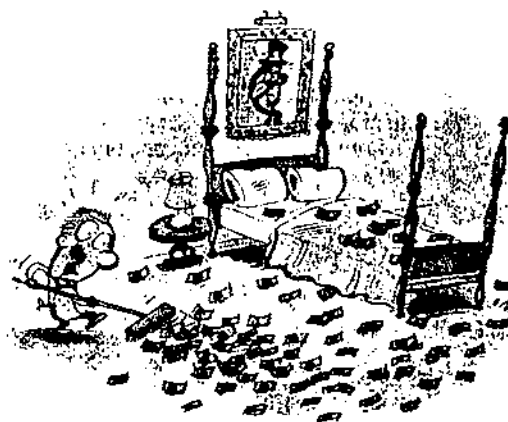
I'm working on it. What about Gore's explanation that "no controlling legal authority" told him not to fund-raise in the White House. Isn't that a little like the phrase, "What's the frequency, Kenneth?" used by the weird guy who attacked Dan Rather on the street?

Though sometimes confused, these phrases are actually very different. I believe that when the vice president talked about the lack of a "controlling legal authority," he was simply trying to speak from the heart and put things in his own words.

That's fine then. But White House lawyers and President Clinton

himself said you weren't allowed to solicit money at the White House, so how come the vice president couldn't locate a controlling whatever-it-was to tell him not to do it? And what about those 103 fund-raising "coffees"? The Los Angeles Times quoted a Democratic finance guy as saying, "Tell them they can come to a coffee with the president for \$50,000." And even though the coffees raised lots of funds, Mike McCurry, the press secretary, said they were not real fund-raisers because at a real fund-raiser "you buy a ticket, you sit down, you have a bad chicken meal, and you listen to a speech."

This is easy to explain. A chicken dinner and a coffee are very different. One is a formal fund-raiser. The other is a purely social event that happens to cost \$50,000.

I see. But weren't word games going on, like when President Clinton said no strangers stayed overnight at the White House, but it turned out that a lot of these "friends" were people the Clintons didn't know?

No. It's just that there are two levels of friends, those you already know and like, and those "pre-friends" you just know you're going to like, though you haven't met yet.

Margaret Williams, Mrs. Clinton's chief of staff, accepted a \$50,000 campaign check in the White House, but the Clinton people insist she only "took" the check on the premises—she didn't "accept" or "receive" it. So we have a check that was "taken" but not "received," friends who were really strangers, phone calls from the White House that weren't really from the White House, and \$50,000 per person fund-raisers that weren't fund-raisers because bad chicken wasn't served. Is something amiss here?

Not at all. Why would you think anything is wrong?
