These guests walked in through the East Visitor Entrance, but were not on the WAVES list. Kim Widdess has set up a very strict procedure to deal with people who arrive at the gate but are not on the list. A Social Office representative takes their name and information down on a piece of paper and then a determination is made to clear them into the event. All of this activity is purposefully recorded on paper and copies are kept in the Social Office.

The guests named above never were referred to the Social Office at the gate and were apparently permitted to just walk through the gate without being cleared.

Attached is a copy of the WAVES list from last night and those who were cleared in at the gate which indicates the above mentioned people were not on the list. Also attached is a copy of the receiving line cards which the guests filled out in the receiving line.
