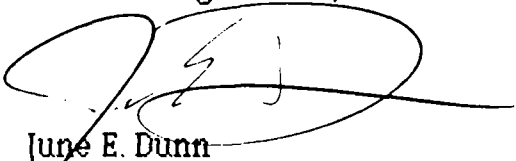

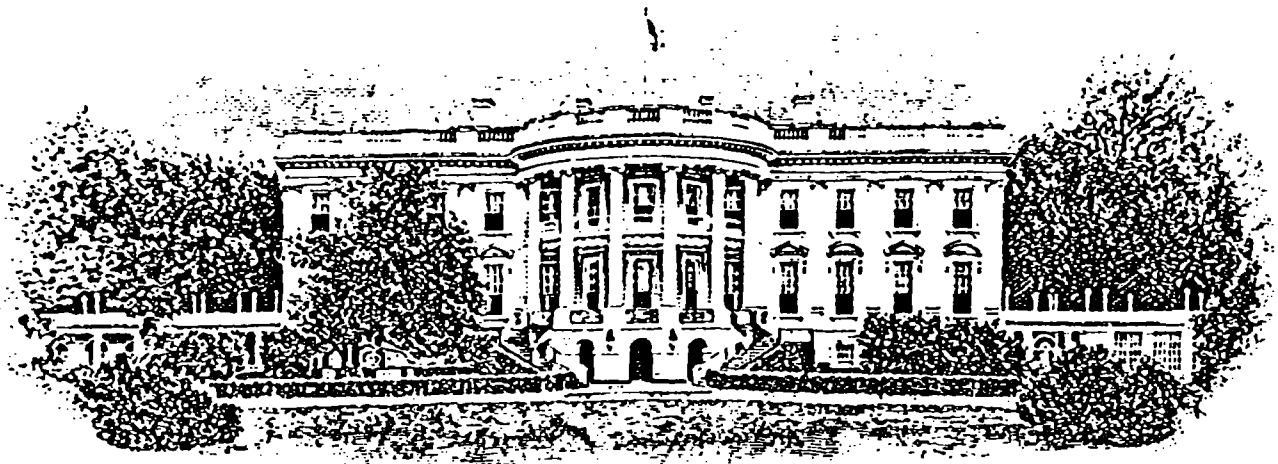

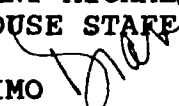

It is with some hesitancy that I approach you for a favor. I was asked to approach the President and even though I know that you are extraordinarily busy, the President is even busier, hence my approaching you.

I have taken the liberty of enclosing a letter from an old friend, Cummins Catherwood, a Philadelphia investment banker, who asked me to see if I could gain the favor that is described in his letter. As you will note, he is trying to maintain the continuity of the Presidential photographs that his grandmother started in 1922. Thus far, the collection is complete with, of course, the exception of President Clinton. Incidentally, his wife, Susan Catherwood, met you as a trustee of the University of Pennsylvania and was just as delighted meeting you as was my wife, Leonore.

Might I suggest that you have Maggie Williams, one of my former students from The Annenberg School for Communication, follow through on this request so that the continuity of the Catherwood family's collection of Presidential pictures might be continued.

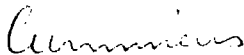
Dear Walter:

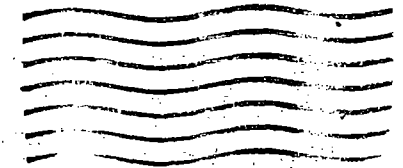

Susan joins me in hoping that your trip to France will be enjoyable. We look forward to a full report on the Barnes collection upon your return.

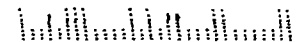

As you will note, he is trying to maintain the continuity of the Presidential photographs that his grandmother started in 1922. Thus far, the collection is complete with, of course, the exception of President Clinton. Incidentally, his wife, Susan Catherwood, met you as a trustee of the University of Pennsylvania and was just as delighted meeting you as was my wife, Leonore.

Might I suggest that you have Maggie Williams, one of my former students from The Annenberg School for Communication, follow through on this request so that the continuity of the Catherwood family's collection of Presidential pictures might be continued.

I very much regretted your inability to have been my dinner partner at the Metropolitan Museum of Art last Monday night but, of course, in your life priorities take command and the Rabin/Arafat scenario certainly had precedence over the opening of the Met's new galleries and the viewing of my paintings.

Although I only had the privilege of meeting you once, I do look forward to further opportunities to be in your presence.
