SUBJECT: Arkansas Partnerships Project here next week

We have received a packet (sending a copy to each of you) which I think will give you information to use in setting up the two sessions with this group next week. Claudia can fill you in on details of logistics.

I see the purpose of these meetings which the President asked us to do to be a sharing by the Partnership of their program and how they feel the federal government can be a better partner; from our side we should be prepared to ask feedback on our five areas of Partnerships project as at conference this week as well as the type child welfare questions we've been asking of persons, Lyn.
