U.S./KOREAN ECONOMIC ISSUES

BACKGROUND

- o Korea has the world's 13th largest GNP. Two decades of dynamic growth have carried per capita annual income to nearly \$8000. Korea is our seventh largest export market. US-Korea trade topped \$35 billion in 1993; our trade deficit with Korea grew to a modest \$700 million.
- o However, wage inflation and structural rigidities slowed growth in 1990-93.
- o On taking office in February 1993, President Kim Young Sam announced an ambitious economic reform program aimed at deregulating the economy and restoring Korea's sagging competitive position.
 - President Kim seeks OECD membership for Korea, to sustain the momentum of economic reform and obtain international recognition of Korea's status as a developed country.
- o If implemented, ROKG plans to open Korea's economy will improve the climate for U.S. investors and exporters.
 - Korea contributed a positive market opening package to the December 15 Uruguay Round agreement. President Kim personally intervened to overcome strong domestic opposition to rice imports.
 - Notwithstanding policy reorientation and, in recent months, favorable media coverage, Korea still has a poor reputation with U.S. business. It remains relatively less hospitable to foreign investors than other Asian economies.
 - Chief U.S. business complaints are excessive government regulation, reservation of key sectors and activities to indigenous entrepreneurs, and an anti-foreign bias among bureaucrats and consumers.

LIMITED OFFICIAL USE

- Our front burner bilateral trade concerns, however, are barriers to selling into Korea's automobile and financial services markets, and onerous, often specious, health and safety standards that curb Korean imports of agricultural products.
- o Presidents Clinton and Kim launched the Dialogue for Economic Cooperation (DEC) in July 1993 to address business environment issues.
- o US and Korean DEC negotiators will report modest progress (investment approval procedures, government rulemaking, taxation, and enforcement of anti-monopoly laws) to an Economic Subcabinet meeting in Washington later this month.
- o At the Subcabinet meeting, U/S Spero and colleagues will:
 - warn that American willingness to emphasize dialogue on bilateral economic issues will wane if concerns like auto import constraints and specious health and safety standards are not constructively addressed;
 - provide for a DEC follow-up process; and
 - underscore that US support for Korea's OECD aspirations depends on massive reduction of impediments to foreign investment and capital flows;
