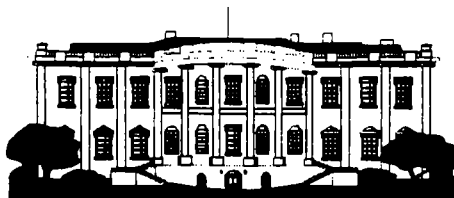

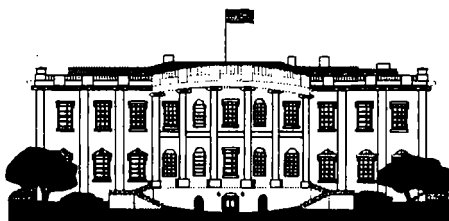

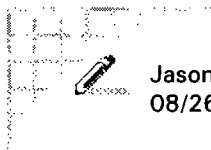

MEMORANDUM FOR FAST TRACK WORKING GROUP

FROM: Jay Berman
RE: Legislative Meetings

Throughout the spring and summer, Administration officials have been meeting with members of the House and Senate and their staffs to discuss Fast Track in general terms and the President's decision to send up legislation shortly after they return from the recess. In addition, the President held two meetings with a number of undecided Members just prior to the recess, asking that they not make any commitments to oppose the legislation until the Administration has had an opportunity to finalize our bill and present the case for it.

Based on all of these meetings, follow-up phone calls and past voting histories on trade bills, we have compiled a list of Members who could be supportive of Fast Track. In advance of actually producing the final version of the bill, which is scheduled to be rolled out at a White House event on Wednesday, September 10, we are asking all of the principals to visit Members for individual consultations to determine what type of bill, on introduction, will get the legislative process started toward enactment before adjournment.

It is essential that your appointments be scheduled for the week of September 1, as that only leaves the 3rd-9th for decision-making on the final version. We will also need to be doing a parallel effort with outside support groups, so time is short.

We will have talking points for your use and Ambassador Barshefsky and Jay Berman will participate in a conference call on Tuesday morning, September 2, to address all of the issues in greater detail.
