This memo seeks your agreement to meet for 30 minutes with the British Intelligence and Security Committee on the afternoon of June 27. This newly-created senior panel consists of nine Members of Parliament, who will exercise Parliamentary oversight of the British intelligence community. They are visiting the U.S. to learn about our intelligence oversight arrangements, and will talk to HPSCI and SSCI, CIA, NSA, and others. They seek your perspective on relations between the senior policy maker and the Congressional intelligence oversight committees. They also would like your thoughts on the value this Administration places on the work of the Intelligence Community.

If you consent to this meeting, I will forward additional background and talking points. In view of the size of their delegation--11 people altogether--I will reserve a conference room for the session.
