RE: Follow-up Summary from October 1999 PACHA Meeting

The Council would appreciate a follow-up to our October 1999 meeting with Secretary Shalala and thus I am enclosing a copy of the October 1999 meeting minutes for your reference. While the Presidential Advisory Council on HIV/AIDS (Council) is pleased with the Administration's overall progress on HIV/AIDS, they remain focused on several key issues:

1. HHS Internal Review – HIV/AIDS Strategic Plan

The Council is hopeful regarding the strategic plan being developed at HHS and is interested in ensuring that HHS' HIV/AIDS strategy identifies specific targets and sets timelines to achieve those targets.

During the October 1999 meeting, Secretary Shalala stated that a draft of HIV/AIDS strategic plan would be ready for the Council's review by late fall of 1999, and that a final document would be completed by early this year. She further urged members to submit comments to HHS regarding the draft.

The Council, however, has not received a draft and would appreciate one to review for their March meeting. In addition, they are hopeful that a detailed timeline on the forecasted rollout of HHS' HIV/AIDS strategic plan will be included as well as information on the inclusion of other "strategic plans" that may have been developed, i.e. Healthy People 2010, "Know Your Status" Campaign, Surgeon General's Leadership Campaign on AIDS, Minority AIDS Initiative, 1999 HHS regional meetings, etc. that would be essential in order to fully integrate a comprehensive HHS HIV/AIDS Strategic Plan.

2. Needle Exchange

Prior to the October 1999 meeting the Council was informed that HHS was developing a “street-level” guide on the science of needle exchange programs. At the October 1999 meeting, the former chair, Dr. Scott Hitt inquired of Secretary Shalala about a date specific timeframe for release of such a guide and Dr. Eric Goosby noted that the report would be made public within a 2-week timeframe. The Council further encouraged wide dissemination of such a guide at the national, state and local level. Additionally, the Council urged the Secretary to submit editorials regarding the science-based efficacy of needle exchange programs. The Council would appreciate an update on the development of the science regarding needle exchange programs and dissemination of it for their March meeting.

Included with this memorandum is information from the San Francisco AIDS Foundation that developed a compendium of material and additional resources to assist localities in legalizing needle exchange programs. For California, it is an instrumental tool used to assist the community in taking advantage of new legislation (AB 136) that allows local governments to legalize needle exchange programs in their jurisdictions. This packet of information is a model of what the Council is asking for from HHS to enhance their existing framework supporting the science.

3. HHS Regional Meetings

The Secretary stated that she believes that the decision-making process regarding health care policy must be conducted from the bottom up. She emphasized that HHS, the Council, and community-based organizations are part of one team. Last year HHS convened 10 regional meetings to engage consumers and providers of HIV services. The Council was informed that reports from these meetings would be forthcoming.

The Council would appreciate a summary regarding these meetings for our March meeting.

4. Healthcare Worker Guidelines

The Secretary clearly stated that she would not be able to provide a specific date regarding the completion of the healthcare worker guidelines because HHS had not resolved its internal debate on the guidelines. Dr. Hitt stated he had been told that the CDC ethics committee had signed off on the health care guidelines, and they would be forwarded to HHS within 1 to 2 weeks. You confirmed that HHS would move as quickly as possible on the guidelines once they were received by the Secretary’s office.

The Council would appreciate an update on the status of the healthcare worker guidelines and any anticipated release of these new guidelines.

5. “Know Your Status” Campaign

The Council would appreciate an update of CDC’s “Know Your Status” campaign and all of it’s components including funding and staffing within the CDC at the March meeting.

6. Minority AIDS Initiative

The Council would appreciate an update of the HHS Minority AIDS Initiative and the development of a comprehensive approach to ending racial and ethnic health disparities as it relates to HIV/AIDS.

7. Access to Care

The Council would appreciate an update on access to health care including the Medicaid waiver demonstration program recently approved in Maine.

8. Global HIV/AIDS Issues

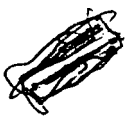
The Council would appreciate an update on the HHS' efforts to address the epidemic on the international front including current initiatives at the Office of International and Refugee Health.

Summary

The Council will be working to develop a progress report of the Administration's HIV/AIDS efforts as well as HIV/AIDS health care policy recommendations for future Administrations to address. The report is scheduled to be released at the October 2000 meeting.

Finally, as we go into the March 19-21 meeting and upon completion of the vetting process there will be fourteen new members on the Council. The Council is excited about the new energy and leadership and the opportunity to draw on the expertise and background of both new and reappointed members. I am certain that the newly formed Council would appreciate an overview of these issues from you. Please note that other relevant HHS agencies have been invited to attend. They will be going into further detail on each issue.

The Council appreciates your work and that of HHS and they look forward to a continued collaboration on resolving the aforementioned issues.
