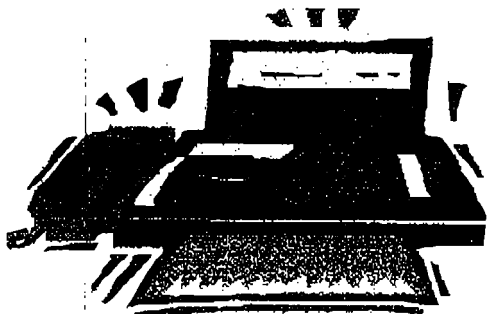

Dear Sandy,

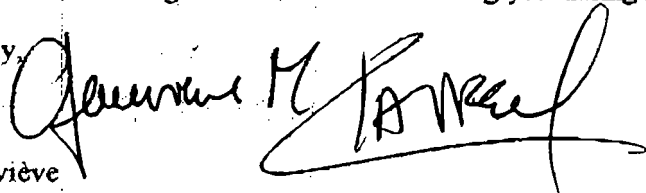

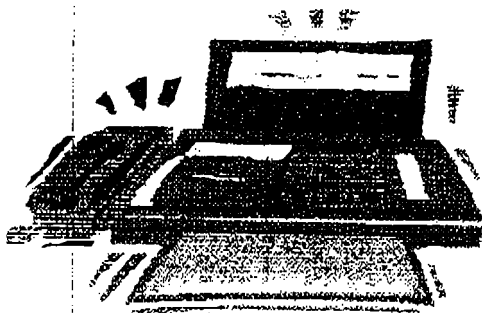
