As we discussed, I have enclosed a series of pictures dealing with Team Nutrition for the slide show for the First Lady's slide show. They're pretty self-explanatory; the two pictures of the First Lady with the Team Nutrition logo in the background are from our launch event in June of last year; the other, of her speaking with a child who seems to be offering her a sandwich, is from a separate school visit.

The remainder of the pictures show a variety of Team Nutrition activities, including nutrition education activities developed by Team Nutrition partners, tastings of fresh produce, volunteer chefs demonstrating nutritionally-improved recipes, and visits to Team Nutrition gardens, where children learn about "where food comes from" by planting and growing their own vegetables.
