1. THE EUROPEAN COMMISSION ON JUNE 2 ANNOUNCED THE GRANTING OF ANOTHER 200,000 ECU (ROUGHLY THE EQUIVALENT OF 234,000 USD) TO FINANCE EMERGENCY HUMANITARIAN AID FOR THE VICTIMS OF THE CIVIL WAR IN YEMEN. THE AID WILL COVER THE PURCHASE, TRANSPORTATION AND DISTRIBUTION OF MEDICAL KITS AND DRUGS AS WELL AS THE LOCAL PURCHASE OF ITEMS NEEDED FOR DISPLACED PEOPLE AND REFUGEES. THE NEW CREDITS WILL RAISE THE TOTAL OF EU AID GRANTED BY THE COMMISSION SINCE THE BEGINNING OF THE FIGHTING IN YEMEN TO 500,000 ECU (585,000 USD).
2. THE OPERATION WILL BE CONDUCTED BY THE "MEDECINS SANS FRONTIERES" OF FRANCE, WHICH WILL:
-- TAKE OVER THE RESPONSIBILITY FOR WAR VICTIMS OF BOTH SIDES;
-- DISPENSE ESSENTIAL CARE TO SOUTHERN PEOPLE WHO HAVE BEEN DISPLACED AND REGROUPED IN ADEN AND LAJEH (40 KILOMETERS NORTH OF ADEN) AND ARE CURRENTLY LIVING IN SCHOOLS AND OTHER PUBLIC BUILDINGS IN VERY PRECARIOUS CONDITIONS;
-- ASSIST 7,000 SOMALI REFUGEES NOW LIVING IN THE CAMP OF AL KAWD IN THE GOVERNORATE OF ABYAN (EAST OF EDEN), WHO WILL GET SUPPORT FOR THEIR REINSTALLATION AWAY FROM THE FRONT LINES AS SOON AS POSSIBLE.
