SUBJECT: MORE EU AID FOR VICTIMS OF FIGHTING IN YEMEN

REF: (A) USEU BRUSSELS 6075; (B) USEU BRUSSELS 5838

1. THE EUROPEAN COMMISSION ON JUNE 13 ANNOUNCED THE GRANTING OF ANOTHER 720,000 ECU (ROUGHLY THE EQUIVALENT OF 835,000 USD) TO FINANCE HUMANITARIAN AID FOR THE VICTIMS OF THE CIVIL WAR IN YEMEN. THE AID WILL FINANCE TWO PROJECTS FOR A DURATION OF TWO MONTHS.

2. A FIRST PROJECT (470,000 ECU) WILL BE IMPLEMENTED BY THE "SECOURS POPULAIRE FRANCAIS," WHICH WILL PROVIDE FOOD AND MEDICAL ASSISTANCE AS WELL AS ESSENTIAL ITEMS TO 5000 DISPLACED FAMILIES, INCLUDING 2000 NORTH OF THE FRONT LINE (IN SANAA, AMRANE, SOFIANE AND DHAMAR) AND 3000 IN THE SOUTH (IN DALEH, ZENGEBAR AND MOKAIRASSE).

3. THE SECOND PROJECT (250,000 ECU) PROVIDES FOR WATER SUPPLY AND THE BUILDING BY CARE INTERNATIONAL OF MINIMUM SANITARY EQUIPMENT FOR 1000 DISPLACED FAMILIES IN THE LAHEJ REGION (NORTH-EAST OF ADEN).

4. THE NEW PACKAGE WILL RAISE THE TOTAL OF HUMANITARIAN AID GRANTED BY THE COMMISSION SINCE THE BEGINNING OF THE FIGHTING IN YEMEN TO 1,220,000 ECU (ABOUT 1,415,000 USD).
