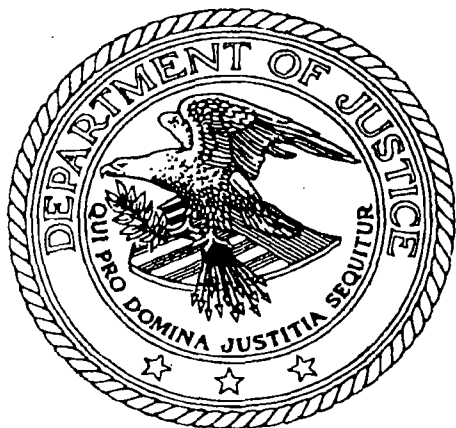

Attached is a summary of Small Arms purchases by DOJ from FY1989 through the second quarter of FY2000. The information was obtained by searching the data contained in the Department's procurement data base (this is the data provided by DOJ to the Federal Procurement Data System).

The information is listed in column format by contractor name, contract number, dollars reported spent under that contract, and a brief description of the items purchased. The information is grouped by Bureau with a dollar total amount provided for each and a DOJ grand total (\$29,652,382).

The descriptive information is often cryptic and generic (i.e., weapons) but is generally specific. Since this is the only information contained in the data base, we will have to consult with each bureau on a contract by contract basis to get greater detail on the purchases. We will try to get more detailed information for those purchases simply described as "Weapons" or "guns" and will pass that on to you as soon as possible. Since it could take several days to track down that detail, I am presenting you with the data I have now.

The attachment is a table in WordPerfect format. If it is not readable or you would like it in another format or hardcopy, please let me know and I will get it to you immediately.
