Dear Chris:

Having twice had the audacity to invite you to speak to CHA members in Washington, DC, on a Saturday, I am writing on behalf of the Catholic Health Association of the United States (CHA), whose more than 1,200 Catholic health care systems, facilities and related organizations constitute the nation's largest group of not-for-profit health care facilities under a single form of sponsorship, to invite you to participate in a "Socratic Dialogue" conducted by nationally-known Professor Charles J. Ogletree, Harvard Law School Professor, on the topic of "Managed Care, Quality and Consumer Protection."

The forum will be at CHA's annual Assembly on Wednesday, June 10, 1998, from 8:00 a.m. to 9:30 a.m. at the New Orleans Marriott Hotel.

Nine other prominent persons with diverse points of view will engage in a discussion facilitated by Professor Ogletree about how to guarantee the *quality* of health care delivered in a managed care setting and what kind and in what manner consumer protections should be assured.

CHA will, of course, reimburse you for traveling expenses and can offer a modest stipend of \$500.

I know travel is demanding on your family and your White House responsibilities. However, you have been so cooperative in trying to respond to CHA's needs that I would be remiss if I didn't offer you the opportunity to be part of this illustrious panel and ensure that the President's views on this important issue be represented. You would add a lot to this kind of dialogue, and you would love the format.
