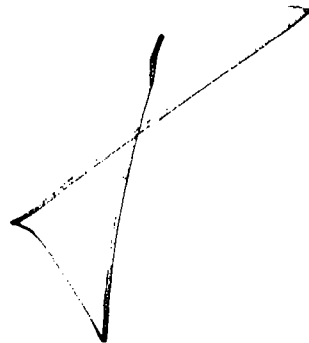
Dear Greeting Office

Who gets the most mail? The White House isn't saying. But plenty of fans want paw prints from the dog.

Buddy, a pet Pomeranian in Belle Isle, has a new pen pal — make that "paw pal."

Buddy's owner, Richard Synan, in December wrote to President Clinton's dog, who also is named Buddy. Synan enclosed a snapshot and an excerpt from an Ann Landers column

about giving pets love and attention.

"Could you send me your picture and paw print for my album?" Richard Synan, 83, wrote on his dog's behalf. "I want to be a pal of yours. We Buddies have got to stick together."

Over the weekend, he received a response from the presidential pooch.

"Thank you for writing to me," reads the letter. "Living at the White House is very exciting, and I am enjoying my new family."

The letter is signed with a paw print and Buddy's name. Also enclosed was a photo of Buddy sitting on a park bench with Clinton.

Thousands of letters have poured in regarding Buddy, but Socks, the Clintons' cat, also has been popular with the public. Which

one gets the most mail?

"We would never say that one is favored over the other," said Lori Abrams, spokesperson for the White House correspondence department. "Actually, we don't have a count broken down to show which first family member gets the most mail."

In addition to responding to letters about White House pets, staff also sends letters to those who write in about a new baby, an 80th or subsequent birthday, a 50th or subsequent anniversary, an Eagle Scout Award or the Girl Scout's Gold Award.

Requests must be sent at least four weeks in advance, but not more than six weeks, to The White House, Washington D.C. 20500. Allow four to six weeks for processing.
