on the porch here.

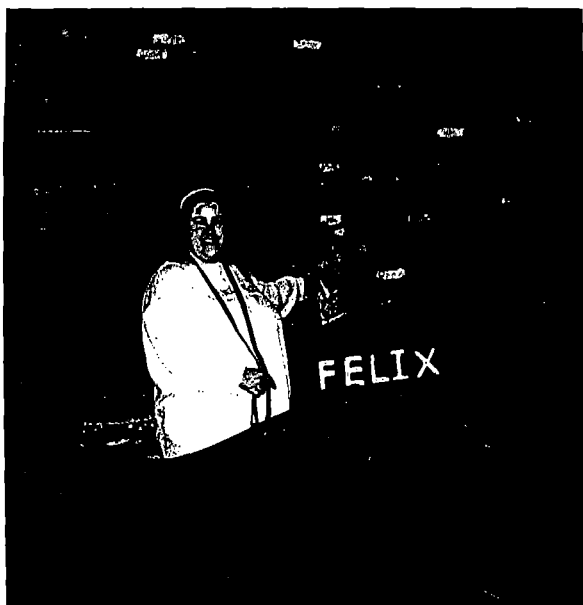
